You'll also have the opportunity to work closely with and receive mentorship from a highly credentialed Principal Investigator/Project Director, gaining valuable insights and expanding your professional skills.

This is currently a project-specific, on-call position with flexible hours. As Latis continues to grow, there is strong potential for this role to expand into a full-time position with increased responsibilities. Fieldwork will be conducted under the guidance of our Principal Investigator and will involve frequent travel. Candidates should be comfortable working 8-to-10-hour days in varied outdoor conditions.

- Lead archaeological field crews in survey, excavation, monitoring, and laboratory work

- Oversee site recording, evaluation, artifact identification, and analysis
- Coordinate with agency representatives, tribal monitors, and project stakeholders
- Develop and implement fieldwork strategies under the guidance of the Principal Investigator
- Maintain accurate and timely field documentation and project records
- Contribute to report preparation, including data synthesis and interpretation
- Provide mentorship and technical guidance to field staff and junior archaeologists
- Monitor project progress and ensure adherence to safety protocols and quality standards
- · Assist with equipment preparation, maintenance, and troubleshooting for field operations

# **REQUIREMENTS**

- Bachelor's degree in anthropology, archaeology, or cultural resource management (required);
  M.A. or M.S. preferred and sufficient to meet Secretary of the Interior's standards for a Supervisory Archaeologist
- Minimum of 1 year of professional archaeological fieldwork, including:
  - 4 months supervised archaeological survey
  - 4 months supervised excavation
  - 4 months artifact identification, analysis, and data synthesis
- Demonstrated ability to plan and conduct archaeological research (via thesis, dissertation, publication, or 4+ months as field supervisor/crew chief)
- 5+ years of overall archaeological experience preferred, including at least 1 year with excavations
- Experience with construction monitoring and collaboration with tribal monitors
- Strong knowledge of NEPA, NHPA, ARPA, NAGPRA, and Arizona cultural resources regulations, policies, and procedures
- Experience conducting research, literature reviews, and cartographic reviews
- Experience writing compliance reports and completing site forms
- Background in a consulting environment with ability to manage multiple projects and meet deadlines preferred
- Experience leading and supervising crews in the field
- Proficiency with GPS technology and Microsoft Office Suite, Adobe, and SharePoint
- Excellent communication, analytical, and organizational skills
- Willingness and ability to travel to project sites and work outdoors in varied weather and terrain and able to travel frequently for extended periods
- Physically able to walk long distances over rough terrain, excavate shovel tests/test units, screen soil, and carry field gear, equipment, and/or supplies (up to 40 lbs)
- Comfortable working independently in the field and office
- Motivated, organized, and committed to working safely with minimal supervision while promoting, implementing, and ensuring adherence to safety requirements and protocols
- Compliance with pre-employment and ongoing drug screening and background check
