This Stamp has a little nick at the top right hand corner and is toned. This is the only recorded copy of this Official Perfin ever found and is extremely rare. This item is being sold with the original sheet from the E. M. Richford Catalogue and the original E. M. Richford Invoice dated 15 AUG 1934 sent to the GPO which has three (3). A very interesting and unique Exhibition Piece.



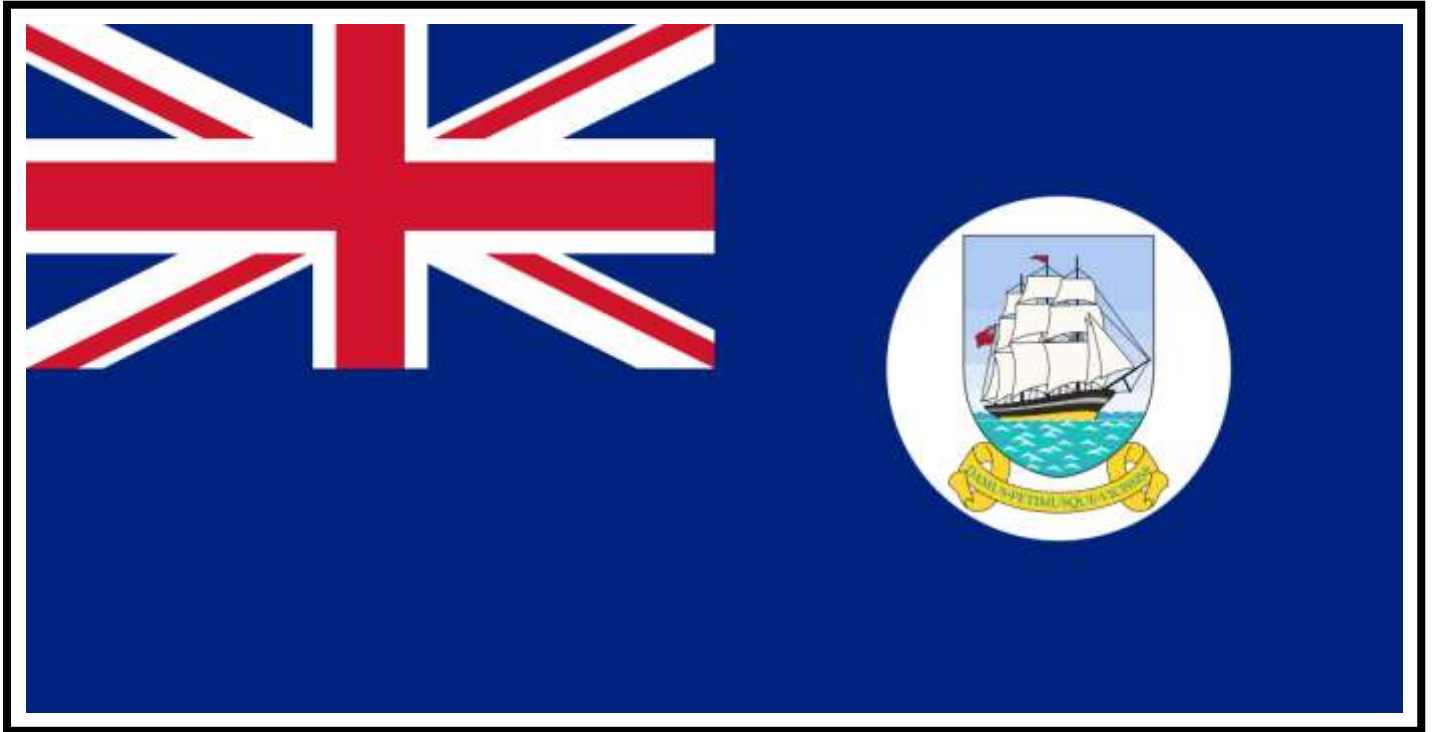

SPECIMEN PERFIN

Many years ago there was great fear that stamps would be counterfeited, and the Government defrauded of the revenue. Various means were employed to make it difficult to copy current postage stamps and pass them off as legal. So Perfins were once used to identify certain stamps as being genuine.

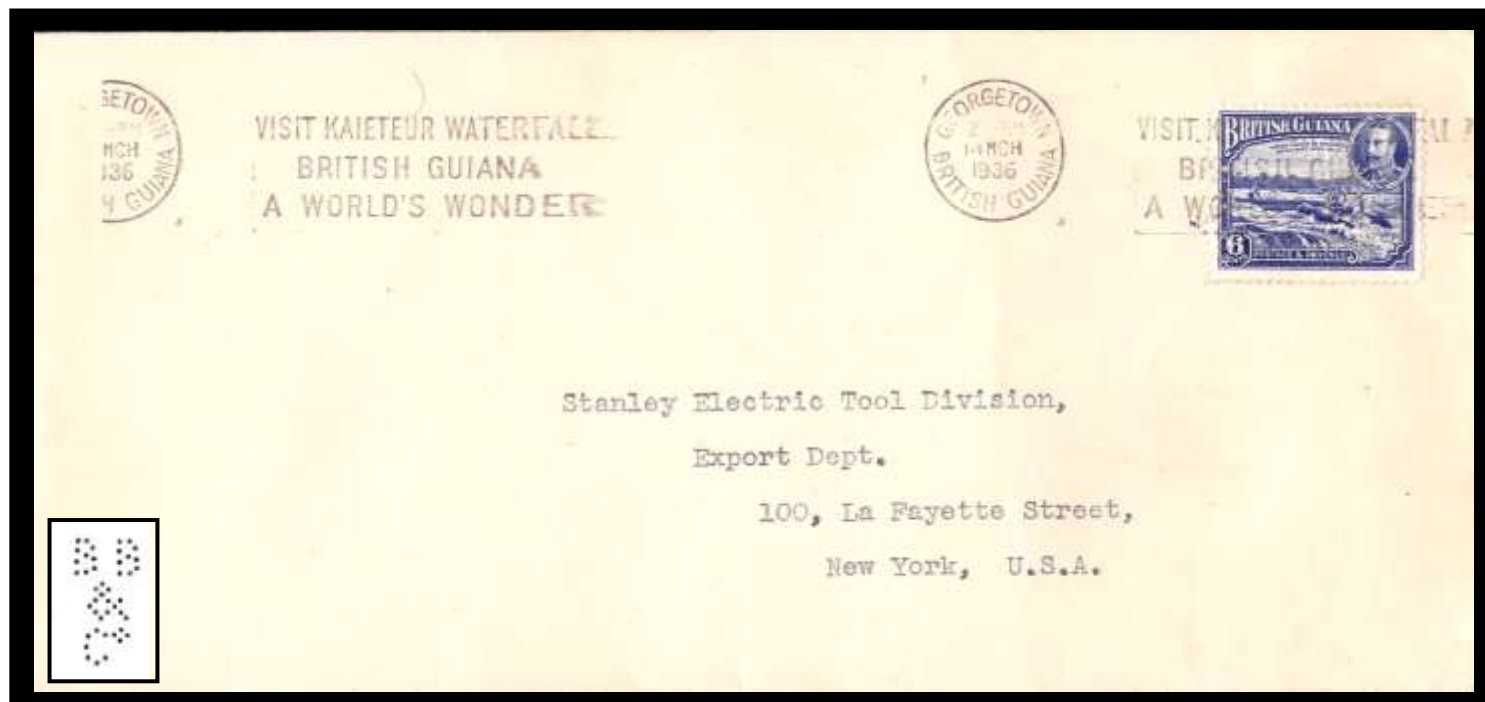
In 1882 British Guiana issued these type -set stamps in sheets of 12 printed on colored wove paper, There are two distinct designs and different colors of Purple & Yellow.

To prevent "fraud on the government" the word "SPECIMEN" was perforated diagonally across each stamp. It was also used to perforate Cards (As above) & Wrappers. The perforating machine was made and supplied by Baldwin.

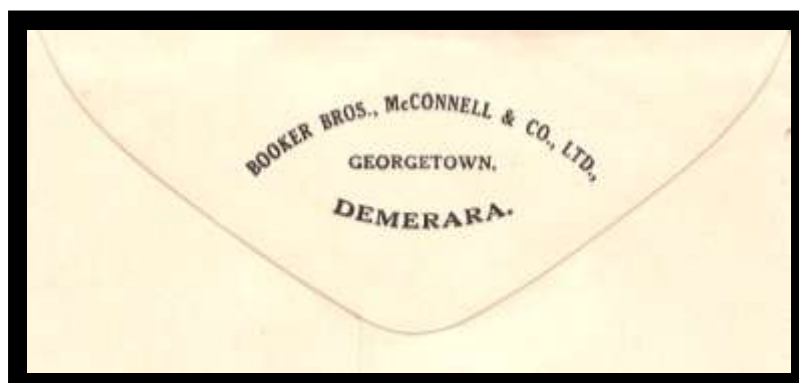

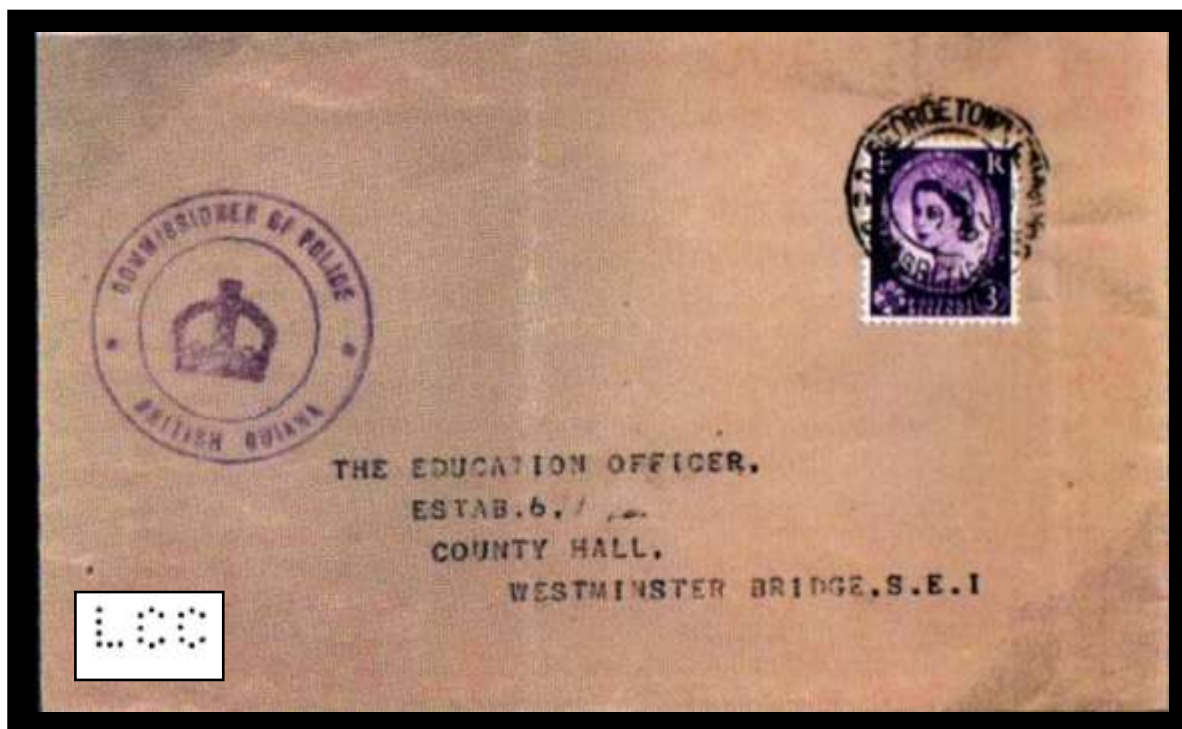

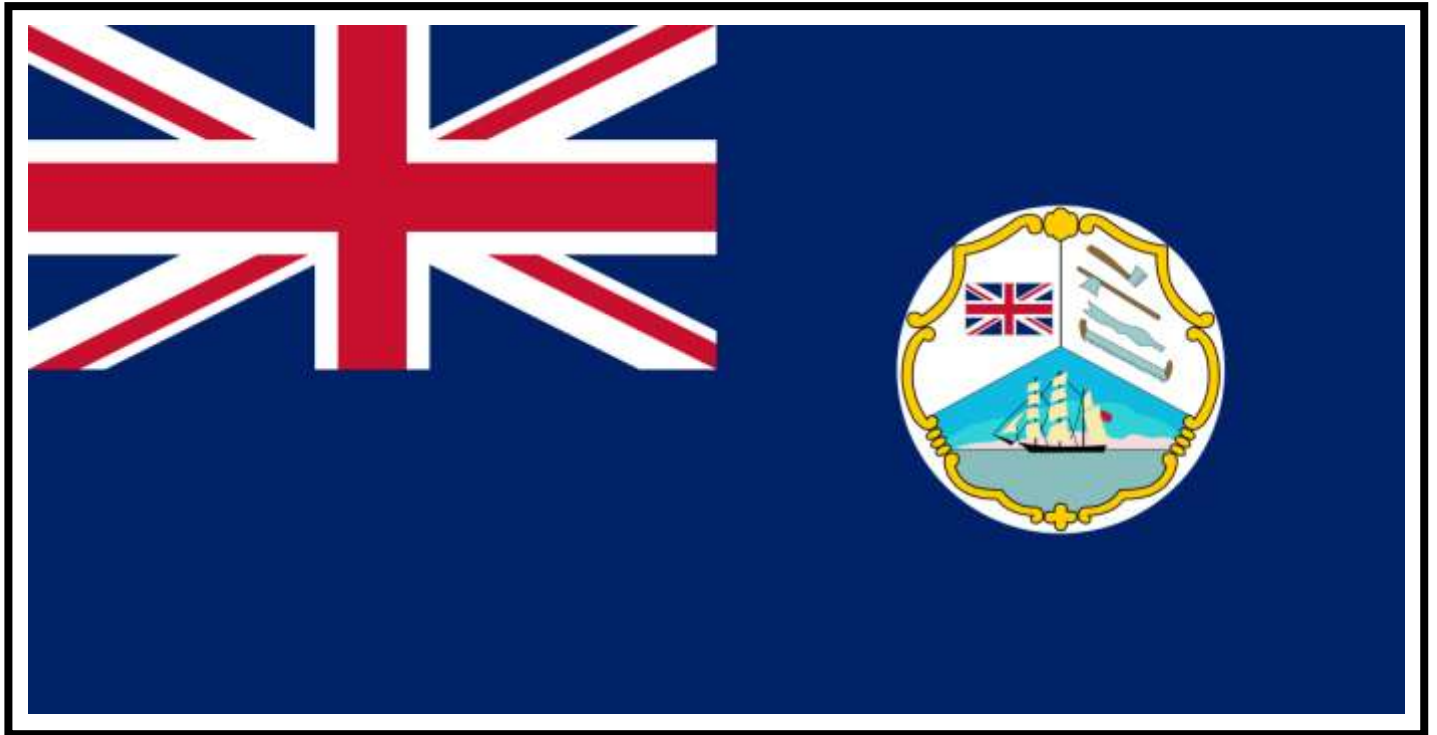

Most worthy of mention here is this new find by Richard Husband mentioned in the June 2020 Perfin Society Bulletin, a very unusual cover with a clear Georgetown cancel of 1961, and a British 3d Wilding stamp with the LCC perfin of London County Council, Die L 1020.01cM
The Die was in use between 1954-1985.

Apparently this was a stamped addressed envelope sent by the London County Council to the Commissioner of Police in Georgetown. The contents comprised of a reference relating to a job application to work in a London school, from a former resident of British Guiana.

Worthy of mention here is this very unusual cover with a clear Bath Jamaica cancel of 5-12-1955, and a British 2½d Wilding stamp with the EN/E perfin of The Railway Executive Eastern Region, Die 3220.01M. The Die was a 12x1 multiheaded die and was in use between 1948-1965. In all probability this was a stamped addressed envelope sent by The Railway Executive to Jamaica Railways for its return to London. Note the Jamaica tax cancel of 16 cents.



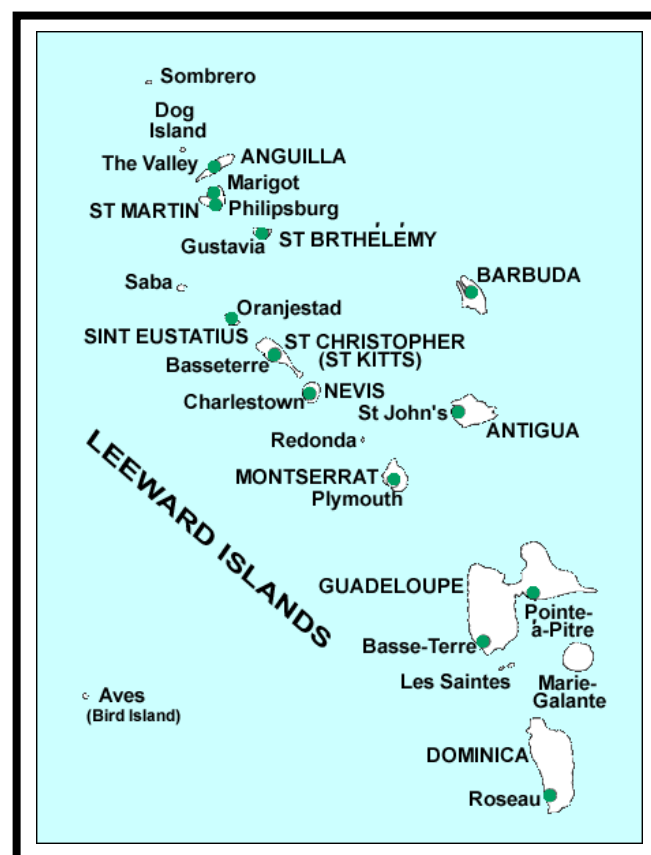
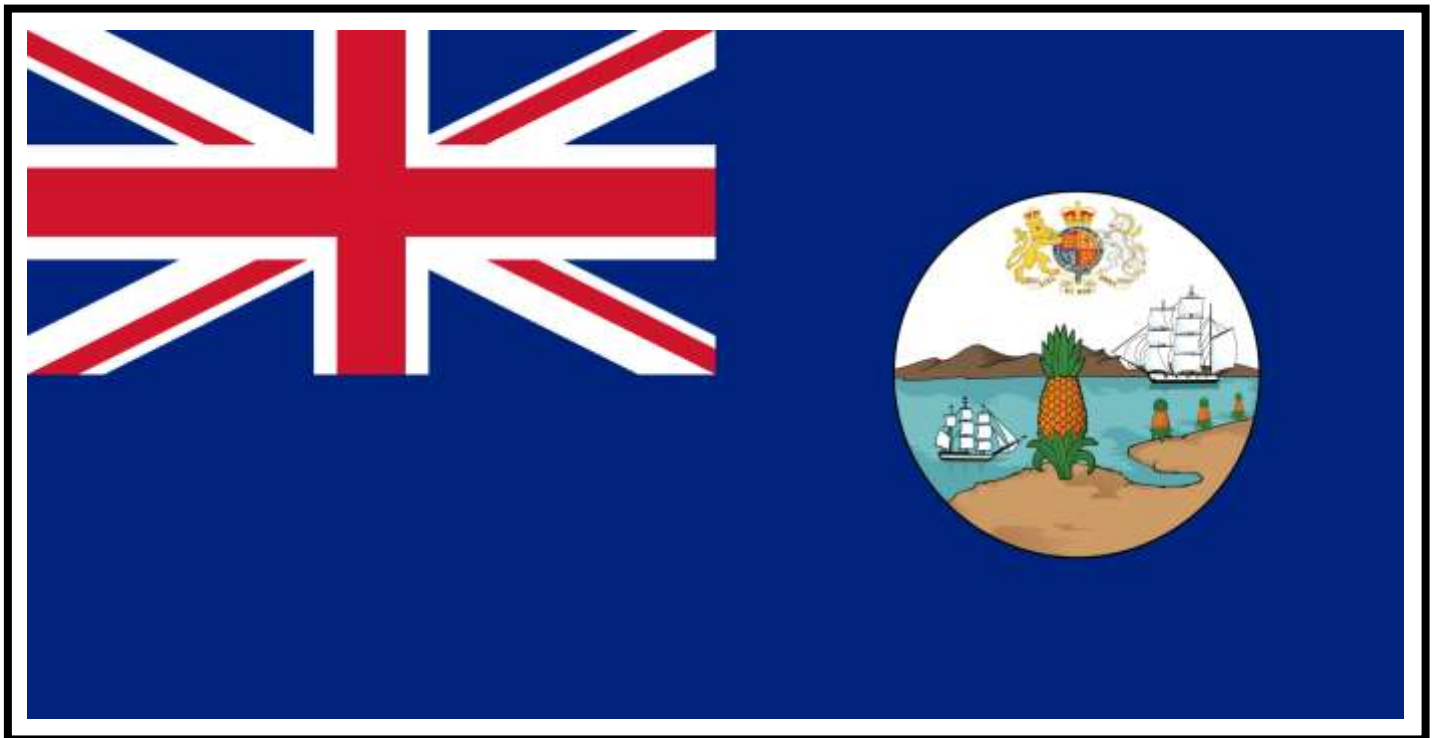

John Sutcliffe & Son, were the agents for the Hamburg American Mail Steamship Company with seven sailings monthly to the West Indies.

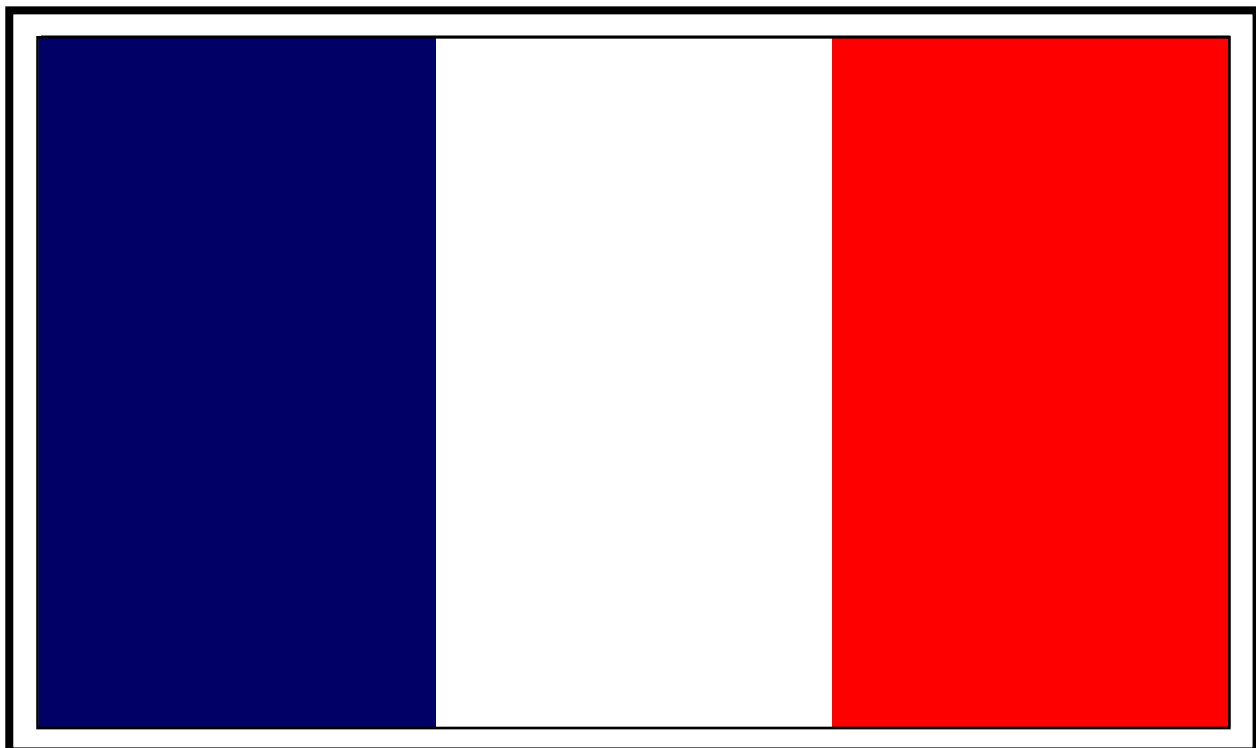

WILLIAM LAWLESS 1829-1897

BRITISH CONSUL IN MARTINIQUE



William Lawless was born in Dublin in 1829, and took up the post of British Consul in St Pierre Martinique ● in early 1875 on a salary of £400 per annum, succeeding his father John Lawless who had been in the post since 1849. After France's abolition of Slavery in 1848 the French Antilles experienced a sharp decline in its labour force so it was decided to recruit indentured Asian labourers, mostly from British India.

They were indentured to work there for a certain number of years at certain rates of pay and conditions, however these conditions were appalling, almost as bad as slavery, and William Lawless played a big part in trying to enhance the life styles and conditions of these India immigrants. By 1887 his tireless work had resulted in big improvements, and by 1888 a law was passed where no further indentured recruitment was to take place.

To date 2024 :- This is the only recorded perfin die on GB Consular Service stamps.

Worth mentioning is the die image below, it was manufactured and used on permits, (Punched through) to license the supply of postage stamps in the immediate 1945 post WWII exchange control. The permits were used as a form of Currency control.
