AUTHORISATION

A transcript of the letter of 27th June 1870 from the Inland Revenue to Joseph Sloper, authorising the use of perfins on revenue stamps:

**INLAND REVENUE
SOMERSET HOUSE, LONDON W.C.
27th June 1870**

Sir,

The Board of Inland Revenue have had before them your letter of the 23rd instant, inquiring on behalf of Messrs, Huth & Co. relative to the plan sanctioned by the Postmaster General for the perforation of postage stamps with the names and initials of Firms, etc., and in reply, I am directed to state that the Board will not object to the plan in question being extended to the perforation of Foreign Bill Stamps and also to the one penny Inland Revenue stamps in the manner pointed out in your letter.

It is to be distinctly understood, however, that the Queen's Head in the stamp is to be left untouched by the operation.

NOTE: - It is apparent that over time the rule regarding the perfin die skirting Queen Victoria's head was ignored.

INTRODUCTION

It was the duty of the Post Office to collect Inland Revenue with the use of adhesive stamps; these were first issued in 1853.

In 1875 this duty was passed to the Treasury but still handled on agreement by the Post Office. Some time later in June 1881 "The Customs & Inland Revenue Act" was passed, and this required that stamps could be used for either Postage or Inland Revenue

The 1d Lilac Postage & Revenue stamp (Sg 170) was then introduced. Following this it was no longer necessary to keep a range of stamps purely for Inland Revenue purposes.

The remaining Inland Revenue stamps, which were held in stock by companies, were allowed to be used up as postage stamps. (1st June 1881) this being why you will find Inland Revenue stamps with postal cancels, as well as Manuscript cancels.

1d stamps. 1867-1878.

There is one die of Sg F11 (Lattice background 1867) with a small anchor watermark W10.

There are four different dies of Sg F12 (1868-1878) with a small anchor watermark W10: -

Die 4 (1881) is recorded with an Orb watermark W11.

Queen Victoria 1d Purple (Sg F11) Inland Revenue Stamp.



This revenue stamp Sg F11 (with lattice background) and small anchor watermark W10, was issued on 1-9-1867, and was only in use for approximately one year before the introduction of Sg F12 in June 1868. Consequently it is much scarcer with a perfin than the other issue.

For many years now I have been curious as to the use of the perfinned G R / W small 1d Qvic Inland Revenue stamps with G.W.R. and date overprint on it. Over a period of about twenty years I have been able to accumulate only five of these stamps. However, in March this year I was able to purchase on Ebay a Debenture Stock Dividend Warrant with one of these overprinted stamps Attached. (first stamp in illustration).

Is this the answer to the use of these overprinted revenues?

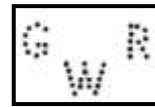
The overprints are in fact a handstamp. The angle of application is always slightly different from one another. A professionally printed overprint would also be much clearer. I thought that each different date had a different handstamp. However the D.S.D.W. that I have just acquired has a duplication of date to another two of the stamps I have, but the handstamp is totally different.

- 1) G W R March 11th, 1874 No stops at G W R
- 2) G W R March 11th, 1874 No stops at G W R
- 3) G.W.R. March 11th, 1874 No stops at G W R.

I think we need to know a little more before we can say anything for certain. Does anyone have any new information that may be of relevance, and prove significant in this matter? It seems that when you answer one question, there is always another question to be answered.

G 4350.02M is catalogued as GR/W but is in fact GWR of the Great Western Railway. The lowering of the centre letter “W” was so as not to infringe on the monarch Queen Victoria’s head, this ruling of the perfin not infringing on the head of the Monarch was laid down by the Postal Authority’s of the time.

You will note that only three (3) more of these stamps have surfaced in over fourteen years. At this time it would appear that there is **no** set pattern for these hand-stamped overprints.

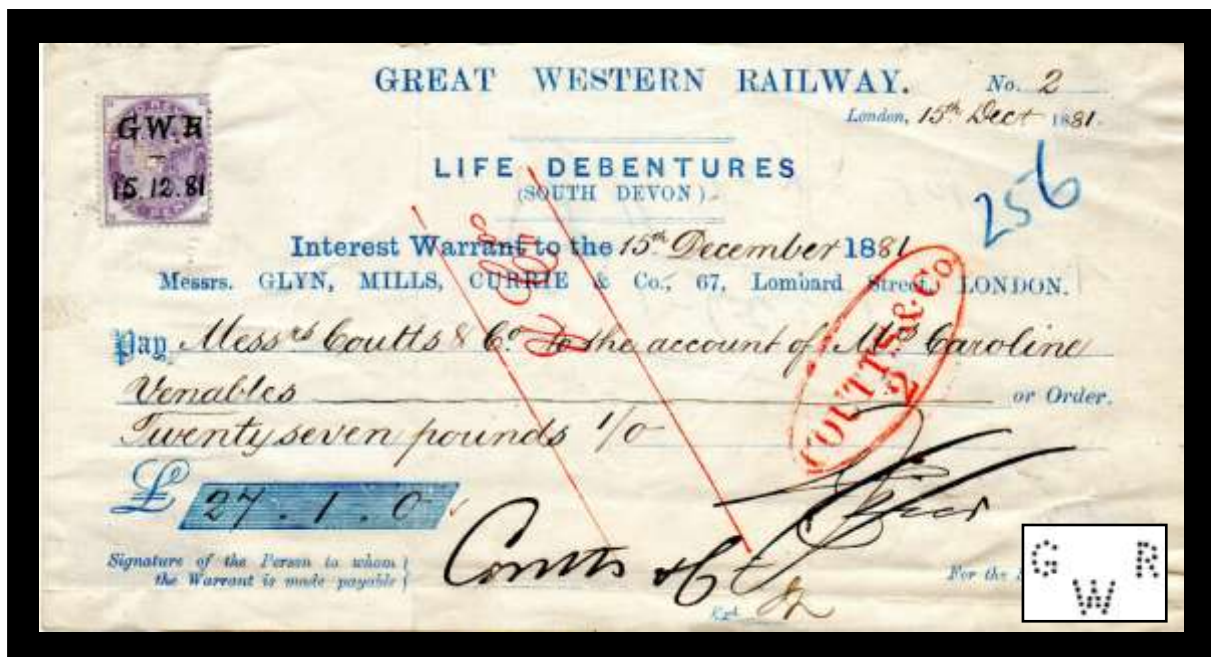

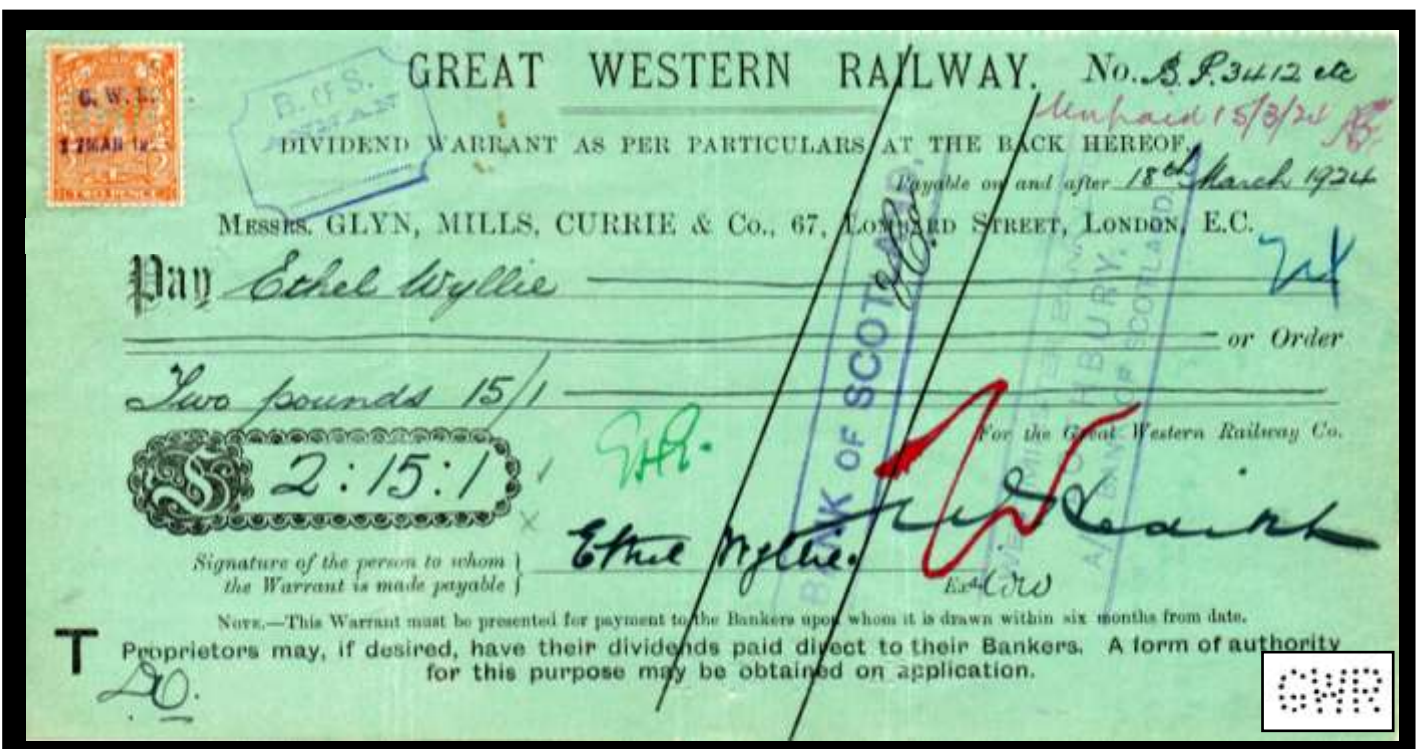

"G.N.R. / (Scrip.) / 8th Oct., 1870."

This overprint is a similar type of overprint, but used by the Great Northern Railway 8-10-1870. (Scrip) ?? No perfin has been used in this case

Addendum.

The Customs and Inland revenue Act of 1881 abolished the low value Queen Victorian Inland Revenue stamps and they were replaced by the new Postage & Revenue stamps. (Queen Victoria 1d Lilac Sg 57).

A further act in 1882 specified that from Jan 1st 1883 any postage stamp up to the value of 2/6d could be used to pay stamp duty.

So from 1883 most tax obligations of the general public (up to 2/6d) were met by the single fiscal use of postage stamps. However as with most taxes it became necessary in 1904 to raise the tax, so you will find that new higher values of the Inland Revenue stamps were reintroduced.

Perfins have also be found on these later Inland Revenue stamps.

Only **EDVII 5/-**, **GV 5/-**, & **GVI 10/-**, are recorded to date.

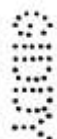

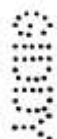
