## **NOTES FOR THE COLLECTOR**

Please note that all Perfin Revenue Catalogue numbers refer to the India Perfin Catalogue where appropriate, but be aware that in many cases the Perfin is only recorded on Revenue stamps, So in order to co-inside with the India Catalogue, new numbers have had to be used many with decimal places.

### **Abbreviations.**

All types of perfin have been recorded here, some will be classed as: -

- 1) Carpet dies (Large and through the document).
- 2) Paid Cancellers, (Perfin through the Cheque or Foreign Bill).
- 3) Punched Letters (Punched through the stamp).

Also worth noting is the fact that there are four (4) "Cancelled NBI Ld" Foreign Bill dies which are also frequently found on British Foreign Bills. This cancellation was used by the "National Bank of India Ltd".

Hyderabad's history is full of fables about foreigners who gave Hyderabad a new meaning and purpose. Albert Abid, a Jew from Armenia, gave Hyderabadis their first department store and a new name to an otherwise abandoned locality.
