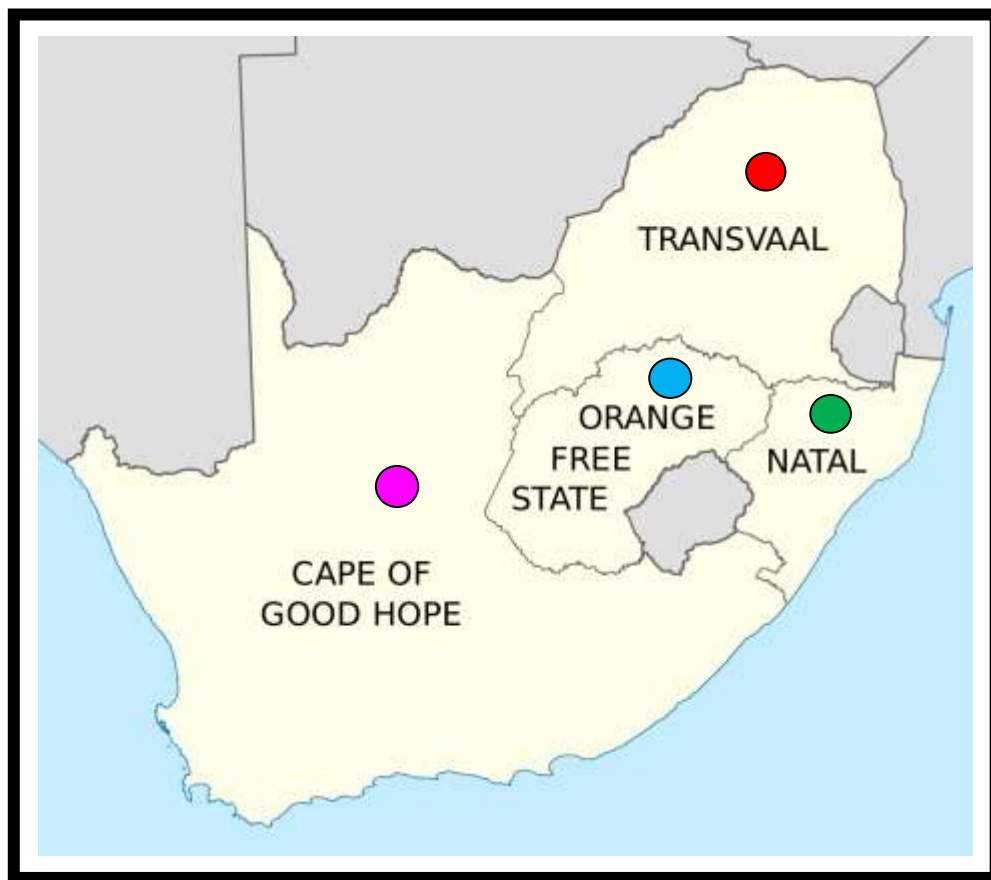

INTRODUCTION

It is now many years since the first listing of the Perfins of South Africa & Provinces was produced by the Perfins Club of America (In their World Perfin Catalogue).

And it must be noted that 60% of the information in this update is their original work.

During these intervening years there has been new information which has come to light, and although I have used the original perfin catalogue for some years my feelings are that it could be simplified and improved upon.

So with the blessings of the Perfins Club of America.

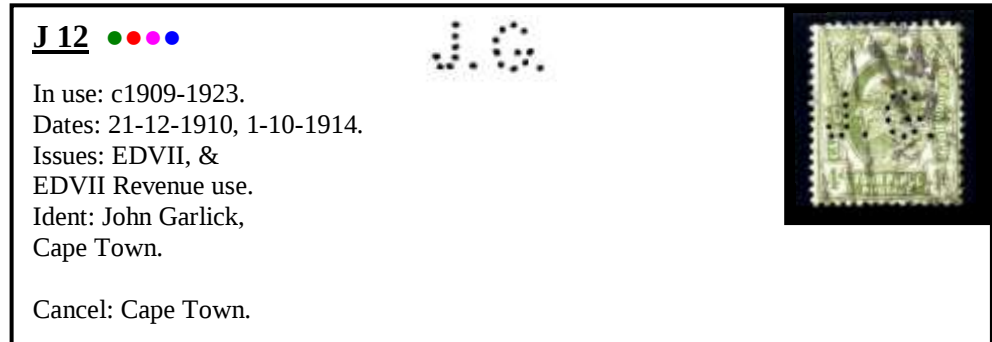
I have decided to make up my own version of the catalogue and produce it with an alphabetical numbering system for the different dies, This **Section One**, deals with the **Four Different Provinces Pre 1910** as in the map above. A coloured dot system  is used to indicate the different Provinces stamps that are found with particular perfin dies. You will see from the map what colours represent which Provinces. The Union & Republic of South Africa post 1910 are dealt with in Section two of the catalogue. There is also user information alongside the Perfin image. A single letter "M" after the die number indicates a multi headed die. A small case "m" indicates a monogram die.

- Suspected Ident:** Ø This symbol indicates a suspected identity.

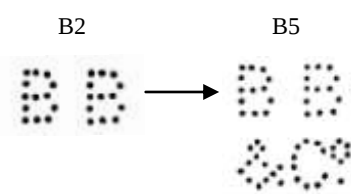
Baker, King & Co: "BB" & "BK" Type perfins

According to information supplied by the Kaffrarian Museum King Williamstown, Thomas Burnham King in partnership with Mr. E Coles Baker, founded the company, Baker King & Co in 1861 in King Williamstown. However it is suspected it was actually founded in 1861 as "Baker Brothers" and Mr. King later became a partner and eventually the sole proprietor. Their business was as "General Merchants and Importers" but they were more "Wholesale Merchants" as they imported goods which they sold to the inhabitants of King Williamstown or sold and traded with the small traders in Kaffraria and Transkei. The business must have flourished as a head office was established in East London, and other premises were sourced in Cape Town and Port Elizabeth. Several premises are recorded in King Williamstown all specializing in general goods, haberdashery, furniture, grain etc.

During the period from the 1890s to the early 1940s, several perforators were in use at different centers, based on a "BB/Co" format and later "BK/Co". Of the eight perfins of this type recorded in South Africa, six have been plausibly identified and two others could well be of the same family. the following seven dies are all recorded on the stamps of the Provinces.

* Measurements on these two perfin dies suggest that die **B2** was created from the die **B5** by the removal of the "&Co" pins.

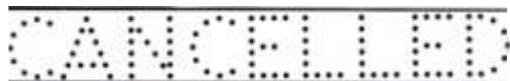

Found with 1913-14 cancellations, on V R I Orange Tree surcharges, EDVII provincial postage stamps, Union commemoratives, and GV kings head postage stamps. Hundreds known.

(No mint examples known.) All denominations from 1d to £1 (no ½d stamps yet seen!) larger denominations just as common as low denominations (apart from £1, which is scarce). Narrow date range: most between 13 November 1913 and 28 February 1914, but two outliers in September 1914.

Wide range of smaller and larger post offices; parcel office cancellations fairly common. Clear from microscope examination that they were cancelled before they were perfined; probably all by same machine, probably perfined on forms in bundles – a few with retained discs, and would explain placement not really in relation to stamps. ? Audit followed by destruction; one leakage

suggested explanations includes use on Telegram forms.

Used to pay customs duty on foreign parcels seems more likely.

THE "NATAL WITNESS" NEWSPAPER AND ITS PERFINS

There are four types of perfins used by the firm of P. Davis & Sons, Pietermaritzburg publishers of "*The Natal Witness*" newspaper for about 30 years at least. These are a 'PD&S' / 'D&S' that have been seen only on QV Natal stamps, a 'D' and 'W' seen on both QV and KE VII stamps, and a pair of vertical parallel holes found on KE VII stamps of Natal. *The Natal Witness* is South Africa's oldest newspaper. These perfins may be found on stamps used on letters, postcards, or parcels. The 1d, 2d QV, ½d, 1d, 3d, 6d, and 1s KE VII stamps are recorded with the 'Witness' type perfins. Businesses would perforate stamps with letters or other symbols to prevent them being pilfered.

David Dale Buchanan (Fig.1 below) the founder of the *Natal Witness* newspaper, wrote to Donald Moodie, Secretary to the Governor of Natal on 23 Feb 1846 informing him that he was about to publish a newspaper in Pietermaritzburg. Three days later the first issue of the newspaper appeared on 27 February 1846 (Anon. 1981). Buchanan came from Scotland and together with his brother arrived in Cape Town where David worked for the *Cape Town Mail*, but became dissatisfied and ventured to Natal with his wife and children arriving in January 1846. He brought printers type and a hand-operated press that produced 200 copies per hour which were handed out free.

The paper was carried to Durban together with mail (charged 6d / sheet) by runners. Initially the 'Witness Private Mail Service' left at noon on Saturdays returning on Thursday. Later the arrangement was for a runner from Pietermaritzburg and one from Durban to meet halfway and exchanged mail bags. They were each paid 6d per trip.

In 1852 Buchanan handed over control of the *Natal Witness* to the firm of John May and Peter Davis but he remained as editor. May retired in 1860 and Davis remained in charge. He established the firm P. Davis & Sons. In 1868 Buchanan left for England and when he returned he found that his law practice had diminished. He contracted malaria and later died in September 1874.

Peter Davis (Senior) was mayor of Pietermaritzburg on three occasions and retired in 1873. In 1876 a steam press was acquired which allowed for a larger production of the newspaper. Peter Davis Junior took over control when his father retired and is credited with being a pioneer of journalism in South Africa. The business expanded its commercial activities and advertised that they were also lithographers, illuminators, booksellers and stationers. Davis retired in 1916 but died in 1919. at the age of 82.

THE COMPANY.

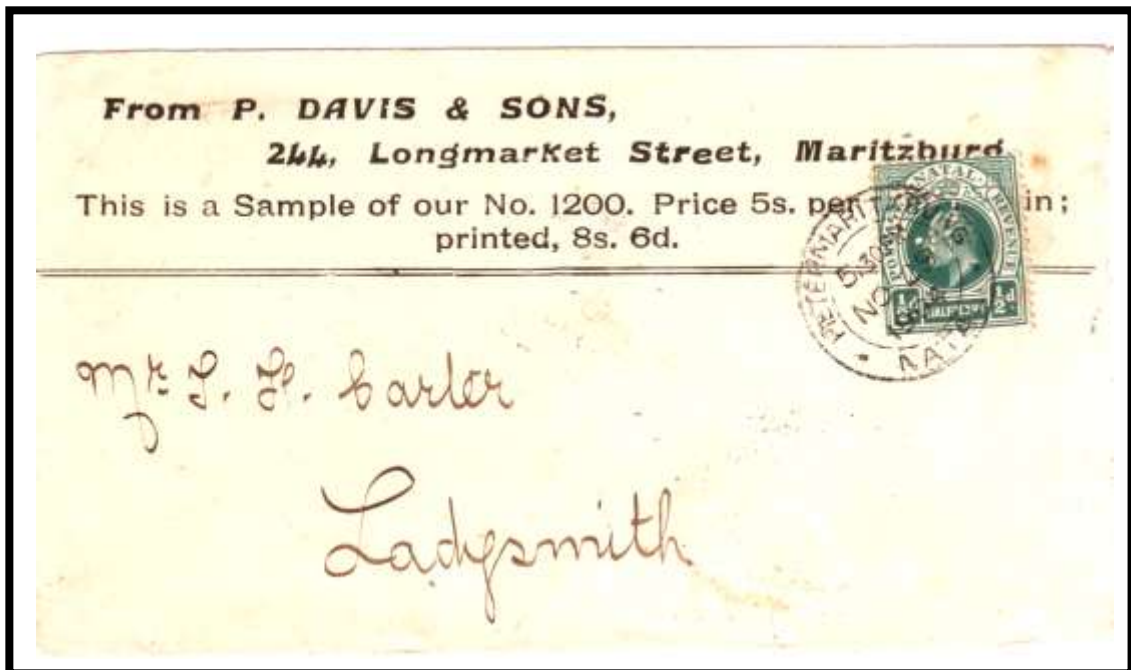
It was during the time when Peter Davis Junior was in control of *The Natal Witness* that the first perfins were used reading either 'PD&S' or 'D&S' They were used by P. Davis & Sons of Pietermaritzburg.



THE 'D' PERFIN.



The 'D' perfin is composed of 13 holes, the earliest date recorded is 28 AP 1902 and the latest date is 1909. This perfin is found facing either left, right, up, or down, double, and with missing perfin holes.

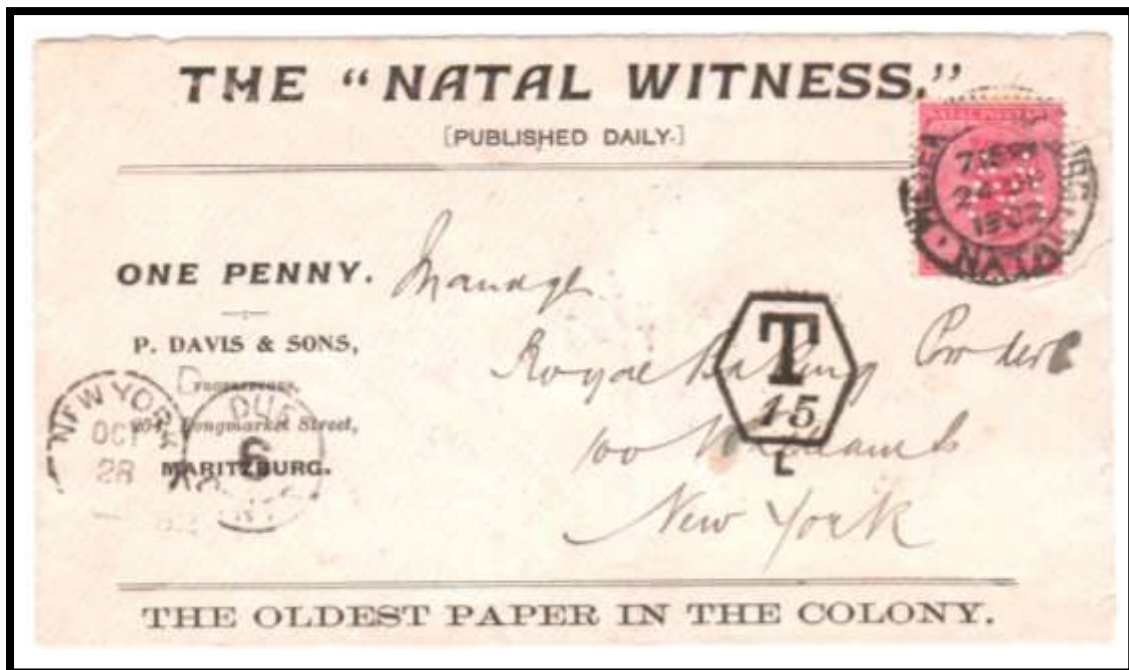

THE 'W' PERFIN.



The 'W' perfin comprises 17 punched holes. The earliest use is on a cover dated 18 AU 1902 and the latest use is 3 DE 1905. It is found normal, inverted, facing left or right, with missing perfin holes, or some blind, and rarely as a double perfin.



1902 taxed 'NATAL WITNESS' cover cancelled Pietermaritzburg 24 SP 1902, stamp with inverted 'W', to New York underpaid by 1½d. On arrival on 10 OCT 1902 taxed 6 cents (15 centimes).

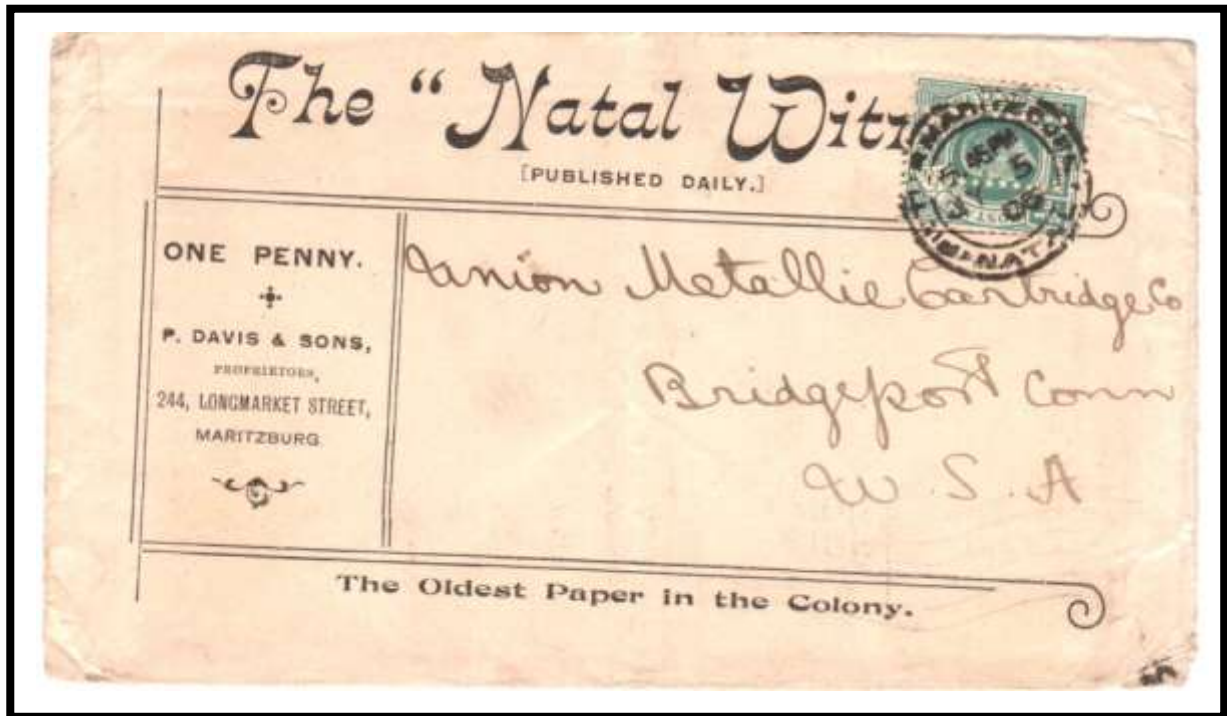

PAIR OF PARALLEL PERFIN HOLES.

The earliest use of the pair of parallel perfins is NO 24 05 and the latest use is JL 7 06. Each row is composed of 13 punched holes. It may be found as a single vertical row of holes. Importantly it should not be confused with the stamps being miss-perforated.

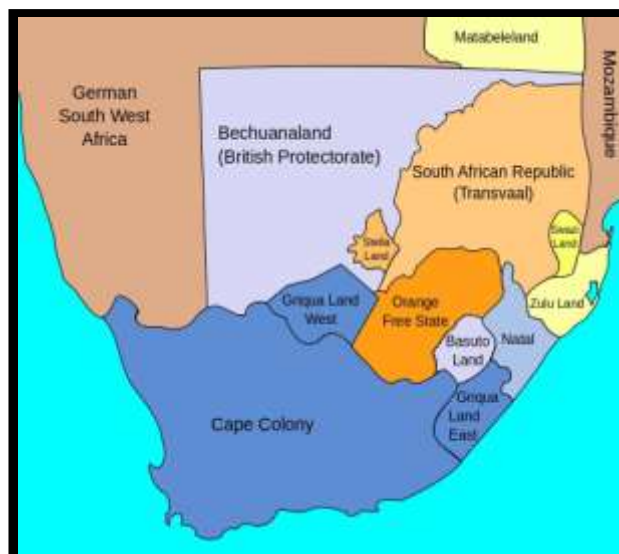
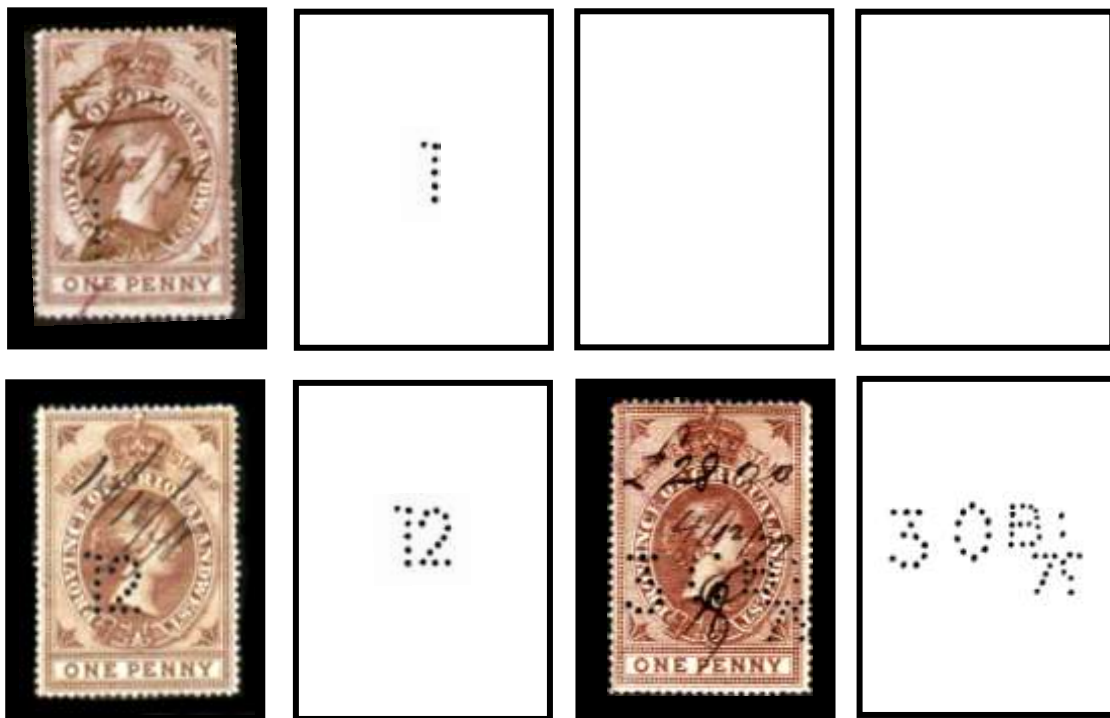

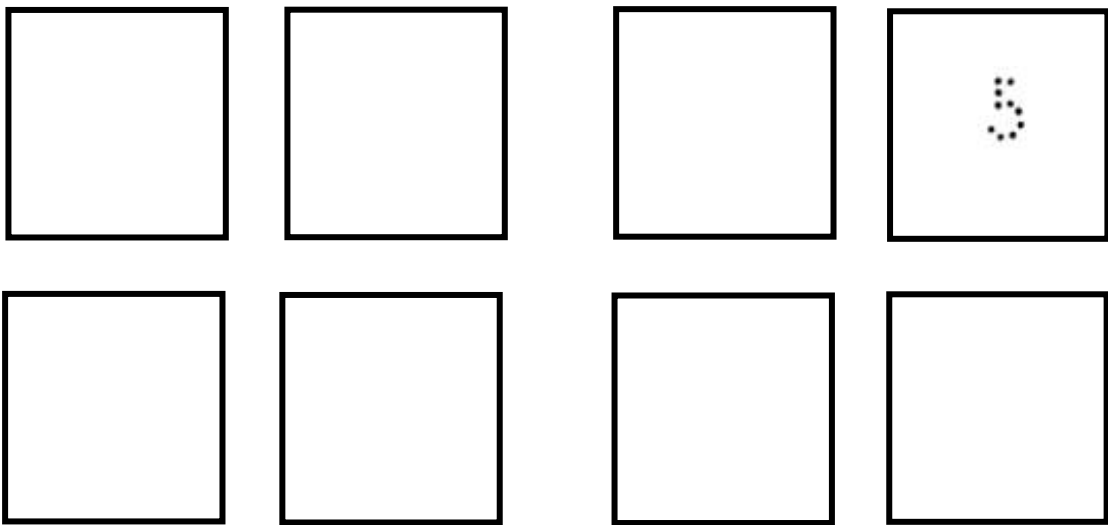

From an interest point of view I am including this page of **Fake Overprints**. Over the last few years there have been quite a number of these fake overprints found. Most of them are easily recognized as fakes with the overprint being on top of the cancel, the wrong font, or of the wrong dimensions.

Below are some examples to give the collector an image of what to look out for. British cancels are most prevalent, and wrong dimensions, fonts etc. **Fake** overprints can also be found on British perfin stamps overprinted "British Oil Rivers" & "British Protectorate Oil Rivers"

No genuine overprinted stamps with perfins have so far been recorded.
