## PERFIN FRANKS THIS ISSUE

By kind permission of the Borough Treasurer of Folkestone Corporation, we have been able to purchase enough 2d stamps, perforated F/BC 2H 7/11,7 to frank this issue.

Stamps with this perfin are used by all departments of the Corporation (otherwise known as Folkestone Borough Council).

The perforating was originally done by Slopers but was changed later to Waterlows when it was found that their charges for overprinting (for receipt stamps) were lower. It was thought to be more convenient to have everything done by the same firm.

Perfins have been used for only about 5 years, prior to that ordinary stamps were purchased by each department from its petty cash.

Only the  $\frac{1}{2}$ d, 1d, 2d, 3d, 4 $\frac{1}{2}$ d, 6d, and 1/- values of QE II have been perforated.

### MEMBER ACTIVITIES

The E.H. EVANS Challenge Trophy awarded to the winner of an exhibition held annually by the Wallasey Philatelic Society has, this year, been won by Miss M.E. Thornton, one of our members,-- the subject - PERFINS.

Competition rules allowed only four pages to be submitted for each entry which set Miss Thornton a bit of a problem in showing perfins to their best advantage. However, she obviously made the entry interesting enough to catch the judges' eye and we now give brief details about how this entry was composed.

The first page was "historical" showing a few overprinted and underprinted initials together with a copy of the traditionally first perfin of T J ALLMAN. The second showed examples of the same perfin runnung through five reigns, e.g., perfins of City of London, Co-operative Wholesale Society, and the Army & Navy Stores etc. The third gave a few Railway perfins and the fourth some full names commencing with ADAM.

Our congratulations go to Miss Thornton for such a fine effort in winning the trophy which apparently has never been held by a woman before.

- B. BUYING MEMBER'S
  - 1. Approval books will be made up of all different perfins arranged alphabetically and priced individually according to their estimated rarity. In general, prices -vary from 1 to 10 points per perfin, 5 points being equal to a penny.
  - 2.Books will be sent to members on request and should be returned within 7 days together with a remittance for perfins retained.

For amounts greater than 1/-, postal order.

3. Further books will be made up as new material is available and will be sent to buying members without further request unless the Superintendent is instructed otherwise.
