# LANCASHIRE COUNTY COUNCIL PERFIN

This difference is to be found in the two letters 'C' which n the case of the Lancashire perfin have straight backs and hence have a squarer appearance.

'PERFIN' or ..... discussion

I recently received a letter from our President, Mr. Jennings on the above subject and as the members are being asked to vote and comment this month, I feel that the letter should be published. The letter appears so heart felt that I have decided to include Mr. Jennings' actual words rather than alter any thing and so loose the point of his views:

# Dear Sir,

Further to the correspondence in the July Newsletter regarding the term 'Perfin', I would like to observe that, if it is thee sole purpose of the Group to collect and study punctured stamps and to ignore their origins in the under and over-printed issues, then there is nothing wrong with the term 'Perfins' or any other name they care to call them. Neither they nor their hobby will ever be regarded seriously by other accepted philatelists and the Group will ba looked upon with some amusement as a minority pursuing some 'back-alley' of philately.

If, however, members are seriously concerned with the mole subject of stamps specially treated, no \_matter how, for security purposes then they must also include, if only on simplified lines, some examples of the early processes. In this event the term 'Perfins' is not wholly descriptive of the subject. 'Security Endorsements' is not, I agree, a correct definition and it is a little pompous. Let us just call them 'Security Stamps' or something that will, at least embrace the whole subject.

If members are not interested in the earlier stamps, then I an afraid that one-third of my proposed book wind be so much waste to them.

Non-collectors of these stamps do not yet realise that the so-called 'Perfins' are the authorised substitute for under and over-prints and while they will avidly seek the latter they reject punctured stamps as defective specimens.

Unless we can bring other sections of the collecting fraternity to regard us seriously we can never hope to gain recognition for our subject by the stamp trade or by organisers of major stamp exhibitions.

Is it just possible that a section of the members are afraid that the introduction of the earlier issues would bring some high-priced material into their subject and that they are quite happy collecting 'damaged' stamps at a fraction of their catalogue value and displaying them under the guise that they are interesting as 'Perfins'.?
