FROM THE CATALOGUE EDITOR

As we are now nearing the end of another revision of the Perfin Catalogues thought should be given to the next stage.

A suggestion has been received that an illustrated catalogue be produced, but in view of the fact that there are about 10,000 different types, I do not feel that this is possible owing to cost and difficulty of production.

A compromise could be made with a catalogue listing all types of dies described by the system now used for the Identities listing.

I shall be pleased to hear what other members think about this and I shall be happy to receive any suggestions they care to make. Such a catalogue is possible and perfins which are not identified, or of which I have no details at the time of publication, would be advised via the bulletin when details become known.

OFFICIALS CATALOGUE

Miss Thornton has completed all manuscript for the remaining pages of the Officials Catalogue and this is held by the Editor awaiting publication.

It will be several months yet before publication is completed but we are sure that you will join in with our thanks to Miss Thornton for such a sterling effort. Everyone will appreciate just how much time and effort she must have put into researching and compiling the 130 or so pages that the work comprises, and we are sure that all will agree she has made an excellent job of it.

Whilst on the subject of Official perfins, does anyone have any thoughts on the status of the NA/FI perfins? The Navy, Army and Air Force Institution is a non profit making body which exists purely for the benefit of the armed forces. Miss Thornton wonders whether this warrants official status.

SUBSCRIPTIONS

We hear from the Treasurer that a fair number of subscriptions have not been renewed yet. There will not be many more reminders so renew NOW if you have not already done so. HON. TREASURER'S REPORT

Once again the Society has had a successful year financially. The increase in the excess of income over expenditure which has occurred in 1969/70 is largely due to a substantial increase in the sale of publications. Members have our President and Editor to thank for producing these publications, which have so greatly improved the Society's financial position.

Despite the sharp rise in postage rates promised for early next year, and the continual increase in the price of virtually everything, there does not appear to be any need to increase subscriptions in the immediate future.

Membership has again risen, and at 31st August 1970 there was a net increase of 7 members, bringing the total membership of the Society to 107 at that date.

It would be gratefully appreciated if members remember the following when making remittances:

- a) Remittances, other than annual subscriptions, will not be acknowledged unless requested.
- b) All cheques and postal orders should be made payable to the Society and not to individual officers.
- c) Members in the U.K. may only make remittances by stamps for amounts of 1/- or under.
- d) Members who live overseas are asked to send bank notes where possible or, failing that, international money

orders, when making payments to the Society. Those in the U.S.A. who send cheques must expect to bear a substantial collection charge, which in many eases is as much as 6/-(72c) per cheque. This charge is made on the Society by deduction from the proceeds of the cheque, so that all those members in the U.S.A., who wish to pay by cheque must allow for this bank charge when making payments in this manner. The Society's bank has also recently introduced a commission of 1/-(12c) on cashing bank notes.

e) It is hoped that members overseas will find helpful the

system of current accounts incorporating the automatic debiting of subscriptions, as and when they become due, and where funds are available.

Finally, I should like to thank John Nelson and Ron Bowman for the enormous amount of help they have given me since my appointment as Treasurer earlier this year.

QUERIES WHO USED THEM

This very distinctive perfin seems to have been in use for at least 62 years. My earliest example is on ld lilac with postmark date 1899, and my latest is on a K.G.VI 1½d dark brown (issued 1937).

Originally the M had 17 holes, according to my examples of Q.V. & K.E.VII. On the later stamps from 1½d of K.G.V., the bottom hole of the M is

missing. Postmarks are London, W or London, W.1.

The stamps seem to have been carefully perforated and the initials are central. About half my examples show the letters reversed.

I have this perfin used on ld lilac with postmark date 1890, and on stamps of all other reigns to that of K.G.VI - 2d orange with 1940 postmark, so it must have been in use for at least 50 years.

My stamps show a diversity of postmarks - Bristol, Cardiff, Cork, Dundee, Edinburgh, London, Plymouth, Newcastle-on-Tyne, Sunderland - all places on the

coast or on large rivers. Also postmarks of Blackburn, Nottingham and Manchester.

There is also an S.S on the line engraved stamps with S= 11 holes. Postmarks on mine are Belfast, Bournemouth, Edinburgh, Leeds and London.

My earliest example of this quite common perfin is on a K.G.V ld, block watermark with postmark date 1927, and my latest on the K.G.Vl dark colours (issued 1937).

One stamp is on a scrap of paper with parts of two words in script lettering.

ROVE In very smal blurred print between NDON W the words is a name that looks like DEUCHMANS Limited.

Answers to these three to Miss Thornton please.

- 4. This die is not complete and doubtful details are shown in brackets. Confirmation of complete die is required. CM(J) 8,17,(7) 6mm.
- 5. Can anyone provide the complete name for the following? L.H/L 7,12/7 5mm. LOUIS HENLE 3, Budge Row, London, E.C. The stamp is 2½d rosy mauve Plate 1.
