#### CD & ROYAL SCROLL CANCEL

From the prolific pen of Mike Burrows comes the following in response to the "Royal" cover recorded by Peter Burrows in our last issue,

The term 'Royal' must be attributed to G.V. Eltringham an eminent student of the cancellation.

At a meeting of the Royal Philatelic Society in London on 5th December 1957, he presented a 'five-minute' paper in which he stated

"Of the covers or pieces that I have seen bearing these cancellations, most carry the Royal Arms or other clear evidence on the envelope flap, thus denoting a Royal source of origin. The remaining covers noted have in each case consisted of a House of Commons envelope and it is suggested that these contained letters written during visits to one or more of the Royal residences. No covers have been seen without such evidence......"

The postmark which was brought into use on 6th November 1882 was not recorded until May 1949, and is reasonably rare. G.V. Eltringham had, by 1957, recorded thirty six copies giving a date range of 10th November 1882 to 7th March 1900, with codes A, B, C, and D. Where the canceller was kept does not seem to be recorded in the Philatelic press. The answer can no doubt be found in the G.P.O. records. A probability is the South Western D.O.

The cover recorded by Peter Burrovis appears to raise some doubt on the restricted use of the cancellation unless the usage was as a stamped addressed envelope for a reply.

# PERFINS FOR SALE

Ron Bowman has some further lots of Q.E.II perfins for sale at £1,25 for 500 or £2.25 for 1,000. Mostly Machins but some Wildings. Offered just-as-they-come with 10% added to cover damaged.

#### G.B. KENT & SONS LIMITED

Established in 1777 by William Kent this firm of brush manufacturers and sponge merchants went through various partnerships to become G.B. Kent & Company in 1854. This was changed to G.B. Kent & Sons in 1880. Located at 11, Great Marlborough Street, London, W., in 1885, the Company was incorporated on 2nd July 1900.

A 1910 directory shows 15, Robinson Road, London, N.E., as the firm's headquarters, whilst trade lists of the 1920's give the address of the head office as 75, Farringdon Road, London, E.C.l., with a factory sited at Victoria Park, London, E. An out-of-town works could be found at Hemel Hempstead in Hertfordshire.

With the slogan "BEST BRITISH BRUSHES" the Company continued to flourish, and by the 1960's Crosby Comb Company Limited and Titterton & Howard Limited were under the Kent mantle. The Company then being operated from 24, Old Broad Street, London, W.1.

# Perfin : S.G. 14,12 9½mm

When Lt. Colonel John Raymond Danson 112.C., T.D., M.A., passed away on 18th June 1976 the philatelic world mourned the loss of yet another of that all too rare type of philatelist who believes in sharing, through publication, the knowledge they have gained through study of their possesions which others less fortunate are unable to acquire. The dispersal of the Sudan portion of the DANSON collection was entrusted to the Robson Lowe organisation who in 1977 conducted two sales. One held in Geneva on

In the catalogue of the Geneva sale it is lot 844, which with the excellent illustration, is of great interest to the student of the first official perfin of the Sudan. This lot was a block of 20 (5 x 4) of the 5m issue of 1897 for Egypt, which was printed by Thomas De La Rue & Company Limited in sheets of 240, divided into 4 panes of 60 (6 rows of 10), and is thought to be the largest mint piece in existance. The issue was later overprinted in Arabic and French for use in the Sudan and released perfinned on the 8th February 19000

Study of the half-tone photograph of this block confirms, as had been originally stated\* that it was perforated on a single die hand operated machine. The examination reveals that the first row has the perfin reading correctly. The second row is inverted/ reversed. The third row is reversed and the fourth inverted. From this it will be realised that the various positions came about by folding the block in half, perforating one side, then turning the whole around and perforating the other side. Specialists in this issue have identified each row of the overprint by its various characteristics. So it might be possible to determine exactly from which position of the original plate this large block came from.

When it came to bidding this, at present unique item, sold for 425 Swiss francs.

In the same sale, a similar item, a block of 12  $(4 \times 3)$  was either unsold or withdrawn. This same piece appeared as Lot 2200 in the sale in London in November, where it was considered to be of sufficient importance to warrant an illustration. Although from a different pane position, the perfin appears as before. The first row normal, the second row inverted/reversed, and the third row reversed. The block sold for £50.

Single stamps on cover were on offer at both sales, with covers originating from BERBER, KHARTOUM, OMDURIVIAN and WADI-HALFA CAMP.

Officials Catalogue (Now out of print) 1 & 2/79/Page 7 Of the lm brown and pink, watermark Quatrefoil, issued perfinned in January 1901, a complete pane of 12 x 5 of this famous camel issue was unsold. In the various lots of mint and used the c.d.s, for FASHODA was noted. A collection of 45 used sold for £135. Whilst two covers, one cancelled KHARTOUM and the other ARMY/B 14 11 02 N/TELEGRAPHS, made nearly twice the valuation and eventually went for £105 the pair.

No example of the companion 5m watermark Quatrefoil was in evidence. In the S.E.P.S. catalogue previously mentioned two copies of the 5m with Die 1 perfin are recorded as being in the COLONEL HEBBERT collection. This collection was incorporated into the November sale, the vendors being Gonville & Caius College, Cambridge, to whom it had boon presented. The purpose of selling was to establish the 'H.E. Hebbert Trust' for studentships at that college.

In 1912 D.B. Armstrong gave a figure of 500 for the 5m perfin. Presumably this appeared in his handbook published by Messrs. Bright & Son, part of a series entitled Bright's Philatelic Library. As both the lm and 5m were printd by De La Rue in sheets of 120 stamps, arranged in two vertically disposed panes of 60, containing 5 rows of 12 impressions, it would seem logical that 480 might be the correct figue. Although Armstrong can never be accused of being given to error, a figure divisible by either 120 or 60 would seem to make more sense.

# THE NAME GAME Mike J. Burrows

One of the early customers of Joseph Sloper was Samuel Montagu (or was it Montagu Samuel?) who was the user of the perfin

As you will see it could just as easily have been MS/&Co.

In Liverpool on 21st December 1832, Henrietta Samuel gave birth to her second son, which she and her husband Louis, decided to name Montagu. Whilst the child was still young they changed their minds, for reasons best known to themselves, and reversed his names and began to call him by his surname.

At thirteen years of age he obtained employment with his brother-in-law, a foreign banker in Lombard Street, London. Moving about a bit he eventually opened his own bullion merchant, foreign exchange and banking business in February 1853. His eldest brother, Edwin, was taken in as a partner, the firm being known as Samuel & Montagu,

In 1862 the name of the concern was changed to Samuel Montagu Company. A year later offices were found at 60, Old Broad, Street, London, and in the same year he was created Baron Swaythling.

In 1894 he obtained a royal licence to change his name to Samuel Montagu. A further application in 1904 saw the change to Samuel-Montagu.

A very active and philanthropic member of the Jewish community he died on 12th January 1911.

The earliest dated perfin that I have seen is JY 26 69 and this of the style constructed to avoid the Queen's profile. A rather prolific perfin on the surface-printed issues it seems to have been dispensed with during the early 1880's. My latest date is MY 17 81, but a 1/- Foreign Bill fiscal of 1856, with a London scroll postmark for 28 DIE 85 is illustrated in the December 1978 issue of the Philatelist.

Other perfins in a similar style are known, Cat. Nos. 492.3 and 492.3a. Has anyone a cover to identify them?

The United Baltic Corporation Limited was formed in 1919 under an agreement between Andrew Weir & Co. Ltd. (owners of the Bank Line) and the East \_Asiatic Company of Copenhsgen. Perfins are known from K.G.V. to Q.E.II. with UB/C in two sizes and a third type which is a mixture of sizes and could be a wartime provisional.

0321 Flour graders hove a lumpy time Burrows M.J. SEPS Bull., July/Aug. 1978, (176), 3

In April 1978, Spillers ceased to manufacture bread and closed its 23 bakeries. Started as a flour mill in 1832 by Joel Spiller, the company grew to be a major force in the U.K. food industry. The perfins used by the company illustrate its changes over the years:- S&B/LD (Spillers & Bakers Ltd.), SI/LD (Spillers Industries Ltd) and SL (Spillers Ltd).

0322 Punctured officials of New South Wales - the Type 9 puncture;\* Simpendorfcr J.

> Aust. Commonw. Collect. Club N.S.W. - Bull., April 1974, 3, (4), 16 - 17

It is very difficult to separate Type 7 and Type 9 G/NSW perfins with certainty either by the size of the holes or the dimensions of the patterns as there is some area of overlap. The simplest method of identification is to take a certain Type 7 with small holes and size 15mm x 17mm, and use it as a template. All Type 7 perfins will fit it exactly whilst the Type 9 perfins will gradually run out of register. A full list of all stamps known with\_the Type 9 perfin is included.

0323 Postage stamps punctured for official use in Government departments of the State of Western Australia Lloyd-Smith JR. Aust. Commonw. Collect. Club N.S.W. - Bull., April 1954, <u>3</u>, (4), 19-20

The perfins WA and OS are found on the stamps of Eastern Australia used by various Government departments. A list of such stamps in the authors collection, including the earliest known date of use, is given.

0324 Another new perfin Spencer A. Perfins Bull., July/Aug. 1978, <u>31</u>, (7), 2 Albert Spencer's personal perfin shows his musical interests by incorporating a treble cleff with his initiels.

0315 continued A now State of Michigan perfin (M in circle) is shown which has been produced by removing every other pin from the circle of the original perforator.

0316 Early Canadian perfins\* Dicketts N. Perfins Bull., May 1978, 31, (5), 7

Perfins on the small Queen's head issues of Canada are; very scarce. U.J. Gage Co. Ltd. of Toronto was the earliest user although the Intercontinental Railway and the uncertain (J. H. Semple?) user of the J.H.S. porfin are also known to have used their perfins on these issues.

0317 Punctured Officials of New South WDlas\* Watkins A.F. Aust. Commonw. Collact. Club N.S.W. - Bull., March 1963,  $\underline{2}$ , (3), 24-26; May 1963,  $\underline{2}$ , (5), 43-49; June 1963, 2, (6), 56-61; July 1963, 2,(7), 72-75; Aug. 1963, 2, (8), 85-90; Sept. 1963, 2, (9), 96-99 & Oct. 1963, 2, (10), 103-105.

There are nine different types of official perfin used by the State Government of New South ialus. All of the perfins are illustrated and every stamp on which each perfin is known is listed together with the varieties found (inverted, sideways perfin, etc.) Two Australian Antarctic Territory stamps are also known with the G/NSW perfin.

0318 The "status" of postage stamps punctured for use in Federal, and State Government departments. Sheppard N.J. Aust. Commonw. Colloct. Club N.S.W. - Bull., Nov. 1963, 2, (11) , 112-113,

Although State and Federal Government official perfins were authorised by the Government and fulfilled the same purpose as tho overprinted OS stamps, they have been maligned and largely ignored for some forty years. In a reply from the P.M.G's Department, dated 1909, it is pointed out that both the Federal and State Governments are customers of the Post Office and can perforate their stamps as can any other person or firm.

0319 Canadian Pacific Shipping Line\* SEPS Bull., July/Aug. 1978, (176), 3

In 1903, the Canadian Pacific Railway Company entered the Atlantic shipping trade by purchasing the Beaver Line from Elder Dempster. In spite of the outlay of almost £1½ million they failed to obtain the Canadian Mail contract which went to the Allen Line. In 1915 the Allen Line was merged with C.P.R.'s Atlantic shipping interests. The company used the perfin C.P./S. which is known on the stamps of all reigns from K.G.V. to Q.E.II.
