## S.E.P.S. SPRING AUCTION

The Spring Auction went off successfully with 130 of the 140 lots on offer being sold. The highest price realised was £16.10 for a lot of 392 Edward VII perfins, although the top bidder would have gone much higher for them. Some quite staggering bids on other lots, especially non G.B. items, shows the continuing trend of demand far exceeding the supply of material.

Nevertheless, about 75% of the bidders received at least one lot, so on average most people should be happy - especially the vendors. If you wish to join their "happy band" there is still time to submit lots for the July Auction (lots by end of June at latest). There is already a fine array of material in hand but more is welcome

### WHO KNOWS THE ANSWER?

We have received the following plea from Jack Brandt in Canada,  
" A few months back I obtained two Great Britain perfin covers,  
one with an AB perfin and the other with an AS perfin.

Details are:

1. To: A. van der Valk Esq., Santiago, Chile,  
From. The Anglo South American Bank Limited.  
(embossed on flap)

Cancel: London 14 February 1933.

Stamps: K.G.V. 1924-26 2 x 1/-, 1 x 3d - all  
unperfinned and 1 x 6d (S.G. 426a)  
with perfin as shown but inverted.

Sent: By airmail, Santiago receipt cancel of 3 March 1933.

2. To: as above.

From: as above, with London address, all on brown tape used to  
seal the envelope.

Cancel: London 14 February 1933.

Stamps: K.G.V. 1924-26 1\_x 1d with no perfin  
and 1 x 6d (S.G. 426a) with AS perfin  
as shown but inverted.

Sent: By registered surface mail, Santiago  
receipt cancel of 13 March 1933.

Now comes the question - why on letters to the same person,  
from the same company, on the same stamp, and the only perfinned  
stamp on each cover, were there two different perfin types?  
Neither type is listed either in the McKee\_Tomkins, list or the  
old Van Lint listing.

I have been thinking for some time now, and have not come up  
with an answer. However, recently I acquired a Spanish cover with  
the perfin A.S./A.B., and the user identified as The Anglo-South  
American Bank Limited, with a Barcelona address. In the G.B.  
issues the AS and AB both sort of fit the user, but not as well  
as the Spanish type. So, I am wondering is it at all possible that  
machine perforating the G.B. issues punched different letters on  
different stamps? Such a practice is definitely known for perfins  
of the U.S.A., but I have not heard it for G.B. Who knows the  
answer, and will share it with us?"

## SALES PACKET

The operation of the Sales Packet has gradually deteriorated over the past few years and I feel that a few notes on the causes of the deterioration, and the steps being taken to put it right are needed.

Firstly, the previous 3 years have been very bad for me from a philatelic point of view; I got married; moved house; changed my job; and moved house yet again. This caused extreme disruption in my philatelic activities which are only now getting straightened out. It has also caused me to have two current addresses

(this is my parents' address which I continue to use for bulky items since they have a convenient porch for the postman to leave packets in) and

(this is my home address).

Either address will do, but for bulky items which might not fit through a standard letter box

The second problem was the loss of a packet last year, addressed to Mr S. Butler of Wrexham. He is no longer at his old address and my enquiries have failed to locate either him or the packet. To minimise such losses in the future, all Packets must be sent by recorded delivery, must bear no indication of contents, and have my address on the back. Hopefully then, if a Packet is presented to an out of date address, it will be refused and returned to me. Obviously, there is no need to return packets to me by recorded delivery, just obtain a certificate of posting.

The final problem is one of slow circulation. Please make every effort to pass packets on within 2 days of receipt (Sundays excepted). Packet R, sent out in the first week of January has averaged 1 week per person on the circulation list. In future, packets will be identified by the month they went into circulation (rather than by letter) so that evryone can see whether they have been delayed.

To provide a worthwhile service I intend to send out one packet each month. There is enough material on hand to see me up to the June packet. If you wish to see more packets each year, start making up some booklets now.

Packet Q This packet has been lost. The member to whom it was sent has moved and has now been dropped from the Society. All members owning booklets in this packet have been paid in full. The Society lost approximately £30.

Packet S Packet S was put into circulation in February and contains books to the value of £73,41.

Packet T This went out in April and contained 18 booklets to the value of £146.80.

April Packet This was not sent out until the first week in May and had 12 booklets with. a total value of £106,36.

0503 continued

During the Second World War, Thomas Cook & Son Ltd., were authorised to provide a forwarding service for letters to enemy territory. Initially, the service was run through various P.O. Boxes in Amsterdam but after the fall of the Netherlands, the facility was rearranged using Box 506 in Lisbon. The procedure used to transmit letters to and from enemy territory explains why some covers, apparently unconnected with Thomas Cook & Son bear their perfin.

0504 Agricultural & General Engineers Limited

Burrows, M.J.

S.E.P.S. Bull., July/Aug. 1979, (182), 4-6

Agricultural and General Engineers Ltd., was established in 1919 with the intention of providing a single marketing body for fourteen companies engaged in the agricultural engineering field. Of the companies involved in this conglomerate, four are known to have used perfins: Aveling & Porter Ltd. (A & P); E.H. Bentall & Co. Ltd. (EH/B/& Co); Bradford & Perkins Ltd. (B&F/P) and Richard Garret & Sons Ltd. (R.G.) The perfin J&IFH has been tentatively identified with James Frederick Howard Ltd.

0505 Dienstmarken II Fur die Bundesverwaltung (Official stamps II for the federal administration)

Katalog Schweiz/Liechtenstein und Campione 1969.

Zumstein & Cie., Bern, 1968, pp. 142-145

Translation: S.E.P.S. T 25, pp.6

From 1935 to 1938 Swiss official stamps were perfined with a cross. Subsequently, an overprinted cross was used to distinguish official stamps. All of the stamps which were perforated with a cross are listed and priced.

0506 Perforations from the Moscow postal department on stamps from pre-revolutionary Russia

Mazur, P.

Filat. SSSR, 1973, (5) , vii-viii

Translation: S.E.P.S. TRANS. 27, pp.6

To prevent the re-use of high value postage stamps on certain transit documents, the Russian department of posts and telegraphs instituted in 1908 secondary cancellation by perforation within the Moscow postal district. Details of the 48 Moscow postal districts which are known to have used a perforated cancel are given.

0507 Perfins odds'n ends

Roy, R.

Perfins can have intrinsic interest as well as interest concerned with the user. Examples given include a perfin on a very high face value stamp, the largest and smallest perfin area/stamp area ratios; a pair of stamps one with and one -, Without a perfin and a mirror image pair of perfins on the one stamp.

0508 Canadian users who remain unidentified  
Dicketts, M.

Perf. Bull., Apr. 1979, 32, (4), 3-4

Although Canada has relatively few perfins and these have been catalogued since 1955, there are still a few whose user is unknown. In an effort to identify the remaining perfins, seventeen are illustrated together with all the information known about them.

0509 A note on British affixer perfin

A number of coil testing labels perfinned DH/E are illustrated. The stamps appear to have been used to demonstrate an automatic stamp affixing machine of the Poko type, which simultaneously perfinned, moistened and applied stamps directly to envelopes.

0510 Discover a "new world": revenue perfins. Part 2  
Richerson, W.D.

Perf. Bull., Apr. 1979, 32, (4), 5-6

Certificates of sale of stock, which are the original source of very many revenue perfins are the equivalent of perfin covers with return addresses as they always bear the user's name. Additionally, being printed in large quantities in advance of use, they are usually overprinted when the company's name changes and thus trace that company's developments. A great many of the perforations on revenue stamps include numbers which indicate the date. These are invariably perforated cancellations which can often be found together with a normal perfin on the same stamp, Punched letters and initials are also frequently encountered on revenues.

0511 It might explain . . . .  
Burrows, M.J.

Perf. Bull., Apr. 1979, 32, (4), 7

Occasionally, British stamps are found which bear two different perfins. A possible reason for this is that one firm has remitted them to another firm as payment for return postage and the second firm has a policy of perforating all such incoming stamps. Evidence that this practice occurred is included in an advertisement for Francis A. Hancock, which is shown.

0512 Firms perforations on Russian stamps  
Mazur, P.

Filat. SSSR, 1975, (4), 29

Translation: S.E.P.S. TRANS. 28, pp.3

Although very seldom encountered, private firms perfins were permitted on Russian postage stamps from 1907. small number of Finnish firms used perfins prior to 1917. (when Finland was a Russian Grand Duchy) and so their perfins could be found on early Finnish and Tsarist Russian stamps.

- 0513 Liverpool cotton stamps

Cind. Philat., July 1979, 19, (3), 48-51 & 53  
The Liverpool Cotton Brokers Association was founded in 1843 and commenced to use stamps in 1875. In 1885, it merged with its rival the Liverpool Cotton Exchange and formed the Liverpool Cotton Association Ltd. Many of the stamps are known perfinned CH which is presumed to mean "Clearing House". The Cotton Brokers Bank was formed by the Liverpool Cotton Brokers Association in 1878 and it too produced stamps which can be found perfinned.
- 0514 Brian Birch corner. 4 Bulgarian perfins  
Birch, B. J.  
S.E.P.S. Bull., Jan./Feb. 1973, (143), 3  
An illustrated list of the eleven known Bulgarian perfins.
- 0515 The activities of the police  
Hobday, P.  
Stamp Mag. Mar. 1974, 40, (3), 22-25 & 37  
The beginnings and development of a specialised collection dealing with the activities of the police is described. Amongst the items included are two police perfins, the German POL and CP, used by the Jersey Chief of Police,
- 0516 Argentine Republic - 1899 "Liberty" and shield issue \*  
Overseas 1 Stamp Catalogue - A-C; 2nd Edn., Stanley Gibbons Publications Ltd., London, 1976, A87  
The 20p of the Liberty and shield issue is known with its centre inverted (SG 241b). Against the stamp is a note that it only exists perforated with the word "INUTILIZADO", having been used on bundles of newspapers before the error was discovered (Price £325)(Complete)
- 0517 Foreign catalog report  
Walker, F.A.  
Perf. Bull., May 1979, 32, (5), 1-2, 4 & 7  
A detailed report is given on the availability of catalogues of the perfins of specific countries which are held in the Perfins Club library.
- 0518 Great Britain precancelled perfins  
Burrows, M.J.  
Perfs. Bull., May 1979, 32, (5), 3 & 6  
G.B. has never used precancels of the style used by other countries but rather used special postmarks applied prior to posting. A checklist of perfins cancelled by such postmarks is given.
- 0519 Perfin cover of the month  
Maxa, V.  
Perf. Bull., May 1979, 32, (5), 4  
A cover bearing an Austrian stamp perfinned N./CR. of the National Cash Register Company is shown. Although there is no return address or users name, the envelope is illustrated in colour with a picture of a cash register and its satisfied owner.

- 0520 Advert for Baddeley Brothers' perforator\*  
Baddeley Brothers (London) Ltd.  
Am. Philat., Sept. 1977, 91, (9), 735  
The advert shows a drawing of a perforating machine  
and the perfin BB.
- 0521 Netherlands - 1943-44 issue \*  
Scott's Standard postage stamp catalogue - 1971  
127th Edn., Scott Publishing Co., New York, 1970,  
Vol. 2, 928  
In 1944, 200,000 copies of No. 247 (2c Swans)  
of the Germanic symbols issue, were privately punched  
with a cross and printed on the back with a number and the  
words "Prijs 15 Cent toeslag) ten bate Ned. Roode Kruis."  
These were sold at an exhibition, the surtax going to the  
Red Cross. The Dutch post office tolerated these stamps.

- 0522 G.B.: Tea Clearing House Stamps

Cind. Philat., July 1979, 19, (3), 53-54  
The Tea Clearing House stamps of Great Britain are  
known with the perfin T.C./&Co. although the user is not  
known.
- 0523 Beginners please: what is a SPIF?  
Rapkin, F.  
Stamp Mag., Aug. 1979, 45, (8), 79  
A very brief and basic introduction to perfins.
- 0524 Perfin of the Comptoir National d'Escompte de Paris  
Prins, J.  
Perf. Bull., July/Aug. 1976, 29, (7), 3-6  
The Comptoir National d'Escompte de Paris, one of  
the largest banks in France, was founded in 1889. As  
well as several hundred branches in France, it had branches  
throughout Europe and the French colonies in Africa.  
Sixty two perfins from the various branches of the Comptoir  
National can be found on French stamps and some 17 perfins  
of the overseas branches can be found on the stamps of the  
appropriate countries. Most of the patterns are illustrated  
together with two CN perfins which are not from Comptoir  
National.
- 0525 Common British official perfins  
Brandt, J.  
Perf. Bull., July/Aug. 1976, 29, (7), 7  
The most common British "official" perfins are  
DS/IR of the Department of Scientific and Industrial  
Research and HM/SO of Her(His) Majesty's Stationery Office.  
Prior to the introduction of the HM/SO perfin the  
S(crown)O perfin was used.

- 0526 Story behind the perfin: L-130, Daniel Low & Co., Salem, Mass.  
Walker, F.A., Crow, R.B., Murrin, R. & Haack, E.  
Perf. Bull., July/Aug. 1976, 29, (7), 7 & Sept. 1976, 29, (8), 7  
The U.S. Low perfin is known used between 1917 and 1941. It was used by Daniel Low & Co, of Salem, Mass, a mail order company established in 1868. Originally, a single die perforated was used to perforate the owner's last name through the stamps but this has now been discontinued in favour of a meter machine.
- 0527 Responses to articles - Faroe Islands perfins\*  
Bergman L.  
Perf. Bull., July/Aug. 1976, 29, (7), 8  
The following additional information is offered to the article by J.H. Baker in the March 1976 Perfins Bulletin: According to the late Ostergaard Hansen, the perfin "V.L." existed on provisionals. Hansen may have listed this in "Posthistorisk Tidsskrift" with other Danish perfins. Lot 818 in the Danam Stamp Company auction of May 1 and June 1, 1976 is "V.L. " perfins on provisionals tied to a piece from 1940. The oldest copy of this perfin in the author's collection dates from 1935 (Complete)
- 0528 Responses to articles - numerical perfins \*  
Brandt, J.  
Perf. Bull., July/Aug. 1976, 29, (7), 8 & 10  
Many countries stamps can be found with numbers or number and letter combinations perforated through them, four examples of which are illustrated. It is known that some of these at least are from address labels attached to films sent for processing. A list of 18 countries from which such perforations are known is included.
- 0529 The State of New Jersey perfin  
Jackson, P.T.  
Perf. Bull., July/Aug. 1976, 29, (7), 9  
Official departments of the State of New Jersey use the perfin S/NJ. Two perforating machines are used - both manufactured by the Cummins Perforator Co. of Chicago. Various minor varieties have occurred over the years due to breakages and repairs, five of which are illustrated. As an example of the usefulness of perfins, an account is given of an employee apprehended after having used some of the State stamps for private postage.
- 0530 Perfin cover of the month  
Crow, R.B.  
Perf. Bull., July/Aug. 1976, 29, (7), 10  
The Mishawaka Woollen Manufacturing Co, use the perfin BB (in a circle) which stands for thuir "Ball-Band" rubber and woollen footwear. An advertising cover is shown bearing a 1912 2c stamp perfinned by the Mishawaka Woollen Manufacturing Co, which doesn't appear to have been used until 1949 - an unaccounted for lapse of 37 years.
