
He came across the five similar patterns in a lot bought at auction. They are all on KGV1 dark colours 1d or 2½d S.G. 463a or 466a and postmarked London Nov. 1941 and Dec, 1941.

It has been ascertained that they are not Braille symbols. So what are they? Some form, of coding? They clearly came from coil dispensing machines and do

have the appearance being produced by the removal of the appropriate pins. The illustrations are as viewed from the back of the stamp, sideways to show the watermark upright. SUBSCRIPTIONS

- ALTRINCHAM AC Confirmation still sought for Cat. No. 101.9 although postmarks tend to verify.
- BANGOR BC Cat. No. 111.3. Can anyone confirm this by cover? Similarly, does anyone know when Borough status was granted?
- BATTERSEA Cat. No. 41.4 BB 14,14 5mm. Member L.W. Brown has a number of receipts for rates from the years 1895 to 1901 bearing perfins which could be assumed to be three separate dies. We believe however that they are missing pin varieties of the above die. The majority of these varieties show 'BP' whilst in others the secon 'B' looks like a '5' or a small 'D' underlined with three dots. Does anyone have similar varieties, particulary in pair with the normal? Here again we have been unable to determine in local libraries the date of incorporation as a Borough. Can anyone help?
