MEMBERS' QUERIES.

MIKE BAVIN has come across a very unusual block (x4) of the GV 1/photogravure, cancelled with a boxed London Parcel/Western. All have the perfin JL/&C°, 7,7/12,8,6 4¹/₂mm but the upper pair have a flat topped ampersand Ia and the lower pair have a round topped ampersand IIIa. The block remained intact when floated from the backing paper.

Has any other member come across such a phenomenon? How did this happen? Mike asks if they could be from a 4 impression machine, or a 40 impression treadle? He thinks that stencils were used for marking out or even as guides when drilling. Perhaps the stencils were accidentally mixed when the above machine was being prepared.

DAVE HILL asks if anyone can confirm if the firm Eyre & Spottiswoode were at 15 Bedford St., Strand, W.C.2 and published 'The New English Review Magazine'? The perfin is E411.1 - ES 9,9 4¹/₂mm GVI stamps.

(I have a 1940 Newswrapper with this perfin on 1d GV1 Dark Colours. The Wrapper is headed "Parliamentary Proceedings" and the address is 'Eyre & Spottiswoode (P),Ltd., Government Booksellers 4 Legal Publishers, 6 Great New Street, London E.E.4. M. R. Smith.)

A second query from Dave concerns C4657.02 C/L^{td} 8/7,6,8 $6\frac{1}{2}/5\frac{1}{2}$. Dave has this on a 3d Wilding, which is on an envelope with an additional nonperfin 1d Machin. The name on the envelope is TREBOR not CLARNICO.

(My cover is dated 1961 with 3d Wilding and is identified as CLARNICO). He says the 1981 Kelly's directory shows no link with TREBOR. Has anyone any suggestions or dates about a merger?

A third question is about B2910.02 BG $4\frac{1}{2}$. This is on a 4d Machin with identity on cover of J.B. Cramer, Music Publishers of 99 St. Martins Lane. Again no clues in the 1981 directory.

MEMBERS'COMMENTS ON PREVIOUS ARTICLES.

<u>G.W.R. Overprint</u> Bulletin 242 Page 12.

At the London meeting on Nov.4th last, Martin Knight said he had had no answer to his article. Since then I have had one reply from ARTHUR SMITH. He has two copies of Brian Smith's stamp dated July 14th, 1876 but he too can offer no solution as to the purpose of the overprint. The photocopy of this stamp was very poor in Bulletin 242 and it perhaps was not clear that the overprint on this one (right hand illustration) was placed diagonally and the letters G.W.R. are smaller than the left hand illustration

HUMBER OR HILLMAN. Bulletin 239 Page 19 and 240 Page 10.

H4490.02 H/Ld is identified in Tomkins' as both Hillman Motor Co. Ltd., Coventry and Humber Ltd., London E.C. The range of stamps is recorded as Queen Victoria Jubilee issue to GV 1934 issue. DAVE HILL has sent the additional information from a book about the motor industry. It might throw some light on the date of use of the perfin by <u>either</u> Hillman or Humber.

"In 1929 Rootes took over the Humber and Hillman companies which were on adjoining sites in Coventry. Both had grown from cycle manufacture. In 1927 Humber, which was concentrating on larger models instead of its pre-war light cars, had swallowed Hillman which was making steady but unexciting medium range saloons. A cash crisis followed, and the Rootes Group stepped in. Rootes' 1930's progress was assisted by the success of the Hillman Minx which became a mainstay of Rootes at the time."

DISPLAYING PERFINS. Bulletin 242 Page 5.

Alan Sandy had asked for ideas on mounting and displaying perfins for exhibition. The following are replies to this request.

IAN BURNS from STIRLINGSHIRE describes his method thus:- "I used to try to draw each perfin by hand but I'm afraid that I am no penman. It was suggested to me that I might photograph each die and mount it beside the stamp. As I was interested in photography this I found very easy to accomplish. I use a sheet of postcard sized photographic bromide paper and I find I can get 15 definitive sized stamps on one sheet. They are held in place by a sheet of glass and the whole thing is exposed under the enlarger for about 15 seconds. The sheet is then developed in the normal way, dried, cut up and mounted in its proper place.

There are a few drawbacks to this method - if the stamps are of different density then sometimes the postmark or the watermark shows through qiite heavily so one has to be careful in selecting which stamps to put together. Using this method I can place the stamps face up or down so that the die will always come out the correct way round and not back to front as some publications show them - obviously photocopies done from the back of the stamp.

I have used this method for some 10 years now with a fair amount of success. 9 years ago I used part of my perfin collection as my display for President's Night at the Falkirk & District Philatelic Society. More recently, on 4 separate occasions, I have shown up to 36 sheets of Scottish perfins to various societies with many favourable comments forthcoming."

A different aspect of displaying is described by RON BROWN of SOUTHEND-ON-SEA. This is more concerned with competition entries.

"Page one must say, briefly, what you are showing and why stamps are called Perfins. Writing should be in bold print or clear writing. Centrally placed beneath this explanation could be a perfin face up in a black mount next to the same perfin face down in a similar mount. Underneath write which Perfin it is and a small amount of detail about the firm using the perfin, range of reigns, values, dies etc. If this is for a competition, keep all details to a minimum and to the point so judges do not get bored reading it all.

Pages 2 to ? can consist of different 'subjects' of perfins eg. Railways, Shipping. Place the perfins at equal positions on each page (say a maximum of eight) allowing room to describe each perfin. Remember you should show FACE & REVERSE to make things clear to the judges. Usually competitions are for 8 sheets or multiples of 8 but make sure of the rules as each society can differ. Your local library may have a copy of the book 'How to Display Stamps'. If I can win a competition - so can anyone and good luck."

In the past there were articles from members about their collecting interests. This article from DAVE HILL could fall into the category of displaying perfins too. He writes:-

"I always had an interest in Perfins during the last 10 years whilst building up a G.B. collection. I did not slavishly follow Gibbons, but told the story of British Stamps from 1840 to 1960 in my own way. I had got to the stage with my G.B. collection where I had nearly all the stamps I could afford and I joined the Perfin Society early in 1989. It has certainly revived my interest and I have more perfins than I can mount at present.

It ties in nicely with my G.B. interests as there are very few perfin users now - no floods of new issues!! I don't collect QEII and mount my identified stamps on a card index system - catalogue details and stamp on the front and I intend to write a history of the firm on the back. I mount my stamps over squares of black felt tip - horror - but I collect perfins not Hawid strips. This is my first experience of a specialist, as opposed to a general society, and I am delighted with the additional interest it gives me".

LOCAL PERFINS. Bulletin 243 Page 12.

MIKE OXLEY of Yarm, CLEVELAND, has made a very positive response to this idea. He has supplied me with a list of 13 new identities, or additional information to existing identities, of the North East: Newcastle, Middlesbro1, Hartlepool, Sunderland, Darlington etc. (I have passed these to Roy for inclusion in the April Bulletin.)

Mike has gleaned more information about these firms from his local knowledge of the area and from local directories.

He is willing to compile as complete a list as possible of the perfin users of the NORTH EAST. To do this, he would like the help of fellow members. If you know of perfin users from this area would you please send him the following information: name of firm, perfin, stamps perforated, date if known and all details printed on any covers in your collection.

It matters not if information is duplicated. Perhaps we have members with time on their hands who own an updated Tilles' or old Tomkins', who could go through the catalogue for all known users in the North East. Mike will then try to find out as much as he can about each firm. His address is:- 9 Manor Drive, Hilton, Yarm, Cleveland TS15 9LE.

Roy Gault, Michael Rucklidge and myself have had a brief discussion about how to present this information when completed. To include it in the Bulletin has little to recommend it. The general idea to date would be to issue a sheet of the same size and format as the present pages of the Tomkins' Catalogue. Two advantages would be that they could be stored with your Tomkins' pages, and secondly, additions to local areas can be inserted in the correct order.


Further ideas, comments, criticisms, offers of other lists will be greatly appreciated.

PEEK FREAN & CO.LTD.



Both have 2d orange stamps. T he 1920's receipt says Peek Frean & Co.Ltd. and the 1930's receipt says P.F.& Co. Ld., M.Ld., S.C.Ld. around three sides of the stamp. The latter letters standing for Peek Frean & Co. Ltd., Mettis Ltd., Suchard Chocolate, Ltd. An interesting spotlight on takeovers. Commercial Overprint members take note.

<u>"COX" PERFINS. PART 1.</u> by Peter E.J.Cox

My main interest over the past 12 years has been a study of the Penny Red with check letters "Q-H". That was until I discovered a 10d QV Jubilee stamp perforated with the name "COX". As my name is COX, I set myself the task of finding out as much as possible about the Cox perfins and the users of these perfins.

The name COX could represent Cox & Co., paymaster to the Army: Cox & Son, paymaster to the Royal Marines/Navy: Cox Brothers, Jute Manufacturers of Dundee. The fun began when I tried to sort them out. There are 5 listed 'COX' Perfins: 3 Horizontal (C5680.01, 5680.02, 5680.04), 1 Vertical (C5690), 1 Diagonal (C5680.03).



The horizontal dies and the vertical die belong to Cox & Co. who in 1758 began with an office in the house of Richard Cox in Albemarle Street, moving to Craig's Court, and later in 1886 to 16 Charing Cross. Finally, before merging with Lloyds' Bank in April 1922, they spent seven months 'married' to H.S. King forming "COX & KING". This was the Cox of the Army connection. Cox & Co's only other branch, outside London, was at RAWALPINDI, India. This branch looked after the banking interests of the serving officers of the English Army in the time of the "JEWEL IN THE CROWN".

I am still following up the history of Cox & Son. It seems strange that two banks with the same surname, both in London, both paymaster to branches of the armed forces, were not connected. Even Lloyds' Bank is pressing me to let them know if I discover anything new about Cox & Son.

I then considered the Diagonal perfin, all copies of which seem to have Dundee Postmarks. It certainly does not belong to Cox & Co. the bankers. My detective work lead me to believe the Perfin belongs to COX BROTHERS of Dundee, who were a large employer of labour. A study of their archives shows no contact with SLOPERS, but there were copies of letters from past employees who became serving officers in the army in 1914-18. They were letters to Cox & Co. the bankers, via Cox Brothers, their former employer. Perhaps it was easier to enclose letters to their bank in the mail to their family still working at Cox Brothers.

Now may I ask for help? Does anyone own a cover with a Diagonal COX Perfin which will yield a vital clue as to the true owner of this perfin? Can anyone inform me of the date when Slopers began to offer their DIES to clients as well as offering to perfin stamps? When, and if, I have more information, I will pen a Part 2 to "COX" PERFINS.

OWNERSHIP AND HISTORY OF COX A Co.BANK.

- 1758 Started by RICHARD COX in his home in Albermarle Street.
- 1765 Richard Cox moved his Bank to CRAIG'S COURT.
- 1766 COX-DRUMMOND. Richard Cox and his friend HENRY DRUMMOND.
- 1768 Firm began its connection with Royalty. (H.R.H.Duke of Gloucester).
- 1771 CHARLES GREENWOOD, cousin of Richard Cox entered the firm as clerk.
- 1771 ARTHUR MAIR taken into partnership in place of Henry Drummond.
- 1772 COX & MAIR.
- 1779 RICHARD BETHEL COX, only son of Richard Cox, taken into partnership.
- 1779-1783 COX,MAIR and COX (until Mair died).
- 1783 Richard Cox and his son, upon the death of Mair, took CHARLES GREENWOOD into partnership.
- 1795 RICHARD HENRY COX, grandson of Founder, entered the business.
- 1800-1803 COX, GREENWOOD & COX. (Richard H.Cox became a partner).
- 1803 GREENWOOD & COX (C.Greenwood & R.H.Cox) upon the death of the Founder, Richard Cox.
- 1807 CHARLES HAMMESLEY, nephew of Charles Greenwood brought into partnership

1808-1813 GREENWOOD COX & COMPANY.

1823 HENRY RICHARD COX joined the Company.

1828 HENRY RICHARD COX appointed a partner.

1823 Charles Greenwood died.

1834-1923 COX & COMPANY.Richard Henry Cox.

Henry Richard Cox.

Charles Hammersley.

Frederick William Cox.

Various changes of partners but still known as COX & COMPANY until being taken over by Lloyds' Bank in 1923, but the name of COX & KING lives on in the History of Banking and the Army to the present day.

LEEWARD ISLANDS.

Some observations on the M.C./A. and M.C./B. perfins. Andrew Hall.

A small quantity of these perfins came into my stock recently:-1d postage stamps of Queen Victoria and King Edward VII Fees stamps. None has any cancel, so it looks as though all were used fiscally - the 1d to make up odd amounts below the 6d; the lowest value of the Fees issue.

A further interesting point is that the perfin seems to have been from a single die-pairs almost always have different alignments on both stamps, and apart from the example shown, I have not seen any with a double impression on the large format Fees stamps.

For the record, M.C./A. are about twice as plentiful as M.C./B. On the large format stamps, M.C./A. seems to occur upright and sideways in roughly equal quantities; but all the M.C./B. on this type I have seen are inverted. I'd be interested in further observations, (Illustrations on next page.)


PERFINS ON 2d BLUES.

He has not seen this perfin before and thinks it may be the one which Jennings lists for 1d Plates 166, 181 and 182 but no other values.
