EDITORIAL

A small nucleus of members provide research, knowledge and participation in the activities of the group. Whatever your level of collecting, I have found from personal experience, that contributing in any way can increase one's enjoyment in a hobby. I hope all members will read the reports, and if possible, respond to the various pleas, ideas or suggestions therein.

SOCIETY INFORMATION

A.G.M. - LONDON.

The A.G.M. took place, as usual, at Baden Powell House on November 10th. A record 18 members were present. The reports are as follows:-

Secretary's Report.

The Society continues to flourish. Membership at 31 August 1990 was 262. In the past twelve months 32 members have joined: three members died, one resigned and 14 lapsed, giving an increase of 14.

The usual London meetings were held in November and May. Provincial meetings were held at Morley in August and at Birmingham in September. It is hoped that these will continue since it will enable members who, geographically, find it difficult to get to London to meet other enthusiasts.

Special mention must be made of Stephen Steere's efforts. He is a comparatively new member and obviously very keen. His approaches to Sloper's have resulted in two visits by five members each time. They were quite enthralling and it was surprising that only six members applied to go on the second one

the first was selfishly confined to officials). A third visit is scheduled for early 1991. Stephen has also discovered some very interesting material in the Post Office archives. This will ultimately form interesting chapters in the history of our hobby. The first, of course, was published in bulletin 245.

Production of the Edwards catalogue has now resumed after an unfortunate gap. Thanks to Roy Gault's efforts only two letters (P & S) remain to despatch. The 6th edition of the Tomkins Identities catalogue also nears its completion. Both catalogues will be completed early in 1991.

Finally on behalf of all our members a big "thank you" to the officers and others who work tirelessly to keep the Society running.

Treasurer's Report.

As you will see from the accounts we have had another reasonably successful year. Some points may require a little explanation.

1. The auction, entirely thanks to Harry Skinner, provides the biggest single item on the income side. Since the receipts and payments do not coincide with our financial year the net figure shown is misleading to some extent: this year it is high - next year it will probably be low.
2. No monies have been received from the Publications Officer, so this item will probably be bigger.
3. Donations are almost entirely due to lapsed member's credits over the years. More correctly they should count as subs.
4. Bulletin expenses are higher due to
 - a) increased number of auctions
 - b) increased Tomkins pages
 - c) some 300 spare Tomkins pages are ordered each time to cope with demand until a new edition is printed
 - d) increased postage costs.
5. Officers' expenses include postage, printing of publicity material etc.
6. The Society has bought a photocopier (for publications) and a typewriter (for Bulletin). These are one-off items and

Auditor's Report

I have examined the above Income & Expenditure Account and Balance Sheet for the year ended 31 August 1990, together with the books and records produced to me and in my view the above accounts are in accordance therewith.

strictly only the depreciation should be included, but I prefer to write off the cost at once.

7. The Edwards Catalogue shows a loss: this is because I order some 40 extra copies which will meet the demand until a new edition is completed. I expect these to realise at least £1000.

The printer we have been using for printing the Bulletin has gone out of business. The cheapest replacement we have so far found will result in extra cost of some £350 a year. In spite of this we are keeping the subscriptions as before.

This year we have, for the first time, had our accounts audited. The officers agree with me that in view of the increasing sum involved this was desirable.

Finally may I thank those members who have paid their subscriptions for 1990/91 and remind those who have not that these became due on 1st September. In the interests of economy I do not acknowledge receipt except by the inclusion of a receipt/membership card with the next Bulletin. So if you have not received one you probably owe. We give four months' grace but if I do not receive subscriptions by 31st December I must reluctantly lapse you. I will be sorry to do this but it is not fair to members who have paid to expect them to subsidise those who have not.

Catalogue Editor's Report.

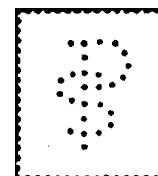
Except for the letters P and S this year has seen the completion of the Edwards Illustrated Catalogue. These last two parts will be ready early in 1991. Update pages have been provided for 8 of the letters of the alphabet, based on new dies provided by members.

New dies are obviously important, but so is the deletion of false dies. After very careful scrutiny, many dies have been found to be missing pin varieties or partials of other dies etc. and these are being weeded out. Slowly the catalogue is becoming a more accurate record of perfin dies.

The Tomkins Catalogue is almost up-to-date with the Edwards Catalogue. The 'L' pages are going out with the Dec.

Bulletin and the 'M' pages will be in the Feb' issue. This leaves just the P and S identities. Once the catalogues are complete, it is envisaged that update pages of each letter for both catalogues will continue to be published each year, until the time is deemed to be right to publish a new edition of the Edwards Illustrated Catalogue which will include all new dies reported since the printing of the original Edwards Catalogue.

Auctioneer's Report.

There have been 8 auctions in the financial year with some 2,474 lots. Because of the closing dates of the auctions, monies from the last two auctions will be shown in next year's accounts. This is balanced by money coming in from the last auctions of the 1988-89 year. The profits for the current year to Society funds is £1806.

Lots and bids from overseas members are more numerous than from U.K.members. Less than a quarter of all members send bids into the auction. A very large collection has come in for breaking down and so 1991 will again see a good scope of material. However, lots are always needed, so keep sending in your unwanted items.

Exchange Packet Secretary's Report.

Although there is not much profit to the Society from the Exchange Packet, it does provide a valuable and much appreciated service to the participating members. Much more material is needed for the packets and although it takes more time to mount up and price loose stamps, the returns can be more than from the auction. Prompt payment to the vendors can be a small problem because of the time taken for circulation of the packet. This latter problem is being monitored to see if a solution can be found.

Librarian/Publication Officer's Report.

After a very unsettled period, the majority of the library material is now in order. It is expected that a full updated Library Abstracts will be completed before long. It has not yet been decided how this will be conveyed to members.

In each Bulletin, starting with this issue, there will

be a "Catalogue Corner" article which will give some information to members about specific catalogues which can be borrowed from the Library. If any member wishes to borrow a book or have a photocopy of any article on a particular subject, please write to the Librarian. State as precisely as possible the subject of your interest and the Librarian will send you the relevant book or photocopy; invoicing you for P.S P. and photocopying costs. Time limit to keep books is usually about a month. Unfortunately books cannot be sent on loan to overseas members.

Bulletin Editor's Report.

The most significant improvement in the Bulletin has been the gain in legibility due to the purchase of an Olivetti Electric Typewriter.

Many thanks are due to Keith Moore, who over many years, has seen to the printing, collating and stapling of the Bulletin and Auction lists. The printer used by Keith has ceased trading but Keith is continuing to provide all the name and address labels and membership lists. Thanks also to John Luft for filling all 262 envelopes with the various bits and pieces, sticking on the labels and then weighing for the correct postage. John apologises for the lateness of the Oct' Bulletin: he was very ill for two weeks at the time when the Bulletin was usually posted.

The most important part of the Bulletin is the content. I have been grateful for all the bits and pieces sent in for possible articles. However, not enough material of genuine perfin information has been available to fill 16 pages. Some articles devoted to 'non-philatelic' or 'perforated' items have been included in the Bulletin. I am aware that this is not to the liking of those who consider a 'Perfin' as being a stamp which was perforated with the object of making it difficult to steal or redeem. The Perfin Society was originally formed to study just these stamps. I would like to canvass members' views about continuing printing items other than those about Perfins.

The members present at the A.G.M. were happy for these articles to be included in the Bulletin if not enough 'true perfin' material was available: and it was made clear that the information was about 'Perforations' rather than 'Perfins'.

Other Items on the Agenda:-

3. Ron Bowman Memorial Prize.

This is awarded annually to the person who has contributed the most noteworthy article to the Bulletin. This year the efforts of Stephen Steere in unearthing some new and important material from the Post Office Archives (Bulletin 245) have been rewarded by the presentation to him of the Ron Bowman Memorial Prize. This consists of a certificate and a voucher for £10 to spend in the auction.

6. Slopers Wartime Provisionals.

Roy Gault presented a paper to the members about his difficulty with the Sloper Wartime Provisional Perfins. Some of these provisional dies are readily identified with, and from, the original. Others are not so easily recognised as Provisionals or even as the original die. A further difficulty is how many, if any, of these Provisionals to put in the Illustrated Cat. Roy will be submitting this paper for a future Bulletin and asking for help with research on this subject.

7. Index for the Bulletin.

Both Dave Hill and Michael Rucklidge have produced, for their own convenience, an index of material found in most of the Bulletins. Both gentlemen kindly gave me a copy of their lists. I had, in the past, wasted valuable time looking for an article which I knew had been printed in the Bulletin. This led me to think that such a complete index could be a valuable resource for other members.

It was generally agreed at the A.G.M. that I produce a complete index from issue 1; the index will be divided into 3 sections:-
a) General Articles: b) Individual Perfin Dies: c) Foreign Perfins; each section to be in alphabetical order; the index will be sent to all members free of charge. It will not be part of the Bulletin, but probably printed as a small booklet.

10. Display. As you can imagine, after discussion of all the afore mentioned items, there was no time for a display.

SUBSCRIPTIONS. J.M. Rucklidge.

As stated elsewhere if you have not paid your subs by 31 Dec this will be the last bulletin you will receive. How do you know if you have paid or not? If you have not paid there is a red dot on the address label of this bulletin and a reminder of how much is owed.

Remittance from overseas.

I would like to remind overseas members that sending money to me by cheque is a very expensive method. Not only does the foreign bank charge you for this, but there is also a high charge in this country. As an example, I recently received a cheque for £37, which had cost the member the equivalent of £51-50p: the amount received by me was £27-76p, a charge of £9-24p being made by the bank in this country.

A much cheaper method is to buy sterling notes and send these. The cost would be about £2 for the member. The total cost in the above example for 4 x £10 notes would have been £42 with a credit of £40, instead of £51-50 with a credit of £27-76.

If you do not like the idea of sending currency notes through the post, by all means send a cheque, but be prepared to get credited with much less than you appear to send.

ILLUSTRATED CATALOGUE. J.M. Rucklidge.

The task of arranging the printing of the Illustrated Catalogue, collating the sheets, addressing envelopes and despatch has fallen to me. This will have involved collating some 85,000 sheets, addressing some 2,300 envelopes and preparing some 2,300 stiffeners. As you will realise this has taken an appreciable part of my spare time and, frankly, I would like a rest. So I am asking for a volunteer to take this task over. Until such time as we start on a completely new edition this will involve up-date pages as and when sufficient new dies are discovered to fill, or nearly fill, a complete page (49 dies). The volunteer must have

- 1) enthusiasm (obviously)
- 2) spare time
- 3) access to a printer who will produce 170 (or so) copies at not more than 4p per page.

So if you think you fulfill these requirements please contact me. I shall complete the remaining two letters (P & S) which should be done early in the New Year.

Why not buy an Illustrated Catalogue? Rosemary Smith.

I believe about 120 copies of the Edwards Catalogue have been sold and the buyers have contracted to receive the new letters as they are printed. As has been reported elsewhere, there are still about 40 spare copies for sale. The total cost for all letters (less P & S) plus Numbers S Designs is £37-60 or £40-60 surface rate abroad - both inclusive of P & P. If you are not one of the 120 lucky owners of the Edwards Cat., I urge you to consider asking your family to club together this Christmas and buy one for you.

CATALOGUE CORNER 1. Geoff Longbottom.

From a historic viewpoint, perfin collectors tend to expect their stamps only to be recorded in specialist catalogues. It is good, therefore, to see their mention in a wider range of catalogues - the recent inclusion in Gibbons Stamp Catalogue, Part 1 of all Australian OS perfins and the inclusion of the German POL perfins in the Michel catalogues are particular examples.

This thought was brought to mind by the recent publication of the 3rd edition of the WASHINGTON BICENTENNIAL CATALOGUE which will be of particular interest to members who collect American precancelled perfins. The first new edition in 50 years - it provides 40,000 entries listing every known precancel on the 12 denomination, 1932 stamp series. All perfins known to exist on these Bicentennial issues are tabulated in the footnotes on each page. Where known, the user's name is given.

A copy of the catalogue, which costs about £8-50p, will be in the Library by January. By that time copies of the new catalogues for Bavaria, India, and British Malaya should also be available.

IBHL Perfin. Bulletin 248 Pg 6

From an ex-bank manager friend, who is a member of the Banking Thematic Study Group, DAVID LANE elicited from him the guess that the initials stand for INTERNATIONAL BANK OF HAMBURG AND LONDON which functioned from 1870 to 1884. Tomkins catalogue notes that the perfin is on Jubilee stamps which were issued a little later than 1884. Is this perfin on earlier issues? Please report. I have this perfin on many Foreign Bill stamps dated between 1884 and 1889.

Visit to Slopers. Bulletin 248 Pg 11

JOHN NELSON reports that Clark & Fenn Ltd. - who appear to have or had the perfin 235 - are a very reputable firm of plasterers and decorators, 681 Mitcham Road, Croydon, Surrey.

C/OF/A Perfin. Bulletin 248 Pg 8-9

JOHN NELSON has a cover postmarked Deal, Kent - 17th July 1970 bearing a Q.EII 5d dark blue with the C/OF/A perfin sideways on the stamp. It contained a letter from Sir Robert Menzies who served as Prime Minister of Australia until 1966 and was, in 1970, Warden of the Cinque Ports based on Walmer Castle, near Deal. A very interesting addition as the date is so much later than the period mentioned in Mr. Swanston's article or "G.B. Official Perfins", which took the use up to 1968.

False Perfins. Bulletin 248 Pg 4

JOHN NELSON has several examples of these numbers, all of which are sideways on the stamps. These are all on KGVII values up to 2½d. The numbers are 1 (without the extra hole), 3, 4, 5, 11 & 12 (there are two of these but one has an additional pin in the top right hand corner). John also has two of the number 4 on piece

with clear postmarks and they are NOT perforated through the piece as well.

CT/StR Perfin. Bulletin 247 Pg 4

HARRY SKINNER has this perfin on a 1d lilac and EVII ½d & 1d and rates it difficult to find. ROY EVERETT suggests Charles Tennant & Co. Ltd., plastics, in Bath St., Glasgow G2. (Plastics at the turn of the century? Ed.) Tennents the Brewers are in the same street. FRANK BROWN says that there is a district of Glasgow called St. Rollox - Postal District C4 or G4. Can any Glasgow member track this down now we have an approximate date?

J.H./FULLER. Bulletin 247 Pg 4

In 1983 John Luft had made some enquiries about this perfin. TED FRANCOMBE sent him the following information.

The 1911 "Smith's" Directory of Reading gives:- "Fuller, John H S Co. Ltd. Wholesale grocers, colour grinders, varnish and enamel manufacturers, cutlers and hardware merchants. 52 Minster Street, Reading." The 1942 "Kelly's" Directory has an advert:- "J. H. Fuller & Son, Builders & Decorators etc. Estimates given for General Repairs. 60 Gosbook Road, Caversham, Reading. As John Luft's perfin was postmarked with the 635 post office number for Reading, it would point to this being the firm in question.

NEWS OF A PERFIN MACHINE. G/N/C Perforator.

STEPHEN STEERE has found out that a lady by the name of Barbara Priddy has rescued the Stamp Perforator of the GENERAL NURSING COUNCIL (G/N/C - N3630.01) She had worked for the General Nursing Council and when they were disbanded in 1982, and were going to discard the Perforator, she asked to keep it as a memento of her years with the Council.

There is a good chance that in the future this will be donated to the Perfin Society. There is no name of manufacturer on the machine, just its number - A154.
