PRESENT EDWARDS & TOMKINS CATALOGUES.

Now the 'S' pages of the Edwards Illustrated Catalogue are going to the post, this completes the individual letters. Roy Gault (and his band of collators) deserves congratulations for speedily completing this mammoth task and producing such an excellent work of reference.

Roy is now busy preparing up-date pages which will contain all the new dies reported by members who have copies of the Edwards Catalogue and obviously have used it as a useful point of reference.

With this Bulletin comes the 'M' pages of the Tomkins Catalogue, with 'P' and maybe 'S' pages with the April issue. A number of members have noticed some discrepancies when cross checking numbers from Tilles to Edwards; or identities missed from Tomkins; or incorrect spelling/addresses in Tomkins.

Roy will be only too pleased to hear about any mistakes in these catalogues. Once a fact is in print, it will remain until someone notices the error. He has deleted many inaccuracies from the old Tomkins, Tilles and Van Lint catalogues, but many eyes are better than one. (Cyclops!)

CATALOGUE CORNER 2. Geoff Longbottom

Collectors of U.K. perfins often think the complexities of their collections are substantial. They can, however, seem relatively modest when compared to the problems of collecting perfins from some other countries.

Through the good auspices of Brian Birch, a former Librarian of the Perfin Society, I recently received a hard bound copy of the fourth, 1987 edition of KATALOG PERFINU Z UZEMI CESKOSLOVENSKA (purists please forgive the omission of appropriate accents). Literally translated it means PERFINS FROM THE TERRITORY OF CZECHOSLOVAKIA and, happily, the main editor, the late Vojtech Maxa, produced an English translation of the preface in 1988 which makes this catalogue easily usable by English language only speaking and reading collectors.

A superb example of the perfin cataloguers art, it contains detailed information, arranged in alphabetical order, on 1029 perfin patterns used by organisations operating in the current Czechoslovakian territory between 1877, when perfins were first introduced, until about 1950 when, effectively, they were discontinued. Many multiple die patterns are shown in a special section, as are the perfins used by private collectors and stamp clubs.

At this point, the complexities start to arise. These perfins can be found on the stamps of Austria, Hungary, Poland, Germany, Bohemia S Moravia and Slovakia as well as Czechoslovakia. Additionally, identifying users is not aided by the fact that during the Austro-Hungarian rule and in pre-war Czechoslovakia, stamp cancellation on printed papers and newspapers sent by mail were applied by the receiving office rather than the despatching office.

Along-side each pattern illustration (all patterns were accurately re-drawn for this edition), there is a catalogue number, a note of the perfin users Post Office and a scarcity rating for each pattern. Substantial additional detail is also given including, where known, the users name (614 positively identified, 242 indirectly identified and only 170 still unidentified), the period of usage, and indications of coil stamp, postal stationery and damaged perforator usage.

MULTI-DIE PERFIN MACHINES. J. M. Rucklidge.

With multiples in the form of strips or blocks it is usually possible to assess the number of dies in the machine. This, I feel, is of interest and is worth recording. I suggest that this could be recorded as numerals - 1 indicating a single die machine, and m x n indicating a machine with n rows of m dies each. For example PAC would be "12x1" (though this was modified to 10x1 for decimal issues) and NC would be "3x2".

It is not obvious where this information could be placed. There is hardly room in the Tomkins catalogue. In the present Edwards catalogue the only feasible position is in the bottom of the illustration rectangle. If the two catalogues were combined with "identities" (only) on the reverse it could be placed immediately below the lettering. Members' views would be welcome.

WHICH PERFINS SHOULD NOT BE CATALOGUED IN EDWARDS? Chris Carr.

There are two opposing sides to this problem. The Secretary thinks that the catalogue should not list those 'perfins' which are strictly cancelling devices e.g. the numbers as mentioned in Bulletin 248 and presumably such perfins as C.0257.01, C.0260.01 etc. My own opinion is that all known perfins should be catalogued whether they are true perfins, cancelling devices or even private perfins used by members for their own mail. The reason I say this is so that everything is recorded, it is then up to members to decide what they will collect. To limit the recording of material now could create problems for future collectors. What do you think? Please write to the Bulletin editor!

THE BULLETIN EDITORS' THOUGHTS.

I too think that there should be some recording of <u>ALL</u> perfin devices. However, I do not think they should be incorporated into the Edwards Catalogue which should be kept as the definitive work of postage stamps perforated for security purposes.

Now we have a number of Slopers' old die books, given to us by Mr. Cokayne, a director at Slopers, there is enough material in these to publish a separate catalogue showing all the 'cancelling' dies other than true perfins.

It would be a large project for the future, but we do have a great deal of information to hand for such a publication.

<u>CDP Link with Charles D. Phillips</u> details from Ron Brown.

On one of my searches for perfins, or perfin related items, I came across a bank draft, with date 7-9-04 perforated through the draft. On closer examination I noticed the EVII 1d stamp used as an encashment receipt had the perfin CDP (C.2130.01 in Edwards) which is identified in Tomkins for Charles D. Phillips. So what! you may say; but the interesting point for the perfin collector was that the draft was made out to Charles D. Phillips and the CDP perfin was cancelled by the signature "Charles D. Phillips".

The draft came from the <u>FISHGUARD & ROSSLARE RAILWAY &</u> <u>HARBOURS COMPANY</u> whose bank was Messrs Glyn Mills, Currie & Co. The bank which remitted the cash was Metropolitan Bank of Newport, Mon.

A second draft was in the vendors box, dated 21st Sept 1904. This too was from the Fishguard & Rosslare Railways & Harbours Company and made out to a James Ottway. This 1d EVII stamp used as the encashment receipt had the perfin GS/WR (Die 3) (W.4870.03 in Edwards). This draft was remitted by the Bank of Ireland at Waterford.

To say I was surprised when I came to study these two items would be an understatement, but this find typifies the fascination of our hobby. It pays to examine every perfinitem very carefully.

(In Ron Bowman's book "Railway Perfins of Great Britain", it says, "The new harbour and station at Rosslare opened in 1906 to accommodate the Fishguard to Rosslare route to Ireland which began operations on August 30th of that year".

The Fishguard & Rosslare Railways & Harbour Company became part of the Great Southern and Western Railway, but I have no date to hand of this incorporation. Ed. - M.R.S.)

<u>An Impression Of My Visit To Slopers Works</u> by Dave Hill.

A small Victorian, even Dickensian, works in a not very salubrious part of N.W. London behind West Hampstead tube station. Having said that, I have to agree with Mr. Cokayne that had they not kept down the cost of what they produce and spent more money on the works they would not have survived over a hundred years.

One or perhaps two women perforate stamps, 3-5 days per week as required using single or 12 headed dies. This is the significance of the 1 or 12 in the record book of dies which is kept by Slopers although they perforate 10 stamps at a pass. These machines are more complex than the dies you see in machines sold to companies to perforate their own stamps. This is because the ones at Slopers have to be changed frequently from one perfin to another. Once there were 12 or more women perforating stamps each day in the years between the wars at New Bridge Street, London EC1.

Perhaps a die wears and they make a new one but its just an engineering job as long as it perforates the stamps all right. Although they use templates the new die will not necessarily be identical to the old one. Indeed, they might get a small order from a new client and have a similar die which they will simply modify in case they get no more orders; perhaps taking the pins from the leg of an 'R' to make a 'P' which would not be as the 'P' template. As a die wore they put in progressively larger pins. This is not to say they have not made machines with different heads.

Each job was looked at primarily from the engineering standpoint. I very much doubt that they ever consciously made different dies for different branches of the same company unless they were asked. If they were asked, the differences would be major ones, not secret marks as is sometimes thought.

Other machines are made to do with security endorsing, i.e. dating or numbering, which require constant changing and these are very neat but again cost is the prime factor. However clever a machine might be, if it is too dear it will not sell.

These machines would work on a slightly different principle to the perfin machine. If I understood correctly, they have in effect pins which retract into holes which somehow prevent the pins perforating. The perfin machine I think always has pins in the shape of the letters and the corresponding holes.

Mr. Cokayne is primarily an Engineer, and prototype and other light engineering work is carried out by the firm.

After my questioning 'plastic at the turn of the century', MIKE BAVIN gives the following data -"The oldest plastic is <u>Celluloid</u> (1869); <u>Casein plastic</u> (1897); <u>Bakelite</u> (1909) although the basic chemistry was known in 1872". I am thoroughly squashed! !

London and Morley Meetings. Bulletin 249 Pg 2



IBHL Perfin Bulletin 249 Pg 13

Whilst Checking through a letter of MAGNUS WERNER from Sweden he has made me aware that the article in Bulletin 248 Pg 6 was misleading. Tilles only shows one die for IBHL Cat.No.13 (not I.1300 as stated) with details 6,16,13,8 7¹/₂mm high. Edwards has a second illustration for this perfin (I.0130.02) which has the same number of holes in each letter, but the letters are ¹/₂mm smaller with the I&B and HSL not being quite so close together. All perfins mentioned by myself and others appear to be of I.0130.02 and I would be very interested to hear of any I.0130.01 or I.0140.01 (I.B.H.L.) perfins on or off cover.

Magnus Werner has I.0130.02 on the following:-

Magnus says there are many die varieties which suggest that a multiple die perforator was used. He has also found several constant missing pin varieties.

Since editing the 249 Bulletin, I have ascertained, from the Banks' Almanac, that the Bank of Hamburg was incorporated into the International Bank of London in 1872 but was withdrawn in Jan 1880. The dates mentioned by Magnus do not show use during these eight years. Please check your holdings of these three perfins.

Western Mail and South Wales News, Cardiff. by Dr.R.W.Powell.

My collecting of Perfins and of G.B. Squared Circle Cancellations have merged with the above item.

The standard book, "COLLECTING BRITISH SQUARED CIRCLE POSTMARKS" by Stanley F. Cohen, Maurice Barette and Daniel G. Rosenblatt, published in 1987, was followed in October 1990 by Supplement No. 1. Here for the first time the Squared Circles of Cardiff are treated. Three blocks of six KGVI 1d stamps are shown that also have Tilles W.516.2 (Edwards 5160.02) WM Perfin 13,13 holes 7¹/₂mm high. The caption "The Squared underneath reads, last Circle in Great CARDIFF 11d-5, used as a precancel for "Western Mail and Britain: South Wales News", FE 10 33, JU 4 37 and OC 22 37".

I went straight to my perfin collection and found the same stamp in block of four with Perfin and Squared Circle, but with date of NO 25 37: which is 34 days later than the latest shown in this Supplement. What can be found in other Perfin collections? Write if you can beat this date for a Squared Circle pmk on the WM Perfin.

<u>MEMBERS' QUERIES</u>.

<u>"The Joseph Rowntree Village Trust"</u> from Dr. Reg Powell.

We are often faced with the problem of finding the user of a perfin, but I wish to bring to your notice the reverse problem of finding the perfin for a known user.

My son-in-law, who is fifty-two, saw the stamps perfined JRVT in use in his York home from about 1940 to 1950. This perfin belonged to the Joseph Rowntree Village Trust, of which his father was the Secretary. It was in the village of New Earswick that the York firm of Rowntree had built houses for renting to some of their employees.

Hence these perfined stamps are likely to be found on letters and receipts stored in the New Earswick-York area. This is where a search should be made, and hopefully you may bring this perfin into our catalogue, and add another to your collection.

Have you any multiples of C.0270? Four variations are listed in Tomkins, these plus two more are listed in Edwards and now a further three have been found.


Please examine your collection and let me know if you have any pairs or blocks which could add to our knowledge of these dies. Photocopies or contact prints will be most welcome.

THE NEW ZEALAND "THANK YOU" PERFIN. Rosemary Smith.

This article is taken from the October 1990 Issue of "Captain Coqk" (correct spelling!) the Newsletter of the Christchurch (NZ) Philatelic Society (Inc.). The Perfin Society has a reciprocal exchange of Bulletin with the above society.

For 1988/89, 100 sheets of the 1c Nephrite stamp were sent to Slopers. It was requested that 90 of these sheets be perforated normally so that the words read correctly when viewed from the <u>front</u> of the stamp; the other 10 sheets were to have the perfin reversed so that the words read normally when read from the <u>back</u> of the stamp. It was thought that some collectors may like to purchase blocks of both varieties, mounting one block face up and the other face down in their collections. The idea was good enough, but its implementation caused some problems.

The sheets of stamps obtained from the Post Office came from two different printings. Most of the sheets were from the fourth printing, on white paper (CP PBlb) with the "four dot" plate number (listed by Campbell Peterson as 11114). The rest of the supply was from the fifth printing, on cream paper (CP PBlc) with the "five kiwi" plate number.

The stamps were received back in New Zealand on Feb 8 1989 and a small quantity of first day covers was prepared on that date.

Slopers had difficulty in perforating the stamps - perhaps the instructions had been hard to follow and, besides the two solicited variations ("normal" and "reversed" perfin) there are a of abnormal variations: including inverted. inverted number and double perfins, perfins. and missing The reversed perfins. following is a check-list of known varieties.

Normal perfin Plate blocks: Four dot plate number and Five kiwi plate number. Double perfin: Triple perfin: Inverted perfin. Inverted perfin in pair with normal perfin. Double inverted perfin.

Reversed perfin.


Plate blocks: Four dot plate number and Five kiwi plate number.Double perfin: Inverted and reversed perfin.Inverted and reversed perfin in pair with "normal" inverted.Double perfin: one impression inverted, the other inverted and reversed.

All of the unsolicited varieties were sold by auction, some of these still appearing in the Philatelic Foundation's various sales. The 1c "Thank You" stamp was sold by Federation at its' stand at New Zealand 1990 and considerable numbers would have been used in the Exhibition "passport".

If the 1988/89 perfin had been something of a collector's dream, the 1989/90 2c perfin was very "ho-hum" in comparison. Again 100 sheets of stamps - this time the 2c Agate - were sent to Slopers. These were all perforated normally, i.e. so that the words read correctly when viewed from the front of the stamp. All stamps came from the same printing - the first printing, on white paper (CP PB2b) with the "one dot" plate number (listed by Campbell Paterson as 11111).

The stamps were received back in New Zealand on 20 April 1990 and, again, a small quantity of first day covers was prepared.

PERFINS ON THE GRAPHITE LINED ISSUES OF G.B. Bob Schwerdt & Roy Gault

One would think that thirty years would be sufficient time for most British graphite perfins to have been discovered and reported, but occasionally new types still come to light.

The graphite lines were applied as an experiment in 1957 and again in 1959 to expedite the sorting of mail electronically, and are found on two types of watermarked paper, namely St. Edward's Crown and Multiple Crowns. This method of detection, however, was not a success, so in November 1959 the remaining stocks of Graphite lined stamps were overprinted with bands of Phosphorescent ink. A table showing the issues involved appears at the end of the article.

The following list represents the current status of the 33 known dies on this small but interesting group of perfins. Collectors are encouraged to report any new dies or values not on the list, as well as fill in some of the gaps and confirm the queries. Please keep a special lookout for signs of the stamps having come from coils, or possibly carrying phosphor bands.

MAW & COMPANY - ENCAUSTIC TILE MAKERS.

An encaustic tile is one in which inlaid coloured designs have been fused directly into the product by heat. The normal method of production is to use coloured slips to fill impressions pressed into the clay. After drying and glazing, these are then fired in conventional pottery kilns.



The firm of MAW & Co. was founded in 1850 when two brothers, George and Arthur Maw, purchased the ailing Worcester Porcelain Company. Within two years the company had moved to Benthall, near Broseley in Shropshire, the source of the high quality clays used in this particular type of tile making. Here the company flourished, producing a rich variety of floor and glazed wall tiles. This was the age when it was fashionable to cover the fronts of public buildings, porches, fireplaces and even shop counters with colourfully decorated, glazed wall tiles.


The site at Benthall proved to be too small, and severely restricted any plans for expansion. To remedy this a new factory was built at nearby Jackfield. Completed in 1883, the 'New Benthall Works' became the largest decorative tile factory in the world. Sadly, the hey-day was short lived as by the early 1900's changes in taste heralded a general decline in the industry. This was further exacerbated by the economic difficulties of the 1920's and 30's. Although the firm was to soldier on for another thirty years, it never regained its former glory. Tile production ceased at Jackfield in 1969 when the company was absorbed into the combine of H & R Johnson-Richard Tiles.

The company is known to have used stamps perforated with the full name MAW (contrary to Post Office regulations) from the very early days.

This is entirely consistent with the known history of the Company, the precise change-over taking place during 1883.

Recently, another perfin has come to light with the full name MAW appearing either upright or sideways on the stamp. Three examples have so far been examined, two of which bear Jackfield postmarks, one with the date 24 JULY 1918. The issues involved run directly on from those of the previous die.

<u>'FESTIVAL OF STAMPS' PERFINS</u>. By Rosemary Smith.

In Bulletin 164/1976 and 171/1977 Gordan Clinch provided some information about the stamps which were perfined for some of the Festival of Stamps Exhibitions. In 1990 I came across a cover produced for the 1978 Festival of Stamps which had not been recorded as either a New Identity or a New Die.

This may be a good opportunity to pull together all facts known about these stamps. My information comes from Gordan Clinch's earlier articles in the Bulletin, from my own copies of these items, and from a letter from the "Stamp Publicity Board".

The covers and stamps in question were produced by the "STAMP COLLECTING PROMOTION COUNCIL" for sale at the Festival of Stamps in 1975, "76, "77 and '78. The S.C.P.C. (now the Stamp Publicity Board) is a non-profit making organisation which exists to demonstrate to non-collectors how their interests can be enhanced stamp collecting and to encourage and advise collectors, bv schools and other organisations on the expansion of interests and aspect of the exhibition is of stamps. The whole use to demonstrate how, irrespective of the interests of individuals. stamp collecting is a hobby with universal appeal.

The S.C.P.C. established May 6th as NATIONAL STAMP DAY in honour of the issuance of the first adhesive postage stamp, the Great Britain 1d black. The Festival of Stamps was always scheduled to include the 6th May in its days of opening. The special covers produced for the National Stamp Day, May 6th, were the only ones with the perfined stamps.


<u>The Festival of Stamps 1975</u> was held at the Royal Festival Hall, London SEI. The special cover for the National Stamp Day showed the Houses of Parliament and was inscribed "Britain's Heritage". The insert card states:- "Cover illustration: Big Ben, the great 13¹/₂ ton bell of the Houses of Parliament clock tower, cast in 1858. The 'chimes' were first broadcast in 1923". The stamps used on the envelope were the se-tenant pair of 7p Architectural Heritage stamps of 23rd April 1975 (S.G.975/976). The stamps were perfined NSD/1975 (N.2955.01) and could be purchased at the Exhibition in two forms: in strips of 10 maximum (i.e.5 pairs) or as blocks of four. The panes of four were included in special souvenir booklets with the stitching, either in white or black, through the selvedge edge of the stamps. Slopers produced the perfin with a total quantity of 80,000 being perforated.

The Festival of Stamps 1976 was held at the Central Hall, Westminster, London SW1. The special cover for May 6th shows 3 stamps (Ascension Island, St. Helena, Tristan da Cunha) superimposed on a map of the South Atlantic. The insert gives this information: -"This year three South Atlantic Islands have collaborated to celebrate the Festival of Stamps and Britain's National Stamp Day in a quite unique manner for, not only have Ascension, St.Helena and Tristan da Cunha decided to simultaneously issue souvenir sets of stamps, they have also agreed to issue a souvenir sheet of the three top values from each set se-tenant, an unparalleled event in the history of postage stamps. The design of this cover is based upon that of the attractive souvenir sheet which will undoubtedly prove to be an extremely popular and highly sought after item amongst collectors". The only stamp perfined NSD/1976 (N.2956.01) was the 8½p Telephone Centenary of 10th March 1976 (S.G.997). This too was perforated by Slopers but only 20,000 were perfined.

In 1977, the Festival of Stamps moved back to the Royal Festival Hall. The cover used for this year was a Souvenir Letter Card with no insert information card. The Letter Card shows the logo of the Queen's Silver Jubilee. The stamp used for May 6th, perforated NSD/1977 (N. 2957.01), was the 8½p Centenary of Royal Institute of Chemistry (S.G.1029) of 2nd March 1977. During the Festival, on May 11th, the Silver Jubilee stamps came out. The Souvenir Letter Card was used on May 11th with the 8½p Silver Jubilee Stamp (S.G.1033) perfined SCPC (S.1767.01). I have one of these with SPECIMEN overprinted in red across the address space.

The Royal Festival Hall was again used for the <u>Festival of</u> <u>Stamps in 1978</u>. The cover used on National Stamp Day shows a line drawing of the Royal Festival Hall below a coloured logo of the National Stamp Day Union Jack. The insert states:- "This year's exhibition shows the development of written communications from the Egyptians to the present day and gives visitors a total picture of the growth of the postal system and its related services". The stamp used was the 9d British Architecture of 1st March 1978 showing the Tower of London (S.G.1054) with perfin NSD/1978 (N.2958.01) In a letter from the Publicity Officer of the Stamp Publicity Board, I am told that these four years were the only occasions when perfined stamps were used; Slopers <u>probably</u> perfined the 1977 and 1978 stamps (SCPC have not kept the record); certainly less than 20,000 stamps were perfined in 1977 and 1978 respectively; the stamp booklet of 1975 and the Letter Card of 11th May 1977 were the only special items produced, apart from the covers and stamps, during the four years.

It is of interest to note that whilst the lettering used for all years is the 'standard' 4-hole Sloper alphabet, the numerals of 1975 are quite different from those used in the other three years. In 1975 the rounded style found on most recent numeral perfins employed by Hospitals etc. was used, whereas the numerals of National Stamp Day 1976, 1977 and 1978 are based on the 18 pin matrix. Detective Work Needed. Ed. M.R.S.

Under a dealer's glass, on a stand at York Stamp Fair, I spotted a perfin cover. The perfin was "F" with 8 holes and quite large but I was unable to get an accurate measurement. The stamp was a 1d GV Typo issue. The user was FISHER & CO., HUDDERSFIELD. On reaching home I checked my Edwards but found three "F" perfins which were possibilities. 0010.06 - 7mm; 0010.07 - 8mm; 0010.08 - 10mm high.

My stamp of 0010.07 has a Birmingham pmk and my stamps for 0010.06 could be Huddersfield. Could you check your holdings of these three perfins and let me know if any have Huddersfield postmarks?
