## RESEARCH IN OLD BULLETINS

## MEMBERS' COMMENTS ON PREVIOUS ARTICLES

Perfin 'Arms Type' Des.0160.01 Bulletin 274/20; 275/6.

JOHN NELSON writes:- "This perfin has fascinated me ever since Keith Rymer-Young sent me a tracing of it twenty or so years ago. The problem was to sort out what the design was supposed to be and I always suspected that it was some kind of deer with antlers but with a few pins missing somewhere at the bottom.

"At last Bob Schwerdt has come up with the brilliant suggestion that it might be a pair of crossed fancy "F's" and I think I can not only confirm this but also provide an almost certain identity.

"I have an 1891 trade directory which includes Dublin and after a short search have found in it a firm which used as their trademark a design comprised of crossed "F's" as in the tracing shown on the New Identities page N.I Pg. 11 in this issue of the Bulletin.

"The user of the trademark was FRANCIS FALKNER, Whiskey and Wine Merchant, 83 Grafton Street and 36 Dawson Street, Dublin and also at 2 Charing Cross Road, London SW."

Perfins "RA" and "R/A" Bulletin 275 Pg.24.

JOHN NELSON makes the following comments:- "The difficulty here is that Philips is a Dutch company and its British subsidiaries are not listed in the Stock Exchange Official Year Book.

"What the letters 'RA' refer to I have no idea but the name of the British company, originally Philips Lamps Limited, was changed to Philips Electrical Limited at some time between 1933 and 1949. It would appear that their present full name is Philips Electronic and Associated Industries Limited. The spelling Phillips (where used) is incorrect.

"Mullard Limited, London Carriers Limited (the address should read WADDON) and Philips Mitcham Works Limited are, or were, certainly subsidiaries of the main company. I cannot be totally sure about Stella Kadio but they probably were as their premises were next to those of London Carriers in Shaftesbury Avenue. I can find no record at all of Combined (or Amalgamated) Electrical (or Electronic) Services but they could well have been part of Philips at some time or other."

(Ed:- can any members from the Netherlands suggest an identity for "RA", as Philips is a Dutch concern?)

STEPHEN STEERE has looked in the Sloper Record Books and has found the following references - all for die RA - R0020.01.

<u>Amalgamated Electrical Services</u>, Waddon Factory Estate, Croydon. Found in Book 2 - the oldest - and in A-K ledger.

Combined Electronic Services Ltd.

In Book 1 - the latest - no address. However in the late 1970's I (Stephen) went to them in Purley Way, Croydon. They were the service agents for Philips products.

Mitcham Works Ltd, Mitcham Junction, Surrey. Later moved to Commerce Way, Purley Way, Croydon, Surrey.

In Book 2 and L-Z ledger, refers to Philips Electrical Ltd.

<u>Philips Electrical Limited</u>, Century House, Shaftesbury Ave, WC2 and Cashiers Dept, City House, 420/430 London Road, Croydon. In the Red Accounts Book.

<u>Philips Lamps Limited</u>, shows in brackets. Philips Electrical Co., Century House, Shaftesbury Avenue, London WC2, branch in Croydon. In L-Z ledger.

There is no other die or other related companies in the records.

"CURRIE" Perfin Numerous Bulletins-latest- 274/14; 275/5.

From STEPHEN STEERE:- "An extra snippet on the Currie Perfin. I have just picked up a cover dated SP-7-1887, cancel Scottish Duplex 166, Grangetown, die C7980.03. The address on the back is REVACK LODGE. It's again addressed to Captain Wisely in London".

IAN BURNS has sent the following article which he found in the DUNDEE COURIER for 16th February 1995.

## CURRIE LINE WEIGHS ANCHOR

Currie Line, one of Scotland's oldest and largest shipping, warehousing and haulage companies, has been acquired in a management buy-out from parent Anchor Line.

Currie Line was incorporated in the 1790's as the Hull and Leith Shipping Company and changed to its present name in 1940. Anchor Line acquired the company in 1968 and was in turn acquired by the Swedish company AVENA in 1990. The opportunity for the buy-out follows Anchor Line's decision to concentrate on its core gas tanker business. Currie Line's operations account for 10% of all Scottish manufacturing exports."

## "RNB/WB" Perfin Bulletin 273 Pg. 10.

JACK BRANDT assumed this was a broken die - he has no covers or cancels - but has the full RNB/WB on a 4d & 5d Machin but as RNB/WD on a  $6\frac{1}{2}p$  and  $8\frac{1}{2}p$  Machin. (Ed.- I have a 2d Machin as RNB/WB. Is it only decimal machins which show the 'WD'?)

## "C&K" Perfin Bulletin 273 Pg. 12-13.

JACK BRANDT has sent a photocopy of the perfin 'C&K' - C4135.01 but with only one stop - the one between the 'C and ampersand. It is a <sup>1</sup>/<sub>2</sub>d orange Jubilee and has postmark SP-13-98 PENDLEBURY.

Raphael Tuck Perforated Label Bulletins 246/2; 251/8; 270/6.

JOHN MATHEWS (Australia) spotted another of the 6d labels in a local "Cinderella" auction. The penscript notation on this latest example reads, "Miss C. M. Hindley/N° 6/7-3-89." As the date is the year prior to the Exhibition could it be that Miss Hindley's was entry number 6?

MIKE OXLEY tells me that the 6d label mentioned in Bulletin 246 is deep carmine red and the writing appears to read "Mrs Stroud". The 1d label from Bulletin 251 was sage green.

1922 Irish Overprints Perfined Bulletin 272/14-15; 274/16.

There have now been 23 contributors to this survey. I am sure it is not too late to send further reports to Roy. I came across a copy last month and Roy tells me it is a new die - so added information is still out there waiting to be reported.

1993 Netherlands Christmas Stamps Bulletin 275 Pg.22-23.

In the April edition of The South Pacific Perfin Bulletin (pub. by the Perfin Club of New Zealand & Australia) there is a further note on this particular stamp issue. John Mathews illustrated the reverse of the whole sheet of 20 stamps, showing the full perfin pattern. Over the whole sheet of 20 stamps there are only the two different patterns as shown on page 22 Bulletin 275.

In the October 1994 Perfins Bulletin (US) the pattern was referred to as "snowflakes" in a random pattern. John thinks the two stamps together could form part of the Constellations Draco, Hercules, Ophiuchus and Scorpio which appear overhead in the Northern Hemisphere near midnight in December. He also thinks he might have an over-active imagination!!

What is the answer - Netherlands members?

Humber/Hillman Bulletin 239 Pg.19; 240 Pg.10.

In Tilles, H4490.02 is identified with Hillman Motor Car Co. Ltd., Coventry. In Bulletin 239 Rosemary Smith sent in another identity for this perfin - namely Humber Ltd., London EC. The cover was dated 1900 and stamp a <sup>1</sup>/<sub>2</sub>d green Jubilee. The question was asked, "Is this classed as the Hillman Company?"

In Bulletin 240, DAVE HILL wrote to say that Humber did not become part of Rootes group until 1930 and he believed Rootes had already acquired Hillman by 1930, so the 1900 cover must be a Humber Ltd., in its own right.

Now DAVE HILL adds the following:-

"In Bulletin 240 I expressed some doubt of a link between Humber Ltd and Hillman Cars Ltd., both reported as users of H/Ld-H4490.02. I have since found that Humber did have a controlling interest in Hillmans and also Sunbeam Talbot, another car maker. They also controlled lorry makers Kommer and Karrier; bodymakers, British Light Steel Pressings; and coachbuilders, Thrupp & Maberly.

When Is A Perfin Not A Perfin Bulletin 268/22; 269/12; 271/7.

One of the answers seems to be, "When it is a Post Office Clip". In Bulletin 271 it was stated that there was mention of this clip or punch in a philatelic journal. Thanks to the stamp dealer Ken Knight, KEVIN PARKHILL has sent me a page from the November 1984 Stamp Monthly. The article is reprinted whole with permission from the editor of Gibbons Stamp Monthly.

## NOT "RED CROSS" STAMPS

Reprinted from THE BRITISH PHILATELIST, November 1924.

Bulletin No. 276 (Jun '95) Pg. 9.

Some five years ago, the Higher Officials of the British Postoffice came to a decision - and acted upon it! - which might have had a most serious effect upon philately, not to mention the Entente Cordiale, the 'status quo ante' and European politics generally.


They got nervous - or shall we say, apprehensive? They certainly 'went off the deep end' in a red-tape round-about manner.

But why? Because some used high-value stamps had been taken off old telegraph forms, presumably to supply a philatelic demand: not a great matter to make a fuss about. But when the 'taking off is officially rendered as 'frequent surreptitious removals', the man in the street 'sits up' and feels that there is something very seriously wrong indeed.

The outcome of this important and terrible discovery was that an Official Notice emanated from the GPO, and was sent to certain chief Post Offices. Here it is, 'verbatim et literatim':-

In view of the frequent surreptitious removals of the high value Postage Stamps from Telegraph forms, it has been decided, after experiments at certain selected Offices, that stamps of 2/6d and upwards in value shall be clipped at Post Office counters by means of special appliances, in order to destroy the Philatelic value, before being issued to the Public to be affixed to the Telegraph forms. Two pairs of the appliance will shortly be issued. The stamp should be slightly folded before being clipped, in order that the perforation may be made about the middle of the stamp. 15th August, 1919.

Our informant, to whom we are much indebted for communicating the terms of this document, tells us that at Nottingham the high value stamps were, for a while, sold in this mutilated state for all postal purposes - letters, parcels, telegrams. What stock was supplied by the GPO, or made locally by a specially appointed official, there is no available record; but at Nottingham, the stock, whatever its size, was duly exhausted. And then, after all this trouble of issuing a Notice and making 'special appliances', the experiment turned out to be a failure, in so far that it had not the anticipated effect - though it spoiled the stamp; but in so doing, created a new and scarce variety!



The stamps illustrated above were purchased over the counter of a Nottingham Post Office on 8th September, 1919.

Ed:- This would appear to answer the question concerning KGV stamps; but what of the QEII Castles used on telegrams and noted in Bulletin 269? Hopefully someone will come up with a later Post Office directive about these 'clips' which occurred around 1964-65 time.

(Alastair thought this was very "iffy" as only 1d values were overprinted O.U.S. although the stamp is of the right period. He wrote for a photocopy but was informed that it was already sold.)


Lot 142 Q.V. line engraved perfins used with duplication, varied condition. Comprising 1858-79 1d plates (29) inc. GWR (4) & GER (1); 1870 <sup>1</sup>/<sub>2</sub>d (61) and 1<sup>1</sup>/<sub>2</sub>d (41). Cat. £1200+ Est. £90.

G.B. Postal Auction 30th March 1995.

Lot 504 1914 1d & 2<sup>1</sup>/<sub>2</sub>d pairs (perfinned) on PARCEL FRAGMENT with "Charing Cross" parcel post label ft KEVII 2R, 3R & 4As (India). Tatty but most unusual. Perfin is COX. Est.E95.

(Ed:- even if the India stamps were perf'd COX, the £95 is way out.)



#### NEW PERFIN FOR USE BY THE EDITOR OF THE PERFINS BULLETIN

On March 26th 1995, John Lyding, editor of the American "Perfins Bulletin", began to use a new perfin on his outgoing mail. The perfin is a design in the shape of an anchor. I should be interested to know if the anchor design has any special significance to John, or the Perfins Club.

## TELEGRAPH, TELEPHONE AND CABLE COMPANY PERFINS

A non member, MR.W.T.GLOVER, purchased some of our catalogues for his own research purposes and has provided the Society with a few potted histories of companies having connections with telegraph, telephone and cables.

## 1. Anglo American Telegraph Company Limited

A0310.02 AAT/CL stamp period not recorded.

This company was formed in 1865 to raise capital to try to lay a submarine cable across the Atlantic after the 1865 failure by the Atlantic Telegraph Company. This attempt succeeded in 1866. They also recovered the 1865 cable and completed it. Four more cables were laid for the company in 1873-4, 1894 and over the Atlantic Telegraph Company and the 1910. It took French Atlantic Telegraph Company in 1973. In 1911 the company came to an agreement with Western Union to lease its cables to Western Union. WU terminated this in 1963 paying Anglo American a substantial sum in compensation. This was paid out to shareholders and the Anglo American was liquidated on 10 December 1968.

I am not sure of their London office address but a reasonable guess would be EC2, around the Old Broad Street/Moorgate area, (known as Telegraph Alley).

2. <u>Cable and Wireless</u>

C8310.01 C&W stamps Q-U

C8310.04 C&W stamps M-Q

Cable and Wireless came into being in 1929 when the Eastern Telegraph Company and the Marconi Beam Wireless stations plus other cable companies merged into one company:- IMPERIAL & INTERNATIONAL COMMUNICATIONS LTD., with Cable and Wireless as the operating company. This had been brought about by the near bankruptcy of the cable companies by competition from Wireless. In 1934 the Imperial & International Communications Ltd name was dropped and Cable and Wireless became both the holding and operating company.

The head office was initially at ELECTRA HOUSE, MOORGATE, EC2. In 1933 it moved to ELECTRA HOUSE, VICTORIA EMBANKMENT, WC2. In November 1955 a further move was made to MERCURY HOUSE, THEOBOLDS ROAD, WC1.

Their principle telegraph station was at TOWER BUILDINGS, MOORGATE, EC2. In addition they had around two dozen telegraph stations in the London area including one at 18 Old Broad Street, EC2. They had a similar number of offices in the provinces, i.e.:- Birmingham, Leeds, Newcastle upon Tyne.

3. <u>The Exchange Telegraph Company</u>

Formed in 1872, this was a news agency supplying information newspapers, radio stockbrokers, and later television to companies etc., who rented telegraph equipment direct from the company. They also supplied the wire service to bookmakers when bookies shops became legal. At no time did it provide a public service. Head office was at 17-18 Cornhill from 1872 until 1919; 64 Cannon Street from 1919 until 1965 (acquired 62 Cannon street in 1922); Extel House from 1956 onwards (address unknown but situated halfway between Fetter Lane and Shoe Lane 100 yards north of Fleet Street.)

Other premises used by this company were:-

8 Picadilly; 14-15 Panton St; Creechurch Lane; 36-8 Whitefriars Street; Newcomen Street; 22 Budge Row; 13-19 Curtain Road; 61 Knightrider Street; 15 Cannon Place; 85 Tooley St.; 17 Moorgate Street; 16 Fitzjohns Avenue; 21-24 Old Change; 36-7 Queen Street.

The above (3) is taken from EXTEL 100 The Centenary History of the Exchange and Telegraph Company by J. M. Scott published in 1972.


4. <u>The Telegraph Construction and Maintenance Company</u>

T1000.01 T.C.&/M.Co.L Stamps A-B Ø suspected 1d only Formed on 7 April 1864 by the merger of The Gutta Percha Coy and Glass, Elliot and Company. Their first registered office was 54 Old Broad Street, London EC2. In 1869 they moved to 38 Old Broad Street and remained there until 1936 when they moved to 22 Old Broad Street. The trade name of the company was TELCON. The main cable making factory was at Enderby's Wharf, Greenwich. It is still used by STC today but not for cable manufacture. Their principle trade was that of submarine cable manufacturers and installers, becoming the largest such company in the world. In the period of their existence they manufactured in excess of 500,000 miles of submarine telegraph and telephone cables.

In 1935, Telecon and Siemens Brothers merged their submarine cable businesses and called the new company Submarine Cables Limited. Each company holding 50% of the shares.

On 9th February 1959 British Insulated Callenders Cables acquired the share capital of Telcon and split the company up retaining those parts it required and abandoning others. Effectively from that date Telcon ceased to exist. Submarine Cables Ltd continued as before but with BICC owning 50% shares.

In November 1966 BICC sold its holding in Submarine Cables Ltd to AEI, who having already taken over Siemens Bros., now owned the whole of Submarine Cables Ltd. On 4th November 1970 they sold Submarine Cables Ltd to Standard Telephone and Cables Ltd and the firm ceased to exist as a separate company from that date.

STEEPHEN STEERE writes that he has a picture postcard with the unidentified die of RBC/B (R0423.01) on it. It is on a KEVII <sup>1</sup>/<sub>2</sub>d (dark), cancelled Birmingham February 20 1903. The sender is a L.RANDALL with an address of Park Road, Moseley. Moseley is now part of Birmingham. Is - or was - there a Randall Bros Company of Birmingham based in Moseley? Could anyone confirm this or assist with further information please?

#### Sloper's "Tower Royal Works"

JOHN MATHEWS wishes to know why Sloper's premises in West Hampstead were called "Tower Royal Works". From Post Office London Directories, this name seems to have been used for those works from the very early days of Sloper's perforating business. John wonders if any of the company material which is in the possession of the Society gives a clue to the origin of the "Tower Royal Works" name.

#### From ROBERT SCHWERDT

He is preparing a revised edition of the African section of the WORLD PERFINS CATALOG and he has a few questions which he hopes fellow 'perfinists' can answer.

1. There is a note in Scott's catalogue for the MEF overprints in British Offices Abroad sections, namely, in 1950 the 15 stamps (1942-7) were declared valid for use in Great Britain. There is no corresponding note for E.A.F. Somalia, Tripolitania or Morocco. Bob wonders if these latter overprinted issues were also valid in G.B. The reason he asks is that a 2/6d item overprinted TANGIER is reported with R&S/M perfin and Manchester cancel dated cl950.

(Ed:- Looking in my "The Commonwealth Catalogue of King George VI Stamps" 8th Edition 1960-61; at the beginning of the British Offices Abroad section it states, "Overprinted G.B. stamps (unsurcharged) can be used in the U.K." The important words I would think are the "UN-SURCHARGED". This means that A.E.F. Somalia and Morocco were valid in the U.K. for a period of time as there was no local currency surcharge on the stamps for certain issues but not Tripolitania as all stamps overprinted for use in Tripolitania were surcharged too. E.A.F. Somalia 1943-46 stamps were valid in the U.K. and E.A.F. Morocco overprinted TANGIER from 1950 onwards. Stanley Gibbons Stamp Catalogue for the Commonwealth also makes mention of these issues being valid in the U.K. It could be that members who specialise in the Postal History of these territories can give Bob far more precise dates than those quoted by myself.)

2. Bob has another question:- he is trying to determine if for British Offices in Morocco - French currency - BEM perfin - there were two varieties of this perfin. The perfin catalogue lists two but he is unsure if there really are two different BEM's, or if some distortion occurred in the printing of the catalogue since one type is listed in a supplement to the catalogue.

## STORING AND DISPLAYING PERFINS

One of our members, KIM BJARNT of Denmark, could not attend the London meeting and, wishing to participate in the competition, sent me photocopies of how he stores his perfins. Unfortunately, his packet arrived whilst I was on holiday so his entry did not get to the meeting. I found his way of storing perfins very interesting, so by way of apology to Kim for missing out on the competition, I am including in this Bulletin part of his entry. It may be a possible blueprint for others to follow.

He decided to make up his own sheets - as illustrated on the next page - the framework of which is Xeroxed on 80g copy paper. At the top is a header where he writes catalogue number, user and period of use. The page also has a footer where he notes any covers he has. Just below the header are 5 squares; in the first he puts the perfin die, using the reverse of the stamp in a black mount; the other 4 squares are used for variations of the die e.g. Provisionals, inverted dies etc.

The rest of the page is divided into 25 squares and is used to mount perfinned stamps with picture side up, with SG Nos. below. All values of any particular issue can be accommodated.

All sheets are kept in plastic sleeves, open at top and left side for easy access and stored in a 40mm 4 ring binder. He calculates around 110 binders will be necessary for a complete collection. Perfin covers are stored in A5 sleeves/binders with a small sticker on the sleeve for notes.

## <u>IPSWICH PERFINS/PERFORATORS</u> By Dave Hill.

The Archives start with the case of Braham, a sub-postmaster in East London who perforated stamps in competition with Sloper. Braham went bankrupt and was replaced by W.L. Kenny who had perforated stamps in Ipswich. I referred to this in Bulletin 274 when talking about Fison's perfins.

I have obtained some old Bulletins and find that Mike Burrows wrote about Ipswich perfins in Bulletin 190, November 1980. Mike was a frequent and very readable contributor to the Bulletin. His information takes the story back further and shows another link between Braham and Ipswich. I apologise for telling the story backwards and suggest members read this and then read page 11 in Bulletin 274 to get it in the right order.

It would seem that W.L. Kenny's partner or boss was a W. Day as he is listed as proprietor of the sub-post office at 46 St. Nicholas Street. Braham produced stamp requisition forms (one is illustrated on Page 12 of John Nelson's Handbook) for the convenience of clients and some bore an impression of a perfin. They must have also been sent to prospective clients as amongst the 100 or so known are some perfins as yet not recorded on stamps. One such is the perfin "W.DAY", which Mike presumed was more of a sample than an actual perfin to be used on a stamp. Amongst the ones known used are at least two from firms within yards of the Ipswich Post Office of Day and Kenny.

Does anyone know the whereabouts of the Braham perfin requisitions I refer to in the above article - an example as in John Nelson's Book. John Nelson says they were offered some years ago by an auction house. Did a member buy them or does someone know who did? With copies of these it may be possible to establish a Braham "alphabet".

## ONE THING LEADS TO ANOTHER By Mike Burrows.

About ten years ago (now 25!!)/ whilst chatting to members of a local philatelic society after a meeting, the subject was turned around to perfins. During the course of the conversation someone said that they had heard from someone else, that many years ago

it was possible to buy perfinned postage stamps from an Ipswich Post Office.

At the time this was regarded as just a piece of gossip without any foundation whatsoever. But in the belief that all bits of perfin information should be recorded, even if somewhat dubious, a note was made of the conversation and forgotten until now.

To have an interest in more than one branch of philately can sometimes be an advantage. A recent piece of research that involved the identity of sub-postmasters of Ipswich in the late Victorian era, brought to light a possible clue to help substantiate the rumour first heard all those years ago.

As both the port and town of the Capital of Suffolk grew it became necessary to open more sub-post offices or branch receiving offices. In the early 1850s there was only one sub-post office. This was situated near the docks and had its own circular date stamp - WET DOCK/IPSWICH. A very popular postmark with local collectors. In addition to this Ipswich also boasted two branch receiving offices.

By the 1880's several more offices were opened. One of which was at 46 St. Nicholas Street. This office was located in the premises of William Day, a grocer and provision dealer.

On page 12 of John Nelson's book "The Handbook of British Perfins" can be found an illustration of a Frank Braham Stamp Requisition Form. Attached to the form is a perfin DSF/G on the centre margin of either a <sup>1</sup>/<sub>2</sub>d vermilion or a 1d lilac.

Also in existence is a small collection of a hundred or so of these so-called 'Braham Proofs', several of which have had a reference number added in ink. Some of these proofs are of perfins known to have been used on postage stamps by companies in the Suffolk area. Whilst some are not as yet recorded in the catalogue at all.

Reference was made in another article "Ipswich Firm's Philatelic Links" (published Sept/Oct 1980 SEPS Bulletin) to the perfin,

#### 341.1 SHC 10,12,8 4<sup>1</sup>/<sub>2</sub>mm

Known with Ipswich postmarks of 1896-98, this perfin is number 2042 in the 'Braham Proof series.

No.2040 in the same series is:-

# 143 RD/F/JB 11,11/13/7,13 4<sup>1</sup>/<sub>2</sub>/7<sup>1</sup>/<sub>2</sub>/4<sup>1</sup>/<sub>2</sub>mm

and is identified with R.D. & J.D. Fraser of Ipswich and Felixstowe.

In the middle of those two perfins is 'Braham Proof No.2041. Not listed in the catalogue, the configuration of this perfin is:-

## W-DAY 13,11,10,8 4<sup>1</sup>/<sub>2</sub>mm

The stop is not level between the W and D but is equidistant between the bottom two pins of each of the two letters.

The obvious conjecture to all this is that the sub-postmaster, William Day, acted as agent for Frank Braham and, therefore, the rumour was partially true. The possible correct explanation being that companies in Ipswich requiring perfinned postage stamps could order them from William Day. The 'Braham Proof No.2041 being in the nature of a sample of the kind of work Braham could produce, rather than a required security perfin for William Day's grocery and provisions business.

If the perfin SHC does prove to belong to S. H. Cowell (Ed.:- at the present time, 1995, no proving cover has been found but the die is known on 1d lilacs and Jubilee stamps with dates ranging from 1893 to 1899) this would add weight to the theory. Especially as both S. H. Cowell and R.D.S J.B. Fraser were located within a few hundred yards of William Day's sub-post office and grocery business.

Admittedly it is all theory, but can we be sure that we have heard the last from sub-postmaster William Day?

\* \* \* \*

Continuing this theme, Dave Hill adds the following:-

Sidney Allchin, another perforator of postage stamps, produced a list of users for a publicity leaflet; we think about 1910. The list is a bit short and it is not possible to be sure which dies are Allchin's from just a list of users. I did come to the tentative conclusion however that they might use an alphabet which had lots of small pins (like Sloper's at the same date) but with rather untidy "squarish" corners where there should be nice curves.

I would be pleased to hear the comments of any other "alphabet seekers", or anything else that would help to determine the maker of individual perfins.


