It would be interesting to compare the directory entries with a Tomkins. Slopers had other addresses as well, (Walbrook before and Budge Row after) and finally New Bridge Street and of course Tower Royal Works, Blackburn Road, Hampstead.



The trail starts in 1887 with Messrs Robins, Burges, Hay, Waters & Lucas using RBH/&C° (R0495.01), but sometime around 1891/2 'Burges' disappeared from the scene and the die was replaced by one lettered RH/W&L (R2580.01). Over the succeeding years there were many partnership changes, each accompanied by either the modification of an existing die or the production of a new one.


To cut a long story short, the known names of the partners are as follows. The dates have been taken in the main from entries in London Trade Directories, with occasional augmentation from postmark dates on the stamps themselves.

1. Robin Robins, Burges, Hay, Waters & Lucas.	1887-1891.


After cl967 perfins no longer seem to have been used, although the firm continued to operate and probably still does today.

Clear postmarks and dates are a tremendous help in trying to identify a perfin user from a loose stamp. However, when they are coupled with a 'full name' the odds are well stacked in favour of success. Two such items have come to hand recently, which, with a little research, have resulted in two 'positive' identities.

The first perfin is from my own collection and concerns the full name 'Abol'. One example has the clear postmark 'Paddock Wood' (Near Tonbridge, Kent), and is dated 27 September 1929, and another bears a date of July 1935. Fortunately for me, Birmingham is nearby and has a Reference Library with a fine collection of national Trade Directories.




A0805.01A quick search through Kent Directories of the period soon established the existence of 'Abol Limited, Hop and Fruit Wash Manufacturers, Paddock Wood.' The advertisement below comes from a (Feb) 1922 Directory.




Directories before 1922 show that "Abol Ltd" was formerly "E A White Ltd, Farmers, Hop & Fruit Growers, and Manufacturers of Non-poisonous Fruit Tree Wash", last mentioned in their own right in a 1918 Directory. As Abol Ltd do not appear in a 1938 Directory, we can assume that they traded between 1920 and 1936.

The second full name is REX, a hitherto unknown perfin sent in by Ian Burns. He reports two examples on ½d & 1d stamps of King Edward VII, both with Coventry postmarks, one dated March 1906. Again, a search of Coventry Trade Directories of the period quickly revealed the existence of a 'Rex Motor (Manufacturing) Company Limited', Motor Car and Motor Cycle Makers, Osborne Rd, Earlsdon, Coventry.



The company was formed in June 1902 by the amalgamation of Allard of Coventry and the Birmingham Manufacturing and Supply Company Limited. The Birmingham company had already produced its first car (the 'Charette') in 1901, and claimed it 'was most perfect car in the world'. The Coventry was situated in the middle of a residential area as this portion of the O.S. map for Earlsdon, Coventry (dated 1906) shows.



The Rex Motor Company also manufactured bicycles, but these were discontinued in 1903 in favour of motorised vehicles. company made a wide variety of cars including the Airex and the ('The King of Little Cars'), aswell Rexette as 2.8 litre monsters in the Rex-Remo range introduced in 1908. However, after 1911 the directors decided to concentrate on motor cycles, but all too soon the intervention of the First World War put an end to vehicle production. Motor cycles were produced after the war but by 1928 the Rex company had ceased to trade altogether

QUEEN ALEXANDRA'S LEAGUE OF SERVICE AND LORD MAYOR TRELOAR CRIPPLE HOSPITAL "QAL" perfins Q0080.01, Q0080.02, Q0080.02a, Q0090.01p By JOHN BUTTON

Sir William Purdie Treloar, Bart JP, was born 13-1-1843 and became the Lord Mayor of London in November 1906. As a JP he saw many poor children brought before court for begging or vagrancy and from this was born his drive to help them. Under the auspices of the Mayoral Charity Fund he aimed to raise the sum of £60,000 for the Lord Mayor's Little Cripple Fund. The sum raised exceeded this by over £10,000. In support of the Lord Mayor's objective Queen Alexandra opened a very successful three day fete. From this event the Queen Alexandra League was born and with it the Queen Alexandra Rose Day became the very first flag day.

The aim of the cripples charity was:- a) to treat children of both sexes up to the age of 12 who were suffering from TB or diseases of the bones and joints; b) to train crippled boys between the ages of 14 to 16 in handcrafts skills in order that they would be able to obtain a paid employment.

In early 1907 Lord Mayor Treloar was informed by Mr Hall Richardson of the Daily Telegraph that there was an unoccupied military hospital at Alton in Hampshire. On the 22nd March 1906 a visit was made to inspect the property and it was found acceptable. After negotiation the War Office agreed to the transfer and an act of Parliament was rushed through with the proviso that should the Hospital cease, the land and buildings would revert to the crown.

The establishment was first known as the Lord Mayor Treloar Cripples Home and Hospital but was later re-named Lord Mayor Treloar's Cripples Hospital and College.

Ten acres of land was laid out as orchards and kitchen gardens to provide fruit and vegetables together with areas for pigs and poultry. This no doubt also provided for occupational training. A large aviary was also built to house indigenous birds to further the children's awareness and education. The London and South Western Railway provided a special siding into the Hospital initially for supplies but later to accommodate passengers.



SEEN IN AUCTION

PHILIP ROBINSON sent in the following information:-

From the Kohler catalogue for Feb '97 - Lot 4971

On the front an 1878/82 2½d blue plus 1d lilac, manuscript cancel on a folded business letter to St. Petersburg. Arrival mark on front and cache of Wm Brandt's Sons & Co, London 29 JUN 83, perfin W.B/SC° (W0790.02).

The unusual feature of this cover is to be found on the reverse. There is a vertical strip of the 1880 first Telegraph stamp, ½d orange, all perfinned W.B/&C and postmarked Lon 29 JUN.

The catalogue comments - "The Telegraph stamps are very rare postally used. To this destination no doubt unique."

The price quoted was 1800 DM which, at the rate of exchange in my morning paper, comes to some £700.

I am almost sure this was the same cover I examined last year at Stampex, on the stand of an American dealer. If so, it is without doubt a beautiful item.

From DENNIS BOOT comes this very important sighting:-

From Cavendish Auctions, Derby, 7 DEC 1996 - Lot 1547

Memoranda Booklet + Envelope with mint 1d lilac "SDC" Perfin.

The estimate was £350 but sold for £1425 + 15% Premium. Legend has it that it first sold over a stamp shop counter for £5.

Research Into The History Of Perfin Users

I have had a query about source material for in-depth reference to firms using perfins. Some time ago I made a similar plea through the Bulletin for members to identify reference books which they had found useful for this purpose: books which could be borrowed from a library. I had no response to that plea but hope for some answers this time.

I suspect that the majority of histories, which have been published in the Bulletin were obtained by members who live in the locality of the companies and source material is easily obtained in a 'Local History' section of their library. Some histories are obtained by writing to the archivist of a firm but this may only apply if the firm is still trading under its original name or as a

JARROW MARCH & "D.C." PERFIN

Towards the end of last year KEVIN PARKHILL was watching the T.V. programme about the JARROW MARCH. For overseas members who are perhaps not as familiar with this expression as we are, it was the march of many thousands of out-of-work men from the North East of England to London; there to try to open the eyes of Parliament to their plight in the ship yards, steel works and coal mines of Tyneside - Jarrow, Darlington, Durham etc.

Whilst on the march south, the marchers were sometimes housed overnight in village halls etc (if they were lucky). Many of these stops had been planned well ahead of time and the families in the North East could write to their men folk, care of the Post Office, at various towns along the route.

During the programme actual memorabilia was used at appropriate points and it was whilst the film showed men picking up their mail from a set pick-up point that Kevin noticed a letter on which was a perfin. Remember these were actual letters, which had been sent during that march in 1936. Whether this letter ever reached its owner we will never know but as Kevin was videoing the programme he was able to study the sequence when the programme finished.

The letter was to a MR CON SHEILS, G.P.O., JARROW MARCH, LUTON, BEDS. The perfin was D.C. 11,8 holes and a part post mark was TON YORKS. No doubt a Darlington Corporation perfin. Very well spotted, Kevin.

PERFORATED POSTAL STATIONERY

This third article on Perforated Postal Stationery deals with the Newspaper Wrappers of KEVII and KGV. There are two different preprinted stamps on the News Wrappers of KEVII and two on the Wrappers of KGV. All types have sub-divisions of shades, issued at various times, but for the purposes of this research I shall record dies under the one shade/value.




There are quite a number of anomalies in this section. If any member can answer any of the queries, confirm identities on wrappers or give dates, I hope they will write in with this information.

JOHN CORY & SONS, CARDIFF

Member MARGARET HARDING from Wales, a habitue' at our London meetings, brought along a Victorian perforating machine to the last meeting. She had heard about this small size perforating machine being used as a door stop by a member of the Cory family.



The die in the machine is J.C/&S and appears to be J1700.06. This illustration is from a strike through a piece of paper at the meeting. Margaret is hoping to be able to purchase the machine. She also provided me with the following history of the company.

JOHN CORY & SONS, LTD., MOUNT STUART HOUSE, CARDIFF

Taken from "British Bulletin of Commerce" Survey, 1955

John Cory was born in 1823 at Poundstock in Cornwall, the son of a farmer. As a young man he went to sea and in due course became Master, first of a coasting vessel, later of larger ships trading to the Continent. In 1854 he set up in business on his own in Padstow and bought his first ship, the MILLICENT, a 52 ft wooden smack. By 1863 he owned two larger ships and had retired from the sea to manage them, but as Padstow -had started to decline as a port, in 1872 he moved with his family to Cardiff.

Cardiff owed its rise to coal, and much of the firm's prosperity was built upon its export, and the import of iron ore from Spain. John Cory had married some twenty years previous to moving and he now brought his eldest son, JOHN, into the business, soon to be followed by his youngest son, HERBERT.

In 1885 John took his sons into formal partnership and the firm became John Cory and Sons, carrying on business as iron ore merchants, timber importers and coal exporters as well as shipowners. When, in 1891, John Cory died the elder son took over as Chairman and in 1898 the firm became a limited company. Meanwhile the business continued to grow, so that in 1898 it had twenty-three ships, and had moved to larger offices - the present building.

On the coal side special attention was devoted to the famous coking coals and Cory Trading Company was amongst the largest exporters in the UK. Cory appointed representatives in Newcastle and Hull to oversee their interests. In 1913 Messrs. Marchbank and Bainbridge took charge of these areas and were later joined by Dan Stonehouse. On the retirement of two of the partners the firm was incorporated in 1927 as Stonehouse and Cery, Limited.

The first World War took many of the firm's employees and twenty ships: one, the "ROSS", rammed and sank a U-boat. To replace these losses the Directors in 1916 bought the Newport firm of Orders and Handford.

The family continued to increase in numbers and the two sons of John, JOHN and CHARLES, and two of Herbert's sons, DONALD and FRANK, joined the business. Herbert was elected to Parliament in 1915 as Unionist member for Cardiff and later as Conservative and

Unionist member for Cardiff South. In 1919 he was created a Baronet. John was Chairman of the Cardiff Channel Dry Dock and Pontoon Company and Mountstuart Dry Dock.

1920 saw the start of the post-war shipping boom; new firms sprang up in Cardiff and throughout the country, and when the boom ended in 1923 more than half the shipping firms in Cardiff crashed. Cory's however survived and continued to replace its tonnage but at a slower rate. The iron ore trade with Spain was becoming less satisfactory and the subsidiary firm. The Seville and United Kingdom Carrying Co Ltd, had been wound up soon after the war and now, in 1927, the firm's Middlesborough office was closed due to the exhaustion of high grade ore.


1931 saw a further slump in shipping and in December the Chairman, John Cory, died at the age of 76. His death was closely followed by his brother, Sir Herbert, in 1933 and of Sir Herbert's two sons, Frank in 1934 and Sir Donald in 1935. On the death of Sir Donald the Herbert Cory side of the family lost their last member in the firm for FRED, who had managed the firm's London office at Ockenden, had taken to farming on the closing of that office in 1932. It was agreed that the John Cory side of the family should take over their interests but this inevitably led to some curtailment of the firm's activities.

In 1936 the firm had only three ships left, but the Trading Company was fully engaged in exporting coal to Spain. In 1939 John Cory died leaving only his brother Charles to carry on into the second World War, where their remaining tonnage was lost. After the war they took tonnage on charter from the Ministry of Transport. In 1948 they bought a ship from the Ministry and the Coal Department started up again, but the market was now controlled by The National Coal Board.

RAYMOND, elder son of Charles, the first of a new generation, came from the Navy and joined the firm, as did many other employees back from service, though there were many who had lost their lives, particularly among the ship's crews.


The firm looked for new activities. In 1939 the Cefn-On-Basic Co Ltd had been acquired by Cory's Trading. Their plant produces first class doloma and the Company contracted with all the South Wales steel works. An airbroking department was started and has expanded into the travel business with agencies for all the principal liner and air companies. The company has a financial interest in Cambrian Airways, the principal air operator in Wales. The family also has an interest in ship chandling.

The above history was from an article written in 1955 and I am led to believe that John Cory Ltd is now a Travel Agency and Tourist Operator: shipping interests are with Cory Brothers Shipping Ltd.

This photocopy is of another perfin punched through the selvedge. The perfin is KIC° (K1000.01) - identity not known. The selvedge is red and Jack believes it is from an Edward VII 1d. The other copy is the

reverse of an actual KE7 1d stamp - the die of which he has both with and without the missing hole. (See Bulletin 285 Pg.9 for his article on Missing pin dies)

Perforated Triangle Stamps Bulletin 285 Pg.10.

I apologise to the gentleman who rang with the following information. I was in the throes of dishing up the evening meal and although I wrote down the information I did not catch the name of the caller, forgetting to check at the end of the conversation: tantalising smells invading my nostrils!! Drop me a line and I will acknowledge in the next Bulletin.

I was told that there is a triangle Netherlands 1936 6c Pictorial Definitive with perfin 'SB' and a 1926 4d of South Africa with. 'JD&C'o' perfin.

BRIAN DENNIS from South Africa knows of six other triangular stamps with perfin. On the South Africa 1926 4d 'Hope' stamp:-

- 1 E.A./C. of the East Asiatic Co Ltd.
- 2 WD/SS (2 copies) which was probably used by William Dawson « Sons (South Africa) Ltd.
- 3 D.R/C likely used by the Dunlop Rubber Co (S.A.) Ltd.
- 4 TB (2 copies) user unknown.

From the Netherlands:-

5 SG461 - the 12½ Gisbertus Voetius Commem with N.B/V. perfin.

From Austria:-

6 An Austrian Newspaper stamp. SG N32 - which is a 2h Express stamp. This has the MF/C die of M Faber 6 Co, Vienna.

<u>T/BC^o Perfin</u> Bulletin 284 Pg.8-9 etc.

DAVID SCOTT writes to say that although the earliest cover for this perfin is 24-3-71, in the Sloper Impressions Books it shows that the die for this perfin was made by Sloper – Machine No.2670 - and was supplied on 17th January 1870.

German POL Perfins Bulletin 285 Pg.8.

BARRY MILLER says that the 1995 MICHEL Specialised Catalogue has the following note after the POL entry for West Germany.

"Although the formal suspension of the use of perfins by the Police-Department took place on 15 June 1965, the production of perforated stamps by subordinate offices continued until 31 December 1965. From 1-1-66 (reference to circular 178/65) the use of any perforated stamps was no longer allowed."

The last stamp referred to with the POL perfin is Mi 478 (issue of 29 MAY 1965).

This seems likely to be the last use because the last East German POL stamp mentioned in the catalogue is Mi 408 (from the 1953 5-year plan issue).

Sheffield Corporation Dies Bulletin 284 Pg.22-24.

BOB BREMNER suggests that the reason for the shortage of 1d stamps (1st para, Pg.24) was not necessarily because 1d was the general postage rate.

During the war, everyone was exhorted to buy War Savings Certificates to help finance the war. "Street" collectors were organised (I remember my mother taking me, as a small child, round our neighbours once a week selling 6d saving stamps) and for many, a 6d stamp, which was the cheapest one, was beyond their means.

A smaller savings card was introduced on which could be stuck 1d postage stamps and these could then be exchanged for the War Savings Stamps.

I have no reference book to check the dates when this system started during the war, but from enquiries of people who remember buying War Savings Stamps, this '1d saving' was correct.

PERFIN ON ADDITIONAL MEDICINE DUTY OVERPRINT STAMP By DAVID SCOTT

Medicine Duty stamps were first issued in 1783. In 1915 the basic rates of 1½d and 3d were each doubled. To allow stocks of existing duty stamps to be used up, a provisional issue of overprinted postage stamps 1½d and 3d was made. These stamps were stuck on to all the old medicine duty stamps to double the duty.

I was very surprised to find a C/AN/S perfin C0270.05a on a 3d violet overprint.







On the back of this stamp, at the top edge, there is a small bit of the medicine duty stamp to which this additional duty stamp has been stuck, and although this obscures a few of the perfin holes, it does prove that the stamp has been properly used.

The user of the C/AN/S perfin was the ARMY & NAVY CO-OPERATIVE SOCIETY, 105 Victoria St., Westminster S.W.I. Although a large Department Store, they were also listed in Kelly's Directories at this time, 1915, under the classification of Chemists & Druggists, and presumably the Medcine Duty overprint stamps would have been perfinned along with the postage stamps which they were using at this time.

The Army & Navy Co-operative Society acquired the assets of the Army & Navy Auxiliary Co-operative Supply Ltd in 1919, perfin AUX between parallel lines. In May 1934 the name was changed to Army & Navy Stores Ltd.
