

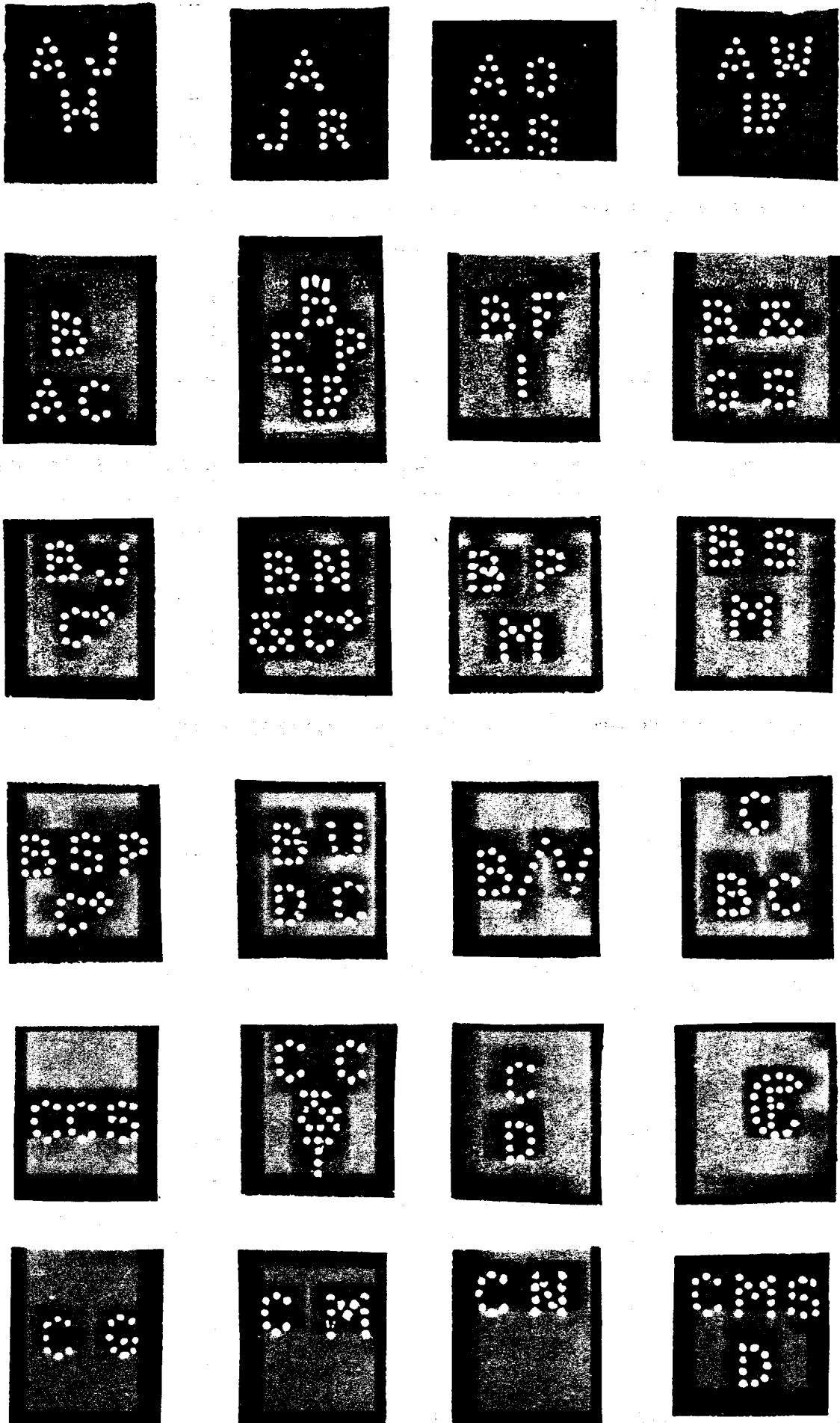
MORE FROM THE SLOPER LEDGERS FROM Stephen Steere.

The dies shown here are from the Accounts Ledger in the postage section, which is the perfin box. None of these are in the Illustrated Catalogue or in the new Update Pages of the Illustrated Catalogue.

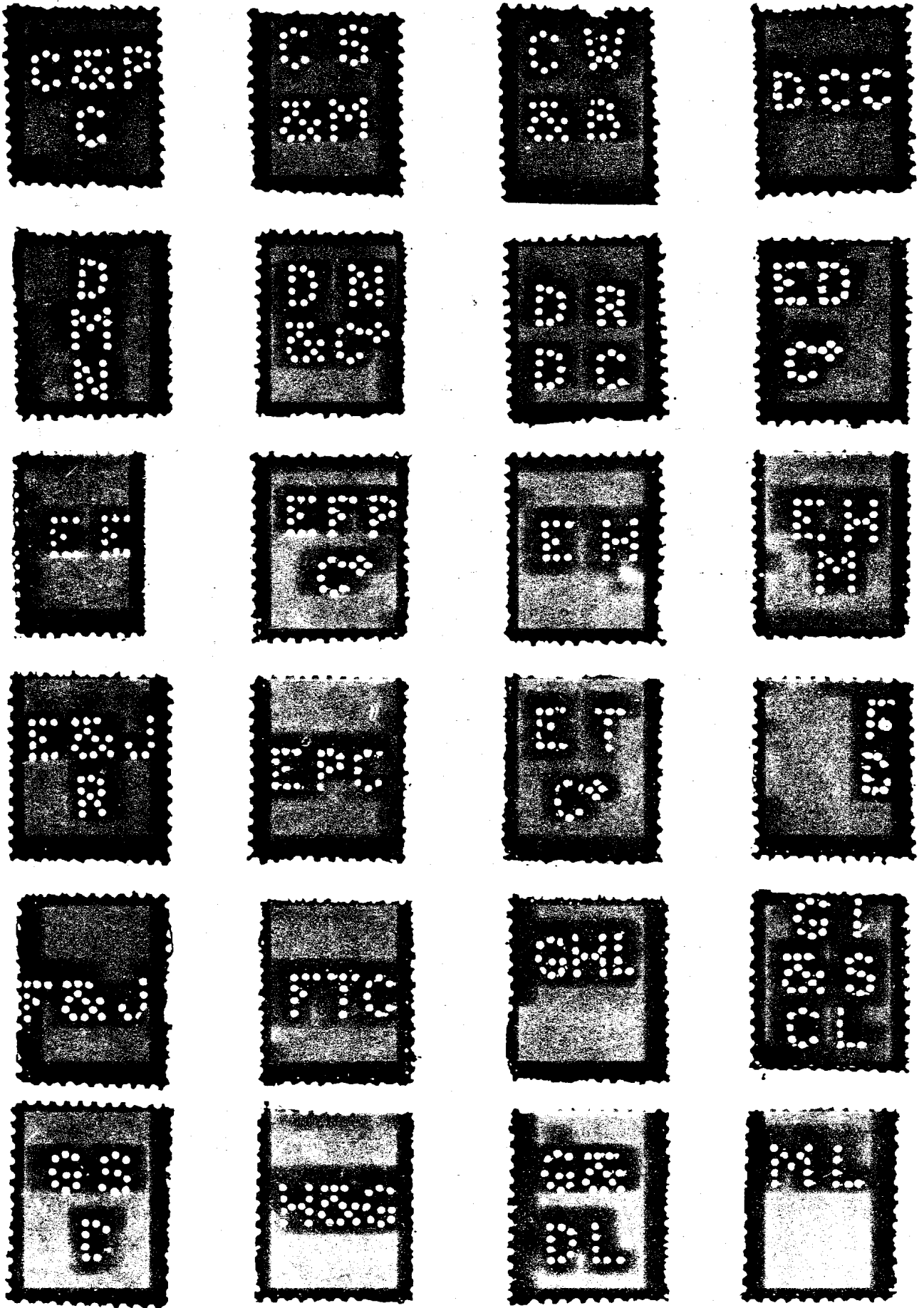

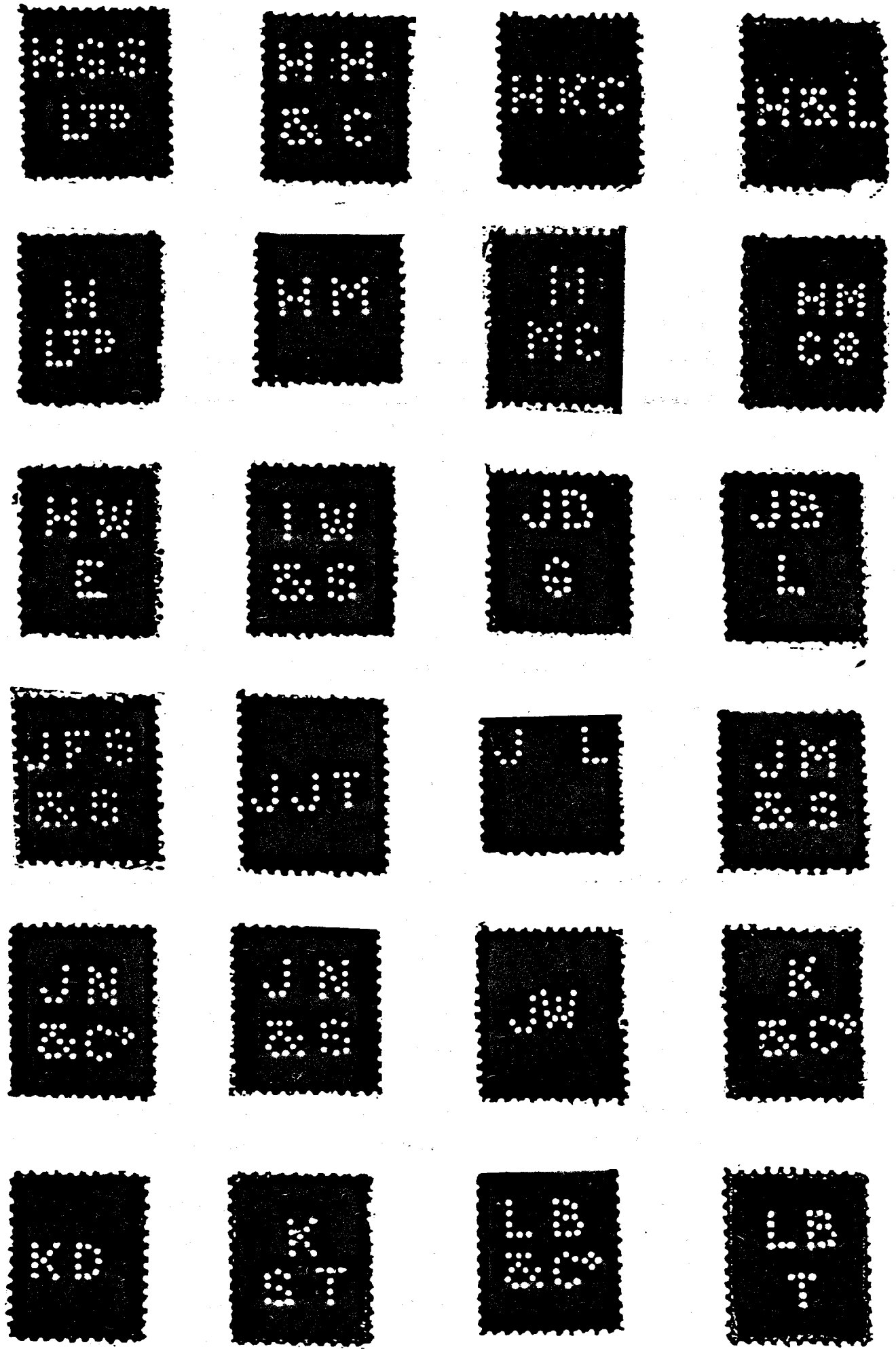

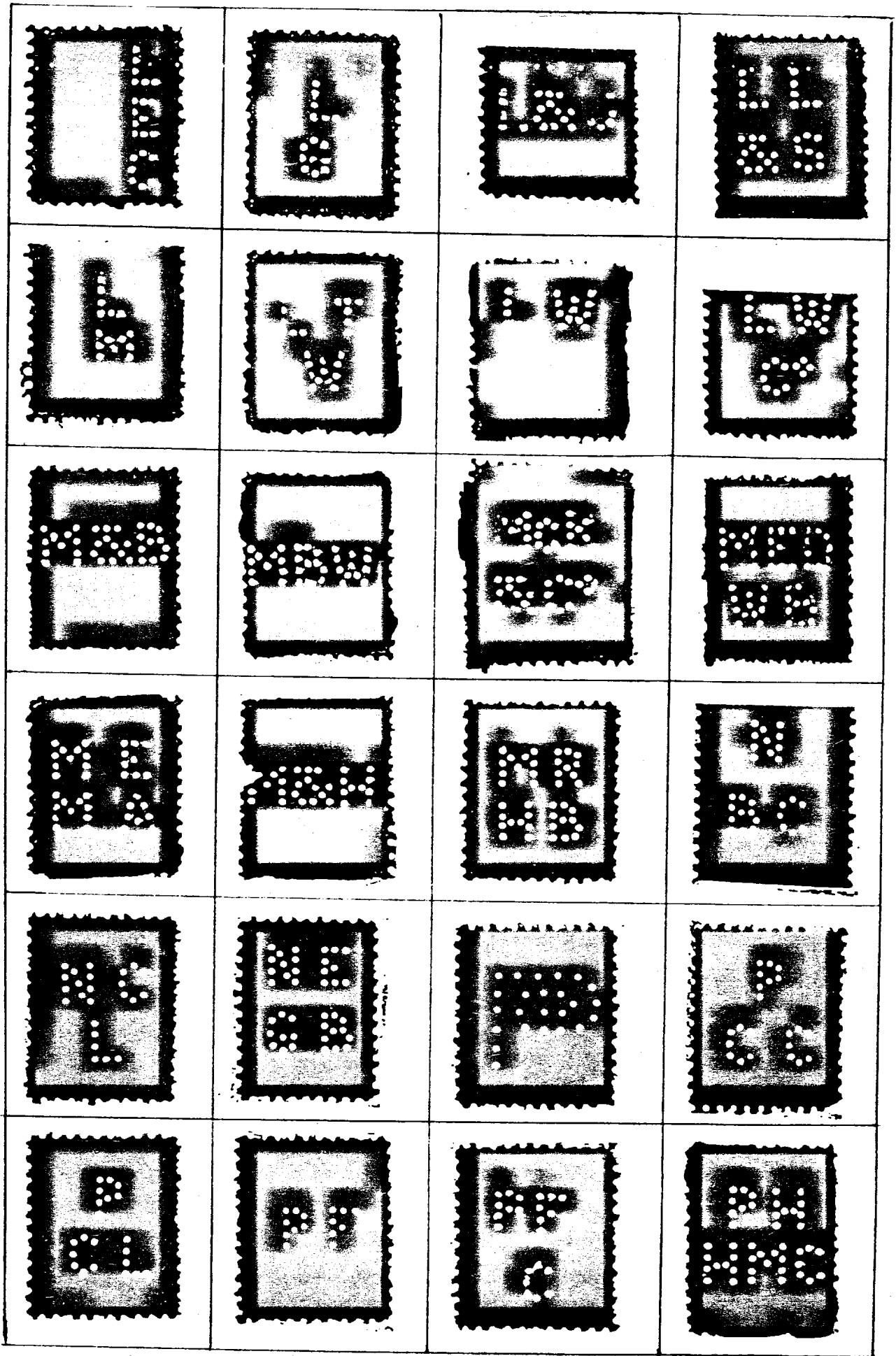
