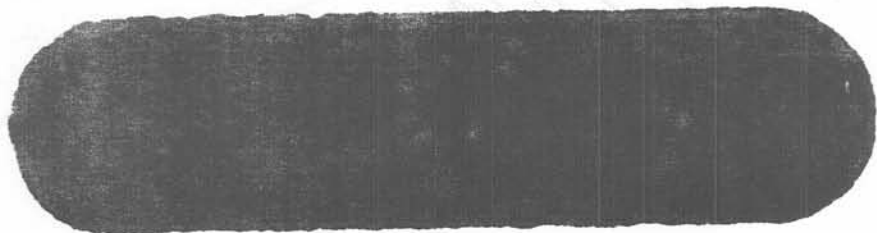
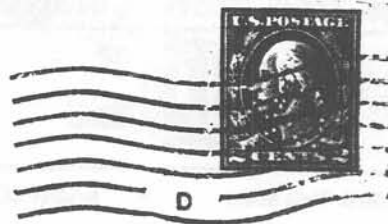

February 7, 1994 The *Catalog of United States Perfins* lists the Sligo Iron Works as the user of perfin pattern S151. This cover's corner card lists Sligo Iron Store Company of 1301 North Sixth Street, Saint Louis, MO on April 25, 1938. I suggest that since the initials match the perfin exactly the iron works entry should be relegated to the supplementary data section of the catalog.
