## The Kanawha Despatch: perfin isn't as tough to find as information

he Kanawha Despatch (Dispatch) perfin-K25-is not as elusive as the history of this railway. For more than four years I have found almost nothing to identify what this railway was other than it was a subsidiary of the 85 Chesapeake Ohio Railway. Numerous requests to railroad historical societies resulted in no response.

The NN & MV was a holding company which leased or had track rights of several small railroads on the East Coast, and in 1888 leased the C&O Railway and the C&O Steamship Company for westward expansion.

By 1890, the NN & MV was broken up, bankrupt, probably but the C&O reorganized and the Kanawha Dispatch stayed operational.

ally the C&O built their system to Cincinnati.

The Kanawha Dispatch was disbanded on May 1, 1918, when railroads the taken over by the United States Railroad Administration. WW I, the C&O resurrected the Kanawha Dispatch and it was operational for some period of time.

The U. S. perfins catalog lists the verified user of K25 as the Kanawha Despatch (the d-e-s spelling, I be-

The relationship of Old Dominion Steamship Company to the C&O is not known but it could be a part of the C&O Steamship Co. The Bill of Lading shows a logo of Kanawha Dispatch, while the Way Bill has a logo of Kanawha Dispatch Routes.


Some of this information was used to prepare album pages for my collection of railroad perfins, which is the only perfins I collect and study.

The Kanawha Despatch was a through (fast) freight line organized by the Newport News & Mississippi Valley Company and began operations on May 1, 1884.

The Kanawha Dispatch used Ohio River to reach Cincinnati and connect the Cleveland, Cincinnati, Chicago & St. Louis RR (the Big Four Lines) which leased trackage rights to the C&O to connect with Chicago and St. Louis. The C&O leased trackage rights with the Western Kentucky Railroad to reach Louisville, Kentucky, and then by the Ohio River to Cincinnati. Eventucan d-i-s spelling). This English spelling may have been used in the NN&MV era.

The American spelling is confirmed by a copy of a Bill of Lading of 1901, a Way-Bill of 1904, and an undated photograph of a boxcar with the C&O markings and the logo of the Kanawha Dispatch.

The Bill of Lading dated March 25, 1901. shows Kanawha offices in Cincinnati, which were shared at one
