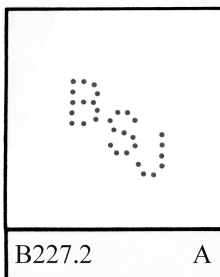

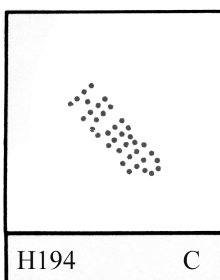

D	C-44	C157.5P	Delete this pattern. It is a partial of C264.5IP (new pattern ID).
D	A&C#1	C344.7	A&C#1 Section E. New Patterns - Delete C344.7, it is a partial of C345 with CO pins removed. Both patterns C345 and C344.7 found on a pair.
C	H-18	H194	Replace photo with A&C#2 photo (note: photo is H194A). The current catalog photo is considered a pin variety.
D	H-18	H194A	Delete this pattern.
D	H-28	H194A	Delete supplemental.
D	N-40	N113C-11A	Delete this pattern. It is a variety of N113Cc-8. Both patterns were discovered in a block of 4.
D	N-59	N113C-11A	Delete supplemental reference.
D	R-6	R47.5	Delete this pattern. It is a variety of R47. Both patterns were discovered in a strip of 3 stamps.
D	R-12	R116A	Delete this pattern. It is a variety of R116. Both patterns (R116 and R116A) were discovered in a block of 4.
D	S-44	S2.19	Delete pattern. S2.19 is a partial of S2.16. A pair was found with both S2.19 and S2.16.
D	S-65	S2.19	Delete supplemental reference.
D	S-16	S144.5	Delete this pattern. It is most likely a check writer punch since it was found on a 1897 U.S. post card and a 1901 Denmark stamp.
D	T-8	T81A	Delete this pattern. It is a variety of T81. T81 and T81A found on a strip.
