I agree to contract with Dawson County Arts Unlimited, Inc., herein called "**The Gallery**", to display for sale my artwork. I agree that **The Gallery** is not responsible for any artwork that is lost, stolen, damaged, or destroyed. All artwork remains the property of the artist until it is sold, except as outlined within this contract.

I acknowledge the displaying of my artwork is contingent upon my purchase of an annual Dawson County Arts Unlimited, Inc. membership. Membership dues are as currently defined by **The Gallery**. The membership year runs from the month purchased to the end of the same month one year later. If my membership dues become delinquent, I will be so advised in writing and given one calendar month to remit dues. If dues remain unpaid after one calendar month, the artwork will be removed from display. If I fail to pay dues or pickup my artwork within 90 days from the **first day of delinquency**, my artwork will be considered abandoned.

I agree to submit all works ready for public display. Hanging works will be properly matted and/or framed, complete with hanger attached. Prints will be framed or properly mounted and wrapped.

I agree to submit artwork that is **my own original work** with content appropriate for public display. **The Gallery** reserves the right to reject artwork for any reason. Any rejected artwork must be picked up by the artist within 90 days. Rejected artwork not picked up within 90 days will be considered abandoned.

**I agree to drop off and/or pickup artwork only in the presence of a board member. I agree to contact The Gallery ahead of time to make an appointment to drop off or pickup artwork. I acknowledge this cannot be done without a board member present.**

I agree to pay **The Gallery** a commission of 35% of the retail price for the sale of my artwork. I acknowledge that payment for sales will be received by the end of the first week of the month following the month the items were sold.

I agree all artwork shall be displayed for sale for a maximum of one year, after which time the artwork will be removed. There is no minimum timeframe artwork may be displayed. Artwork left for display for more than a year, will be removed from display by **The Gallery** unless other arrangements have been mutually agreed upon by The Gallery and myself. (**The Gallery** encourages new displays of artwork every six months if possible.) If 90 days after removal, I have not picked up my artwork, it will be considered abandoned.

I acknowledge any artwork deemed abandoned per this contract will become the sole property of **The Gallery** to sell, gift, transfer, convey, or otherwise dispose of at their discretion. Any proceeds associated with the disposal of abandoned artwork will remain the sole property of **The Gallery**.
