### Rates:

- ◆ **Food Vendors: \$150/day or \$300/weekend**
  - **Booth space: 10 x 20 ft.** No utilities provided. If additional space is required, this will incur an additional fee.
- ◆ **Craft/Baked Goods Vendors: \$75/day or \$150/weekend**
  - **Booth space: 10 x 10 ft.** No utilities provided. If additional space is required, this will incur an additional fee.
- ◆ **Payment is required by the Monday before your reserved day/weekend. Late payments will incur additional fees. Payment is non-refundable.**

- ◆ Payment options will be provided upon selection/approval of your application (cash, venmo).

Expectations:

- ◆ Vendors are expected to adhere to all rules/policies of Mama Mary's Farm & Pumpkin Patch to include: No smoking, no alcohol, and no pets
- ◆ Vendors will supply all of their own equipment to include tent, tables, chairs, etc.
- ◆ Booths are required to be kept clean and void of trash. Trash bins/trash bags will be provided by Mama Mary's Farm; however, you are responsible for emptying your personal trash bin to the main dumpster on the property.
- ◆ **Vendors are required to stay the entire day.**
  - **Booth Setup 7:00 AM- 9:00 AM** (no vehicles allowed in vendor area after 9:00 AM)
  - **Breakdown 6:00 PM**
  - Late arrivals and early departures will not be tolerated
- ◆ You may leave your booth/tent set up overnight at your own risk. There is no overnight security on-site. Mama Mary's Farm & Pumpkin Patch is not liable for any damages.
- ◆ Vendor location is assigned by Mama Mary's Farm & Pumpkin Patch.
- ◆ **Up to 4 entry wristbands will be provided to each booth.** Additional wristbands are available for purchase at the general admission ticket cost.
- ◆ **It is the vendor's responsibility to ensure compliance with Texas Sale Tax Laws and Regulations.**
- ◆ Prepackaged food/produce must be labeled and adhere to the Texas Cottage Law/Texas Health Department requirements.
- ◆ **A Food Handlers permit is required to apply as a Food Vendor.** Include a copy of your permit with your application. **Food vendors will NOT be considered without this permit.**
- ◆ Vendors are expected to show up on their selected dates. Last minute or frequent cancellations will not be tolerated. Vendor payments are non-refundable.
- ◆ Mama Mary's Farm & Pumpkin Patch reserves the right to revoke privileges of the vendors if they are unable to adhere to the rules/expectations.
