

Additional Info Needed

- Previous 12 months' P&L statement (TTM) Trailing Twelve Month.
- Reports: Provider Production and Procedures

TTM, or the Last twelve months of P&L is not the previous completed calendar year. It is a P&L for the previous completed twelve months prior to now.

Example: If today's date is Dec 15, 2025, then a TTM P&L would be for the period of December 1, 2024, through November 30, 2025. ("the previous twelve months")
