### Addendum to Criminal Complaint Against Bishop Michael M. Bibi, Bishop of the Diocese of Buea, Republic of Cameroon, Central Africa

This press release is issued in response to a Pastoral Letter signed on March 11, 2022 by Bishop Michael Miabesue Bibi regarding Catholic University Institute of Buea (CUIB) and affiliate Institutions; and to our criminal complaint filed in February 2022 with a Vatican Court.

We are relieved that our criminal case against Bishop Michael Bibi has prompted him to gradually reveal to the world some of his criminal activities which we referenced in our press release and video documentary of February 28, 2022 to be fraudulent, premeditated and clandestine in nature. Africa E5 Foundation, its partners and a diverse team of Canon law experts, criminal lawyers, international banking experts, investigative journalists, and international non-profit consultants with first-hand knowledge of this matter, **stand firmly behind our criminal complaint against Bishop Michael Bibi..**

Bishop Michael Bibi may despise or try to undermine and humiliate his predecessor Emeritus Bishop Immanuel Bushu in public. The reality remains that Emeritus Bishop Bushu retired as a Bishop of great standing. He was the competent authority with canonical and administrative powers to make decisions and to oversee his diocese at the time these issues occurred.

It is the policy and decision of Africa E5 Foundation to not comment on any on-going criminal or civil cases which are under litigation. We are however saddened to see Bishop Michael Bibi continue to abuse the authority of his position as a pastoral leader by using his bully pulpit to spread gossips, falsehoods, innuendos and revisionist history rather than to promulgate Christ's teachings and the salvation of souls especially at a time of lent.

We would also like to clarify that our complaint is not about the **power of the Bishop** and neither are we **challenging the ownership of the Catholic University Institute**.
