Town Council Incumbents Seek Re-Election

Brian Schmidt, Walter Chase Sr., and Jeremy Newnam all filed candidate applications for the upcoming election. If elected, the incumbents will serve 4-year terms ending in May 2029.

The deadline to file a candidate application was March 18th. However, applications from write-in candidates will be accepted until April 29th.

If no write-in candidates file, leaving the incumbent seats uncontested, the election will be cancelled. (see Town of Trappe Charter, Section 422, Resolution 1-2023)

The deadline for voter registration is April 1st at 4:00 PM. Voters should note that the deadline to request an absentee ballot is May 6th at 4:00 PM.

The election will be held on May 13th from 9:00 AM to 6:00 PM.
