As directed by Ordinance #03-2011, the Town of Trappe established a Residential Rental Registration and Inspection Program.

It is unlawful to rent a unit without first obtaining a Residential Rental License from the Town of Trappe. Licenses expire on June 30th of every year. Application renewals will be mailed in the beginning of March. Rental unit inspections will be conducted every other year.

Owners of rentals built prior to 1950 are encouraged to contact MDE for info on lead paint registration requirements via telephone (1-800-776-2706) or web (www.mde.state.md.us/lead). Rental registration with the Town does not release property owners from compliance with lead paint law and other applicable regulations.
