Bigg Tyme Trash

At their April meeting, the Town Council selected Bigg Tyme Trash for weekly trash collection. The cost is \$3.50 per week/per residence and the contract will go into effect on July 1, 2022. Collection will continue to take place on Friday and all regulations will remain the same. Reminder: each residence is permitted 90 gallons of household trash per week. Controlled Burn Regulations

Residents planning to burn anything larger than a backyard fire pit must only do so under the following conditions:

- * After 4:00 PM, but before sunset;
- * Wind under 10 miles per hour;
- * A burn ban <u>has not</u> been imposed by the State;
- * A person age 21 or older will be present for the entire duration of the burn;
- * The fire is located at least 25 feet from any building or structure;
- * The fire is located at least 15 feet from any fence;
- * A buffer of at least 10 feet has been cleared around the perimeter of the fire.
