Resolution 3-2023 – A Resolution of the Council of Trappe to amend the Charter for the Town of Trappe by repealing the term limit provision set forth in Section 201. (*available for adoption*)

Ordinance 3-2023 – An Ordinance of the Town of Trappe to increase the annual salary paid to the Council of Trappe from \$2,000 annually to \$3,000 annually, to become effective for Council Members elected after the May 2023 Election, and to increase the salary paid to the Planning Commission members from \$1,000 annually to \$1,500 annually to become effective for members appointed on or after May 2024. (*available for introduction*)

Ordinance 4-2023 – An Ordinance of the Town of Trappe establishing a temporary moratorium on applications, site plans, permits for, construction or operation, processing of, and approval of businesses engaged in the manufacture or sale of cannabis for recreational or medicinal use within the Town for a period of nine (9) months in order to allow the Town to consider and implement certain restrictions on where and under what circumstances such businesses may locate in Town to promote the public health, safety and welfare.
