In September the Council of Trappe took public comment regarding the desire and/or need for a town police department even if it means a future increase in taxes. The Council shared the expense associated with a full-time dedicated town officer, and listened as residents talked about crime & existing police coverage from other agencies. Talbot County Sheriff Joe Gamble candidly discussed calls for service & options available from his staff. The Council will continue deliberation on the matter at the October 4th meeting.

#### TOWN OF TRAPPE BULK TRASH REGULATIONS

Large load (over 3 yd<sup>3</sup>), over-size or over-weight item – Call the Town Office at least one (1) week before the scheduled pickup for cost based on loading, hauling and disposal costs.

<u>All materials</u> to be collected must be generated by the resident at that property. Bulk trash will not be collected from businesses or other non-residential properties.

Cardboard boxes must be broken down and bundled (max 10 boxes per bundle)

Broken glass should be wrapped in paper and marked as broken glass.

Sharp objects must be placed in metal or hard plastic containers with lids

Leaves must be in tied bags or covered containers (not over eight bags per household). Wet leaves will not be collected.

Sticks must be tied in bundles not more than (3) feet long and not more than sixty (60) pounds.

<u>Tree limbs</u> must not be more than (3) feet long and not more than sixty (60) pounds.

<u>Christmas trees</u> only will be picked up in January. (A free service provided by The Rural Life Museum of Trappe Maryland, Inc.)

Boards, posts, etc. shall not be longer than 3 feet or more than 60 pounds.

Loader piles of vegetative bulk will NOT be picked up.

Rugs must be dry and rolled up and tied, or folded and tied.

No more than one (1) each, hot water heater, refrigerator, freezer, stove, or sofa per residence.

Refrigerators, freezers, and air conditioners must have Freon gas removed.

Water-soaked debris will NOT be picked up.

Gas engine driven equipment must have all oil and gas removed before disposal.

Metal items must be separated from other debris and yard waste.

<u>Other Prohibited items include</u> antifreeze, asbestos, concrete, brick or masonry rubble, contractor's waste, dead animals, demolition debris, explosives and ammunition, hazardous materials, Items belonging to someone else, Items prohibited at the landfill, motor oil, paint cans with anything in them, propane tanks, soil and dirt, and tree stumps.

(Other restrictions may apply, check with the town office.)

**Items placed for bulk pickup** shall be placed near the street not more than four (4) days before a scheduled pickup date. Items shall not be placed on the sidewalk, in the gutter, or on the traveled portion of the street. Items that cannot be legally disposed of in the landfill will not be picked up. The trash hauling contractor may refuse any item(s) when in his judgment the item cannot be safely loaded, transported, and legally disposed of.

## Water Disconnection Policy Reminder

The Town office has received quite a few questions lately regarding the Town's water disconnection policy so we thought it would be beneficial to everyone to send out a reminder. The Town's policy became effective on <u>January</u> <u>1, 2017</u> and is as follows:

- 1. Water/sewer bills are mailed out monthly with a due date for the following month.
- 2. If payment is not received in the office on or before the due date, a 2% late fee will be assessed.
- 3. If payment is not received before 10 days after the due date, a disconnect notice is issued. Each disconnect notice is mailed to every homeowner and is also posted on the front door of each rental property.
- 4. The disconnect notice will give the owner and/or tenant an additional 10 days to pay their bill in full to avoid disconnection.
- 5. If payment is not received in full by the close of the 10<sup>th</sup> day following the issuance of the disconnect notice, the water will be disconnected the following business day at 8:00 am and a \$35.00 disconnect fee will be assessed to the account immediately. An account is considered disconnected when the address is given to the water department for disconnection, and <u>NOT</u> when the water is physically disconnected. So in other words if the water department receives notice at 8:15 am to disconnect your water and you come into the office to pay before they actually get to your property to disconnect the water, you will still be required to pay the \$35.00 disconnection fee.
- To have your water reconnected, the entire past due bill along with a \$35.00 disconnection fee and a \$35.00 reconnection fee must be received by the Town office. The Town office is the only place that payments will be accepted <u>the water department employees WILL NOT accept payment</u>.
- 7. Payment must be received in the Town office prior to 3:00 pm in order to have your water reconnected the same day.
- 8. Water will be reconnected at the convenience of the water department, which means it may take a couple of hours before they are able to reconnect. However, all paid properties will be reconnected before the water department leaves for the day.
- 9. The Town is no longer able to accept late payments arrangements, payment plans or postdated checks in order to avoid disconnection. **NO EXCEPTIONS WILL BE MADE!**
- 10. The Town accepts cash, money order, checks and credit cards (with a small convenience fee). You may pay over the phone with your credit card if you would like to do so and there is a slot in the Town office door to put payments into if the office is not open.

PLEASE NOTE - Contacting the on-call water department personnel after hours <u>WILL NOT</u> result in your water being turned back on that day/evening. You will need to wait until the Town office opens the next business day at 8:00 am to pay your bill and then your water will be reconnected. The after-hours phone is for emergencies only and this does not classify as an emergency.

If you do not receive a water bill you may contact the Town office around the first of each month to obtain your amount due and the due date.
