**Volunteering is a must!** Everyone needs to pitch in to ensure each class runs smoothly and efficiently. Thank you!

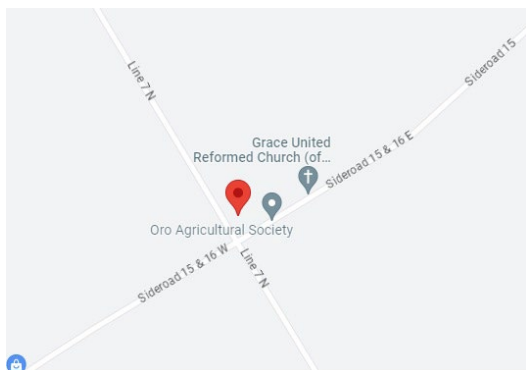
**Entries:** Entries must be received by the closing date to ensure entry.

**Confirmations:** All confirmations will be e-mailed or posted on the website.

**Prizes and Awards:** All dogs earning a qualifying score will be awarded a qualifying ribbon. As well, in each of Starters, Advanced, Masters and Games rounds, first to fourth place ribbons will be awarded in each height division for Open, Veterans and Specials rounds.

Title ribbons will be awarded for teams that earn the following titles: ADC, SGDC, AADC, AGDC, MAD, MJDC, MSDC, MGDC, MTDC, ATChC, and Lifetime Achievement Award of Excellence. Title ribbons may be purchased at a cost of \$10 for teams earning the following titles: Expert Bronze, Silver and Gold Awards, Bronze, Silver and Gold Award of Merit, and Versatility Bronze, Silver and Gold Awards. A team earning several titles for one run, the highest level of title ribbon will be awarded. Title Ribbons for the lower tier event title may be purchased at a cost of \$10 regardless if they are listed above.

**Format:** There is one outdoor fenced ring with a grass surface.

## The Fine Print: Assumption of Risk and Liability

In consideration of the acceptance of this entry by AAC and Animoosh Agility (the "Organizing Club") and the opportunity to have the Dog participate, compete in and/or be judged at this event or trial (the "**Event**"), I, the undersigned, agree as follows:

1. I certify that I am the actual owner of the Dog, or that I am the duly authorized agent of the actual owner of the Dog and that the Dog is not a hazard to persons, property or other dogs.
2. I agree that AAC or the Organizing Club for the Event may refuse my entry for any reason that it deems to be sufficient.
3. I understand and acknowledge that participation in the Event carries certain risks, including, but not limited to injuries (including serious injuries and death) to myself, the Dog, another dog under my control or persons attending as my guests (my "**Related Parties**"), damage to property and other losses. I waive any and all claims that I have or may have in the future against, and release from all liability and agree not to sue AAC, the Organizing Club or any of the directors, executives, committees, representatives, employees, volunteers or agents of either AAC or the Organizing Club (the "**Personnel**") and the owners of the premises or grounds, the Oro Medonte Agricultural Society, the Township of Oro Medonte and the Province of Ontario, upon which this event is held, and their respective employees and agents, collectively called the "Releases," for any injury, death, property damage or other loss that I or my Related Parties sustain due to any cause whatsoever, including negligence, breach of contract, breach of duty, statutory or otherwise, or mistakes or errors of judgment of any kind.
4. I assume full responsibility for the conduct of myself and my Related Parties during the entirety of the Event. I agree to indemnify and save harmless AAC, the Organizing Club and the Personnel from and against any and all claims that may be made against them or costs, fees, expenses or liability (including, without limitation, lawyers' fees on a solicitor and own client basis) incurred by AAC, the Organizing Club or the Personnel that may arise due to:
