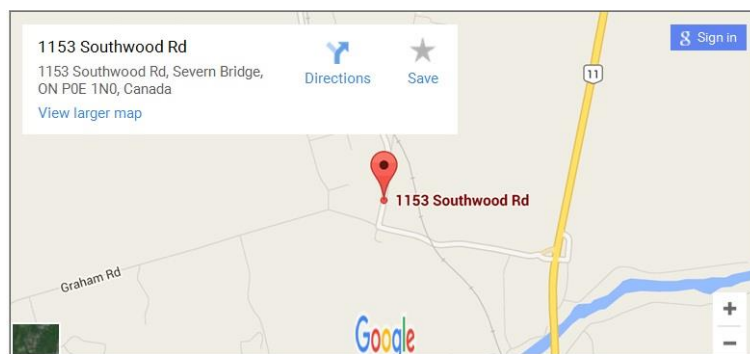
Entries: Entries must be received by the closing date to ensure entry.

Confirmations: All confirmations will be e-mailed or posted on the website.

Prizes and Awards: All dogs earning a qualifying score will be awarded a qualifying ribbon. As well, in each of Starters, Advanced, Masters and Games rounds, first to fourth place ribbons will be awarded in each height division for Open, Veterans and Specials rounds.

Title ribbons will be awarded for teams that earn the following titles: ADC, SGDC, AADC, AGDC, MAD, MJDC, MSDC, MGDC, MTDC, ATChC, and Lifetime Achievement Award of Excellence. Title ribbons may be purchased at a cost of \$10 for teams earning the following titles: Expert Bronze, Silver and Gold Awards, Bronze, Silver and Gold Award of Merit, and Versatility Bronze, Silver and Gold Awards. A team earning several titles for one run, the highest level of title ribbon will be awarded. Title Ribbons for the lower tier event title may be purchased at a cost of \$10 regardless if they are listed above.

Weather: The trial will proceed, rain or shine.

Rules: The trial will be held under AAC Rules and Regulations. All obstacles conform to AAC specifications including breakaway tire and rubber contacts.

Fun Run: Morning Fun Run **Start 8 am – Limited to 25 Runs \$10.00 per Run** Same dog may be entered more than once *****Paid Pre-Entry***** (I will announce on website when full)

Time will be 90 seconds. There will be a buzzer at 75 seconds as a warning, and the second buzzer at 90. Toys can be used during the fun run. Toys containing food cannot be used unless empty and clean. Course maps for the day will be held until the completion of the fun run.

The Fine Print: Assumption of Risk and Liability

In consideration of the acceptance of this entry by AAC and Animoosh Agility (the "Organizing Club") and the opportunity to have the Dog participate, compete in and/or be judged at this event or trial (the "Event"), I, the undersigned, agree as follows:

1. I certify that I am the actual owner of the Dog, or that I am the duly authorized agent of the actual owner of the Dog and that the Dog is not a hazard to persons, property or other dogs.
2. I agree that AAC or the Organizing Club for the Event may refuse my entry for any reason that it deems to be sufficient.
3. I understand and acknowledge that participation in the Event carries certain risks, including, but not limited to injuries (including serious injuries and death) to myself, the Dog, another dog under my control or persons attending as my guests (my "Related Parties"), damage to property and other losses. I waive any and all claims that I have or may have in the future against, and release from all liability and agree not to sue AAC, the Organizing Club or any of the directors, executives, committees, representatives, employees, volunteers or agents of either AAC or the Organizing Club (the "Personnel") and the owners of the premises or grounds, the Severn Bridge Agricultural Society, the Town of Gravenhurst and the Province of Ontario, upon which this event is held, and their respective employees and agents, collectively called the "Releases," for any injury, death, property damage or other loss that I or my Related Parties sustain due to any cause whatsoever, including negligence, breach of contract, breach of duty, statutory or otherwise, or mistakes or errors of judgment of any kind.
4. I assume full responsibility for the conduct of myself and my Related Parties during the entirety of the Event. I agree to indemnify and save harmless AAC, the Organizing Club and the Personnel from and against any and all claims that may be made against them or costs, fees, expenses or liability (including, without limitation, lawyers' fees on a solicitor and own client basis) incurred by AAC, the Organizing Club or the Personnel that may arise due to:

I have read, and do understand the rules of competition and the additional rules (if any) appearing in the trial schedule for the Event, as well as the policies of AAC pertaining to discipline (collectively, the "Rules"). I agree to abide by the Rules and to conduct myself and the Dog in accordance with the Rules. I understand that myself and/or the Dog may be subject to disciplinary procedures or sanctions for breach of the Rules and agree to respect and be bound by any disciplinary decision made by AAC.

I understand that AAC and/or the Organizing Club may, in the course of administering the Event or conducting its activities generally, collect, use or disclose my personal information and that any personal information collected, used or disclosed by AAC and/or the Organizing Club will be treated in accordance with AAC policy and applicable privacy and personal information laws. I hereby consent to the collection, use and disclosure by AAC and/or the Organizing Club of my personal information.

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19
