all entities acting as OFFICIALS are REQUIRED by FEDERAL, STATE, and Municipal Law to provide the lawful **Name, Address and Telephone Number of their Public Hazard and Malpractice Bonding Company** and the Policy Number of the Bond and, if required, a copy of the Policy describing the Bonding coverage of their specific job performance. Re: Clearfield Trust Company vs. United States 318 U. S. 363 – 371 (1942): Governments “(entities) descend to the level of a mere Private Corporation and take on the characteristics of a mere private citizen ... where private Corporate Commercial Paper [Federal Reserve Notes (FRNs)] and ‘Securities’ [Checks] is concerned, for purposes of suit, such Corporations and individuals are regarded as entities entirely separate from GOVERNMENT”.
