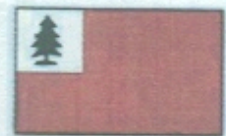

### Writs in the Nature of Constitution and Treaty Violations

I Am Joniah Joni El, a Natural Living Being, Moor American National, In Propria Status, Sui Juris, In Proprio Solo, In Proprio Heredes. I Am an Original Indigenous Sovereign Moorish American National and I am exercising all my rights at this time and at all points in time. Whereas all US CORPORATE, Persons, ASSIGNS, AGENTS and Heirs, have been found in violation of the Treaty of Peace and Friendship 1786 and 1836 and the Constitution for the United States Of America 1789 and 1791

**To:** All UNITED STATES CORPORATE Persons, acting as Public OFFICIALS, AGENTS, ASSIGNS, and HEIRS.

**The below paragraphs from the Civil Order 2014;** pretty much sums up my position concerning the property/Land located at [5343 Westside Road, Cave Junction, Oregon 97534], Territory. The corporate address does not represent the land, it is for reference purposes only. My desire is to **Live** on my land without being violated in any way, shape or form by any UNITED STATES Persons, AGENTS, ASSIGNS, HEIRS, POLICY ENFORCERS (Sheriff/Deputies) due to their unwillingness to adhere to The Law.

#### **Letter to President Obama, from Pope Francis, issued July 4, 2014**

Such “foreign officials” include members of the American and British Bar Associations who were licensed to act as privateers against the interests of the American States and the American State Citizens from 1845 to 2013 in flagrant Breach of Trust. All such licenses are now extinguished. Members of the Bar Associations are required to cease and desist assaults against the American States and American State Citizens and shall be subject to arrest, confiscation, and deportation otherwise.

Insomuch as corporate officers operating the United States of America, Incorporated, and the UNITED STATES have contrived under conditions of fraud and semantic deceit to re-venue the estates of the American States and living American State Citizens to the foreign jurisdiction of the United States of America (minor) they are found guilty of capital crimes, including acts of fraud and treason committed between 1933 and 1945, and are condemned posthumously. My Administrative process was completed prior to May 12, 2019. I have given sufficient notice more than once, and all of my efforts have been completely ignored. The Allodial Title to the parcel of Land is held in Trust and posted in the public at [www.spiritualbreeze.org/AllodialTitles/MACO-00000000502](http://www.spiritualbreeze.org/AllodialTitles/MACO-00000000502), also hand delivered to; Wally Hix dba a LEGAL AGENT, for Josephine County Recorder's Office, as of today; December 11, 2019, have not been recorded in their records. (But perhaps that's because the living and the dead don't mix). Now that I have taken possession of the property, I have been harassment by the local Policy enforcers(Police/Sheriff), the local Bankers and Real estate Agents. They have given me 3 days to move out or be arrested and placed in jail, along with my spouse and custodians(3) that are on the property as well.
