**Tax Fraud:**

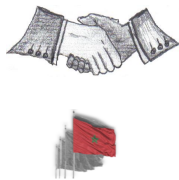
**united states code: title 18> part 1 > chapter 41 § 876: mailing threatening communications:**

- (a) whoever knowing deposits in any post office authorized depository for mail matter, to be sent or delivered by the postal service of knowingly causes to be delivered by the postal service according to the direction thereon, any communication, with or without a name or designating mark subscribed thereto, addressed to any other person, and containing any demand or request for ransom or reward for the release of any kidnapped person, shall be fined under this title or imprisoned not more than twenty years or both.
