## Affidavit

We are in Propria Persona Sui Juris, In Proprio Solo, and in Proprio heredes and we are exercising all of our rights at this time and at all points in time.

The penalty for lying in Commerce is CORPORATE death. We, the Moorish American people are not dead and hereby proclaim that we are alive. Our proclamations of our Moorish American Nationality in our hearts and/or on the public record is proof of life. We are not commercial CORPORATIONS and all CORPORATIONS to include those who have acted unlawfully using CORPORATE NOM DEGUERRES in order to unlawfully claim the living Bodies and property of the living Beings on our land are hereby sentenced to immediate CORPORATE death. The Bodies of the living Moorish American Nationals currently being held in all institutions are hereby set free. Further, we hereby pronounce, proclaim and declare that all CORPORATE TRUSTS on our land are hereby abolished forever. This lawful Affidavit serves as notification of Death for all NOM DEGUERRE Wardship NAMES and shall be used as sufficient Proof of Death to support the immediate payment of all credits to the living Moorish American people and immediate payment of all obligations nunc pro tunc to the Moorish American people.
