**Affidavit of Termination of Trusteeship**

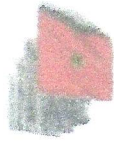

You are hereby commanded to peacefully vacate all of the aforementioned immediately. All citizens will vacate immediately the properties that are chosen by the Moors as we so proclaim it by sending lawful documents to vacate. Upon receipt of the said lawful documents to vacate, the citizens must vacate immediately. Enclosed is a 1923 UNITED STATES OF AMERICA PEACE DOLLAR and a ONE TROY OUNCE .999 FINE SILVER COIN WITH MT. HOOD OREGON inscribed on it. ## RESOLUTION 1099-143305252013

Whereas, the 1099 Affidavit, filed by Drew Ali on August 1, 1928 at 2:52 pm, in the Cook County Recorder of Deeds office, Document number 10105905, Book 521, Page 579 will serve as the Delegation of Authority Order under which the Moorish Science Temple of America shall conduct its business.

Whereas, a Delegation of Authority is an instrument whose source is a sovereign authority in the nature of a grant either to the whole nation or to a class or portion of that nation.

Whereas, we are a Jural society.

Whereas, we execute Jura Summi Imperii and Jura Regia.

Whereas, we invoke the Jura Sanguinis Nullo Jure Civili Drimi Possunt.

Whereas, the Divine Constitution and Bylaws along with the Articles of Association, the Articles of Confederation, and the Constitution for the United States of America shall be the building blocks for the body politic of the Moorish Science Temple of America.

Whereas, the books: 101 Questions for Moorish Children, The Circle 7, the Adept Chamber books, and the Moorish Science Temple Divine Constitution and Bylaws are the literary foundations for the ecclesiastical body of the Moorish Science Temple of America.

Whereas, the Supreme Council and Grand Body will legislate law regarding the Moorish Science Temple of America. These laws will be communicated to foreign authorities, to insure that our operations are acknowledged, accepted, and protected through the normal course of international law.

Whereas, the Supreme Council and Grand Body of the Moorish Science Temple of America convened and resolved that the following will be resolved as law for the Moorish Science Temple of America:

Whereas, all recorded Moors shall have prerogative of jurisdiction in all matters including nationality, title, status, claim, right, interest, and in the nature of any matter civil, criminal, commercial, or otherwise involving a Moor. Furthermore, the Department of Vital Statistics in each state in which a recorded Moor was born, shall transfer and convey, as Title, the Domicile of Origin back to Moorish Empire, of which their domination authority and inhabitation protracted from between 3 degrees north-east of present day Mogadishu and 22 degrees North Latitude at Yemen(Moab), 5 degrees

West of Sabaea, 12 degrees East of the Kingdom a Axum to 42 degrees East Longitude 2,982 Miles longitude. Latitude, and South-Africa 12 degrees East Longitude, South West of Moab at Luanda(Angola). Heretofore, a recorded Moor is one who has filed a declaration of nationality, in its various forms, with the Cook County Recorder of Deeds in Chicago, Illinois, and has received a document number for that filing. In addition, the document number will be used as a tax non-obligation number either in the singular form for individual parties or the collective form for families who have filed one document severally. All recorded Moors, shall have full entitlements to all titles, status, claim, right, and interest in the Moorish Science Temple of America.

Whereas, the District of Columbia and the Congress of the United States, under the United States Code, Title 28, Section 3002, subsection 15a, will not have any undue influence upon the Jural society of the Moorish people.

Whereas, all titles of nobility, namely El, Bey, and Ali, shall be recognized by international law.

Whereas, The Flag of The Moorish Science Temple is, and shall remain, the Red Canopy and the Green Star--the Mother of Flags and evidence and declaration of our Natural Descent to this land, The Moroccan Empire.

Whereas, The Bureau of Moorish Affairs will oversee the operations of all councils currently listed, as well as those that may be established, dissolved, or amended in the future. Only authorized liaisons within The Bureau of Moorish Affairs will deal directly with the central governments of foreign nations, including The United States of America, or authorized liaisons appropriated by such governments. Credentials of ventures sanctioned to operate under the authority of the following councils, shall be furnished within 15 business days of the request by an agent of an authorized liaison appropriated by a foreign nation, including The United States of America, and its instrumentalities. (Business days do not include Fridays, as this day is a holy day within the Moorish Science Temple of America.) All inquiries about the operations of these Councils, and the ventures operated therein, shall be directed to authorized liaisons within The Bureau of Moorish Affairs.

Whereas, the Document 10105905 also known as The Vas Estate of Drew Ali will serve as the instrument by which the Moorish Science Temple of America shall issue credit and discharge debt for recorded Moors throughout the Vas Estate Trust, namely the lands of North, South, and Central America, and the outlying islands.

Whereas, all recorded Moors shall have the right to freely travel unobstructed, unmolested, and unfettered in their various modes of transportation throughout the North, South, and Central Americas.

Whereas, all recorded Moors shall have an unobstructed, unmolested, and unfettered right to bear arms throughout the North, South, and Central Americas.


Whereas, all recorded Moors now imprisoned in penal holding facilities shall have the right to request the aid of a consulate officer of the Moorish Science Temple of America to secure their release from such facilities.

Whereas, if any Moor is forced into a judicial proceeding regarding any statutory violation, the liability charge placed upon the charging offender or offenders, shall be the amount of \$1,800.00 per minute which shall be awarded to the defendant based on the amount of time the defendant was detained, the amount of travel time spent, and the courtroom time the defendant used in negotiating such matters. Also, the charging offender or offenders shall pay the jurisconsult the amount of \$5,000.00 per hour based on the time spent defending the libel. ## The Divine Constitution of Moorish America

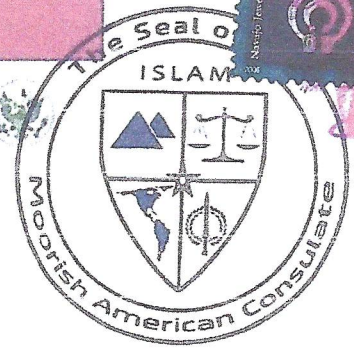

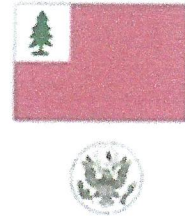

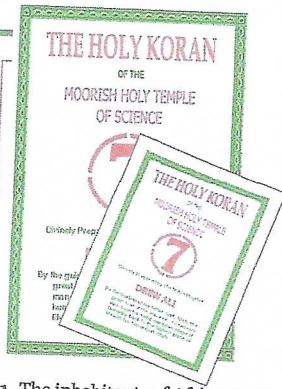
No member is to attend Adept Chamber that has not lived a moral

  3. Bro. I. Cook-Bey and other Moors said The Holy Prophet said, "My good Moors are going to live."
  4. The Holy Prophet said, "I am going to stop the European from thinking, and start you (The Moors) to thinking for your own good."
  5. Sister A. Brown El of Temple 25 said that the Holy Prophet said, "If you got people in the South, get them out, because that is where destruction is going to start."
  6. The Holy Prophet told The Moors, "For the various lynchings and murders that were committed in the South; the South is going to have to pay off, and pay off in blood."
  7. Bro. J. Foster-Bey of Temple 4 and 25, Holy Prophet said, "Every word that I speak is spirit, and you Moors had better heed." (That is give it attention, obey).
  8. Bro. G. Cook-Bey, G.S. (Emeritous) of Temple 1, Chicago, Ill. said that the Holy Prophet said, "Look around, and where you see people; one day, wild animals will be roaming down the streets."
  9. Bro. J. Foster-Bey, Asst. G.S. of Temple 25 and a member of Temple 4 in the 1920's said that the Holy Prophet said, "When the fire comes, I will be the water."
  10. Moors that saw and heard the Holy Prophet said that He said, "What is all these people doing here. There is only going to be a handful saved. I can count them on my fingers, and have fingers left over." 229. Sister M. Lovett El (Past) G.G. said that the Holy Prophet said, "One day, there are going to be so many women, a man is going to have to run for his life."
230. Bro. T. Booker-Bey, G.N.T. (Emeritus) said that the Holy Prophet Noble Drew AH said, "The Moors once ruled the world; now get ready to rule it again. But this time it's going to be done under Love, Truth, Peace, Freedom and Justice."
231. Bro. I. Cook-Bey, G.G. of Illinois (Emeritus) said that the Holy Prophet said, "I can do what Jesus did, but you (The Moors) are not in the condition that those people were in".
232. Bro. J. Foster-Bey of Temple 4 and 25 said that the Holy Prophet said, "The European is our fellow man".
233. The Prophet said, "Money does not make the man, and clothes do not make the man. It is character and free national standards that make the man".
234. Bro. O. Payton-Bey, G.S. of Branch Temple 25 (Ecorse, Mich.) said that the Holy Prophet said, "If you try to tell what a man is by looking at him, you are burnt up from the start." (One cannot tell what nationality a man is by looking at him. One needs to ask him what his nationality is).
235. Bro. J. Foster-Bey of Temple 4 and 25 said that the Holy Prophet said, "If your brother wants something, give it to him so that he won't sin." (Your giving a thing to your brother, will keep him from coveting it, which is a sin). 236. The Holy Prophet said, "I am the fifth, and last Prophet, and I am five times more powerful than I was before." (The Prophet Noble Drew Ali was the last five Prophets that Allah sent, and He is five times more powerful than the others five Prophets before Him).
237. The Holy Prophet told The Moors "If you want European Grand Sheiks, I can give them to you." (Some people are so under the influence of slavery, though they are free, that they do not wish to honor, and follow their own leaders; so the Holy Prophet gave them a choice).
238. During the First Annual National Convention in 1928, one of the Grand Governors of a State failed to appear at the Convention. Bro. J. Blakely-Bey said that the Holy Prophet sent the Grand Governor a telegram informing him, that if he did not attend the Convention, that He (The Holy Prophet) was going to have the F.B.I. to arrest him. (All Grand Sheiks, and Officials of the Moorish Science Temple of America are supposed to attend the Annual National Conventions to account to the Grand Body of their Temple responsibilities for the past year. Each subordinate Temple is to send their Grand Sheik and Secretary to the Convention to represent their Temple and make reports to the Grand Body of Temple Affairs).
239. The Holy Prophet told the Moors, "When you get married, go before your Grand Sheik, and let him perform the ceremony". Some of the Moors did not obey The Holy Prophet's order, so He told the Moors, "go downtown, and buy your wives from the Europeans." (The Prophet was telling the Moors to go and acquire a marriage license, since they were not going to heed what He said, [When a Moor gets married he is to go before
