that is off-limits to the said Moorish American heirs. All Moorish American Nationals shall travel wherever they will, park their conveyances wherever they will, stand and stay wherever they will without interruption, without interference, without interrogation, without the UNITED STATES, and without being approached nor violated by subjects.

3. All subjects are subjects to all Moorish American Nationals, regardless of said subjects association with a Moorish American National. All subjects shall remain under the authority of all Moorish Americans at all times. Should a Moorish American National allow a subject to break the law by not honoring the sovereignty of his Moorish American Kin, He/She too may face reprimand, trial and possible detainment among other punishments by this government. All subjects may face pain of death for any violations of universal sovereignty, although, at the discretion of this government, pain of death can occur at any time for any violation as all have been given years of notification to date.

4. Personam Jurisdiction is hereby invoked into perpetuity for all Moorish American Nationals at all times nunc pro tunc, whether spoken or not. Jurisdiction cannot be waived even by consent of both parties. It is the Supreme Law of the Land. All subjects who choose to violate the Moorish American Nationals shall be arrested, detained, tried, and if found guilty, they may suffer life imprisonment or pain of death.

5. If there is a wait time or a line at any commercial venue on our lands, all Moorish American Nationals, to include those who may be asleep to their true identity, shall receive first priority in all things and shall be moved to the front of said lines in all commercial and non-commercial venues.
