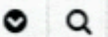

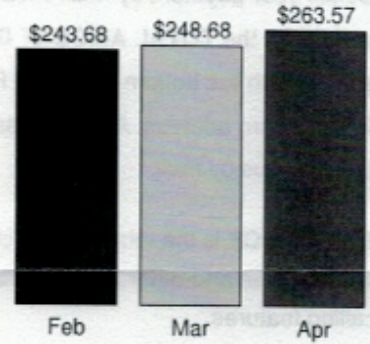

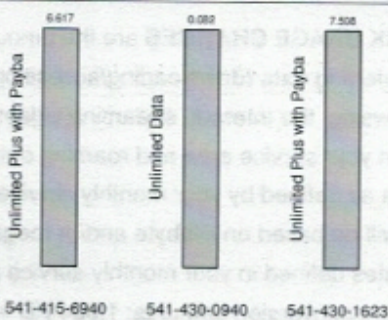
Trend of Monthly Charges

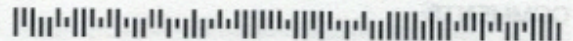
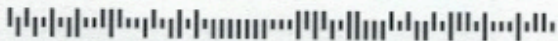
