be it known as of June 5, 2018, notice of the moorish americans existence was issued to all United States Corporate Persons which fired and convicted all Corporate Persons under the UNITED STATES Corporation Company and their officers of fraud, extortion, human trafficking, involuntary servitude, murder, high treason, for crimes against humanity. the order for all Corporate Governmental, Judicial and all Enforcement and assumed powers and authority have been revoked and nullified and all such personnel were ordered to stand down. all Corporate Persons and Citizens are now order to rise and stand. You are hereby ordered to obey the law, the constitution **for** the United States of America(major)1791.

whereas; national and federal law provides that it is a crime to violate the rights of the people under the color-of-law. you can be held personally liable for violating the personal liberties of the people, and for committing ‘fraud’. **attempting to cause a person** to do something by telling that person that such action is required by law, when it is not required by law, is not only fraud, it is a felony and is treason. **title 18, part 1, chapter 13 §241, §242 and §245 of United States codes of law.**

re: 18 u.s. code § 1028 – ‘fraud and related activity in connection with identification documents, authentication features, and information’ ...**example:** appellation/name in all caps, U.S. driver’s license, U.S. identification cards, U.S. credit cards, etc. ‘fraud in its elementary common law sense of deceit ... includes the deliberate concealment of material information in a setting of fiduciary obligation. a public official is a fiduciary toward the public, ... and if he deliberately conceals material information from them he is guilty of fraud’. mcnally v. u.s. 350, 371 – 372, quoting u.s. v holzer, 816 f.2d. 304, 07.

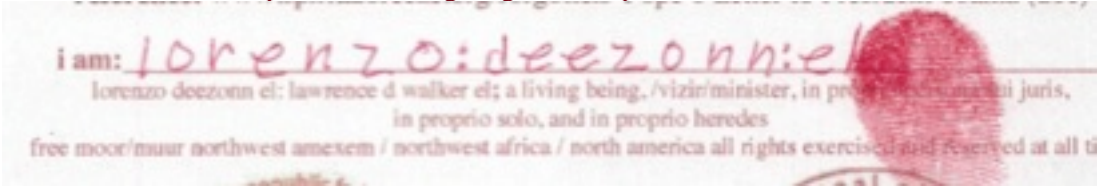
18 usc §242: Whoever, under ‘color’ of any law, statute, ordinance, regulation, or custom, willfully subjects any person in any State, Territory, Commonwealth, Possession, or District to the deprivation of any rights, privileges, or immunities secured or protected by the Constitution or Laws of the United States, or to different punishments, pains, or penalties, on account of such person being an alien, or by reason of his color, or race, that are prescribed for the citizens, shall be fined under this title or imprisoned not more than one year, or both; and if bodily injury results from the acts committed in violation of this section, or if such acts include the use, attempted use, or threatened use of a dangerous weapon, explosives, or fire, shall be fined under this title or imprisoned not more than ten years or for life, or both, or may be sentenced to death.

18 usc §245: provides that Whoever, whether or not acting under color of law, intimidates or interferes with any person from participating in or enjoying (the estate, identified as) any benefit, service, privilege, program, facility or activity, provided or administered by (a person / agent / Officer / Public Servant, operating through an agency, corporation, or association of) the United States; [or] applying for or enjoying employment or any prerequisite thereof, by any agency of the United States; shall be fined under this title, or imprisoned not more than one year, or both.

public hazard bonding of corporate agents: all officials are required by Federal, State, and Municipal Law to provide the name, address and telephone number of their public hazard and malpractice bonding company and the policy number of the bond and, if required, a copy of the policy describing the bonding coverage of their specific job performance. Failure to provide this information constitutes corporate and limited liability insurance fraud (15 USC) and is prim a facie evidence and grounds to impose a lien upon the official personally to secure their public oath and service of office. (18 USC 912)
