"Where rights secured by the Constitution are involved, there can be no rule-making or legislation, which would abrogate them. Miranda v. Arizona 384 US 436, 125:"

there exist NO Delegation of Authority that allows violation of the Constitution and the People's Rights. to perform these acts under the guise of GOVERNMENT OFFICIALS, is in violation of Title 18, Section 912 - Piracy. Corporate Officials performing these felonious acts under trickery and deceit, falls under the definition of "Fraud". Please keep in mind that Governments are only established for the purpose of protecting the rights of the people. Therefor all Entity(s)/DBA and under the United States Corporation Company, all have an obligation to speak & not be silent when they see or witness an infraction of the people's rights; being silent constitutes dishonor (Fraud).

whereas all DEBT (Tax's) is owed by the Debtor; Entities/DBA and under the UNITED STATES CORPORATION Inc., Company. remedy must be provided in exchange for taking the land, and the natural resources from the people. **re: United Nations rights of indigenous peoples, article 28, § 1 & 2**

i, known as johnie-mae, indigenous to the lands of the America's, previous known as morocco, a natural living being, Tax exempt, am with the authority and hereby establish this jurisdiction as follows: i, conditionally and timely accept all presentment(s) as follows: whereas Entity(s)/ DBAWells Fargo **has failed to provide proof of claim;** evidences of a Debt (Taxes) owed by johnie-mae the paramount interest holder for the Public Trust: JOHNNIE M WALKER (U.S. Federal Person).

whereas deformation of character is a criminal offence. Entity(s)/DBA Wells Fargo, in their own words have committed a criminal offence by way of deformation of character. falsely identifying the living johnie-mae to be a U.S. Federal Person, as a JOHNNIE M WALKER and other variation thereof such as Johnnie Walker in their presentment received on 7/5/2023 by way of U.S. Mail and their response received on 7/24/23 by way of Entity(s)/DBA Consumer Financial Protection Bureau; are guilty of perjury. anyone having taken an oath willfully subscribes as true any material matter which he does not believe to be true; is guilty of perjury and shall be fined under US code § 1746, title 28.

remedy:

i, known as johnie-mae the paramount secured interest holder, beneficiary, creditor and director for the Public Trust JOHNNIE M WALKER as well as the Power of Attorney for the U.S. Federal Person: Johnnie M Walker. be it understood that the account that was created under trickery and deceit is **void**. i demand, Entity(s)/ DBAWells Fargo to open a new account with an unlimited credit for the true and rightful holder and director for the U.S. FEDERAL Person, Johnnie M Walker. **without joinder**.

as the Writ in the Nature of Discovery sent to Entities/DBAWells Fargo, in January of 2010 and again in October of 2022, were not honored, all claims, petitions, suits, false accusations with any third party Corporations regarding my true status as a natural living being and indigenous to the land of the America(s)/morocco must be removed, dismissed and expunged from the record.
