re: the United Nations Declaration on Rights of Indigenous People article 8, §1; whereas it clearly states: indigenous peoples (and individuals) have the right not to be subjected to **forced assimilation** or destruction of their culture. article 8, 2e; or any form of propaganda designed to promote or incite racial or ethnic discrimination directed against them. ‘natural law’

whereas all entities doing business are deem to know the law; entities /DBA/ZIPLY FEBER falsely identifying a living being to be a U.S. CITIZEN, one that reside at an address in the CORPORATE STATE OF OREGON (a fiction), there by guilty of forced assimilation without proof of authority, jurisdiction or consent.

additionally, **violated** my rights by not giving me a choice of currency to set off and settle the DEBT, despite several attempts by way of lawful instrument(s) (currency) with my indorsement to set off and settle the DEBT for the services. even after providing my proper lawful status as a natural living and an indigenous being along with the lawful form of currency, entities / DBA/ZIPLY refuse to set off, settle and closed the account. in addition, the instrument(s) were not applied to the DEBT and instruments was not returned to me for any defect; there for by not returning the instrument(s), by law the DEBT is settled, discharged. moreover, by the entity(s) not settling the DEBT in accordance with Trust Law, natural law, it is a breach of entities acting as Trustee/Fiduciary, a miss appropriation of funds and Embezzlement; which is fraud, treason, waring against the people.

For purposes of suit, such Corporations and individuals are regarded as entities entirely separate from Government”.
