**NOTICE:** entity(s)/DBA ZIPLY FIBER Company, Debtor.. and all Administrators, Servicers, Assigns, Principals, Agents or Successors, herein and hereby incorporated by this reference, Entity(s). by the di rector, beneficiary for the Public Trust JOHNNIE M WALKER. herein is my conditional acceptance of this offer to contract, between the parties identified as Entity(s) and johnnie-mae, di rector, beneficiary for the Public Trust JOHNNIE M WALKER regarding, presentment received from Entity(s) /DBA/ZIPLY FIBER Inc., on 07/05/2023, as follows:

*"Where rights secured by the Constitution are involved, there can be no rule-making or legislation, which would abrogate them. Miranda v. Arizona 384 US 436, 125:"*

whereas all DEBT (Tax's) is owed by the Debtor; Entities/DBA and under the UNITED STATES CORPORATION Inc., Company. remedy must be provided in exchange for taking the land, and the natural resources from the people. re: United Nations rights of indigenous peoples, article 28, § 1 & 2

i, known as johnie-mae, indigenous to the lands of the America's, previous known as morocco, a natural living being, Tax exempt, am with the authority and hereby establish this jurisdiction as follows: i, conditionally and timely accept all presentment(s) as follows: whereas Entity(s)/DBA/ZiPLY Fiber has failed to provide proof of claim; evidences of a Debt (Taxes) owed by johnie-mae the paramount interest holder for the Public Trust: JOHNNIE M WALKER (U.S. Federal Person).

whereas deformation of character is a criminal offence. Entity(s)/DBA ZIPLY FIBER, in their own words have committed a criminal offence by way of deformation of character. falsely identifying the living johnie-mae to be a U.S. Federal Person, as a Mr. Walker and other variation thereof in their presentment received on 7/5/2023, and are guilty of perjury. anyone having taken an oath willfully subscribes as true any material matter which he does not believe to be true; is guilty of perjury and shall be fined under us code § 1746, title 28.

i, known as johnie-mae the paramount secured interest holder, beneficiary, creditor and di rector for the Public Trust JOHNNIE M WALKER as well as the Power of Attorney for the U.S. Federal Person: JOHNNIE M WALKER. whereas the account that was created under trickery and deceit is void. i demand, Entity(s)/DBA ZIPLY FIBER to open a new account for the true and rightful holder and di rector for the U.S. FEDERAL Person, JOHNNIE M WALKER, without joinder.

as the Writ in the Nature of Discovery was not honored, all claims, petitions, suits, false accusations with any third party Corporations regarding my true status as a natural living being and indigenous to the land of the America(s)/morocco must be removed, dismissed and expunged from the record.

Dear Federal Communications Commission:

Ziply Fiber has received notification of a complaint from the above individual.

According to the complaint:

- Mr. Walker states Ziply Fiber refused to settle his debt and closed his phone account.
- Mr. Walker states his rights are being violated by not providing him a choice of currency to settle his debt. Mr. Walker states he has made several attempts to pay by way of lawful instrument(s), (currency) with his endorsements but they were not applied to his debt and were not returned for any defect. Mr. Walker states that by not returning the instrument(s) the debt is settled.
- Mr. Walker states Ziply Fiber is not providing his right to resources of communication via phone and internet.

Ziply Fiber has investigated the above statements and offers the following response:

- Ziply Fiber records show Mr. Walker had a phone and internet account ending in 3456 that was suspended for non-payment on January 7, 2021, and was permanently disconnected February 5, 2021, effective the date of suspension. This is in accordance with the Oregon Administrative Rules OAR 860-21-305, grounds for disconnecting utility service, utility service may be disconnected by an energy utility or large telecommunication utility; (3) When the customer fails to pay Oregon tariff or price-listed charges due for services rendered.
- Ziply Fiber advises the outstanding account balance of \$686.34 went unpaid and was written off on March 24, 2021, then sent to an outside collection agency. Ziply Fiber has not received payment for the outstanding balance on the account nor has Mr. Walker provided proof that such a payment has been made.
- Ziply Fiber has advised Mr. Walker that the outstanding debt must be paid in full before a new service can be established.
