i am, that i am known as: johnie mae wilson in my present form, a natural living being. my present political status is moor american national, in propria persona. i am an aboriginal indigenous sovereign moorish american national, and i exercise my rights at this time and at all points in time. whereas all persons/entities acting as/dba US Corporate Citizens, Persons, Agents, Assigns, Principals, Servants, Public Services and Heirs, **have been found guilty of fraud; unlawful occupation on sovereign aboriginal land, i.e. universal/international crimes, in violation of the treaty of peace and friendship -1786 and 1836 and the constitution for the united states of america 1789 and 1791; in short...in violation of the basic laws of nature.**

**Reference:** civil orders June 10, 2012 ... by: Anna Maria Wilhelmina Hanna Sophia Riezinger- von Reitzenstein von Lettow-Vorbeck, page 4, paragraphs 5 and 6,

“Because these “State” and “Federal” entities have all functioned under conditions of non-disclosure and semantic deceit serving to promulgate fraud upon the organic states and the American people, they are all to be considered criminal syndicates to the extent that they have been aware of their status and have failed to correct their operations and representations.
