United States Code: Title 18> Part 1 > Chapter 41 § 876: mailing threatening communications:

- (a) Whoever knowing deposits in any post office authorized depository for mail matter, to be sent or delivered by the postal service of knowingly causes to be delivered by the postal service according to the direction thereon, any communication, with or without a name or designating mark subscribed thereto, addressed to any other person, and containing any demand or request for ransom or reward for the release of any kidnapped person, shall be fined under this title or imprisoned not more than twenty years or both.

re: 18 u.s. code § 1028 – ‘fraud and related activity in connection with identification documents, authentication features, and information’, (**example:** APPELLATION/NAME in all caps, U.S. driver’s license, U.S. identification cards, U.S. Credit Cards, etc.) ‘fraud in its elementary common law sense of deceit ... includes the deliberate concealment of material information in a setting of fiduciary obligation. a public official is a fiduciary toward the public, and if he deliberately conceals material information from them he is guilty of fraud’. *mcnally v. u.s.* 350, 371 – 372, quoting *u.s. v holzer*, 816 f.2d. 304, 07.

18 usc §245: provides that Whoever, whether or not acting under color of law, intimidates or interferes with any person from participating in or enjoying (the estate, identified as) any benefit, service, privilege, program, facility or activity, provided or administered by (a person / agent / Officer / Public Servant, operating through an agency, corporation, or association of) the United States; [or] applying for or enjoying employment or any prerequisite thereof, by any agency of the United States; shall be fined under this title, or imprisoned not more than one year, or both.

public hazard bonding of Corporate Agents: all Officials are required by Federal, State, and Municipal Law are to provide the name, address and telephone number of their public hazard and malpractice bonding company and the policy number of the bond and, if required, a copy of the policy describing the bonding coverage of their specific job performance. failure to provide this information constitutes Corporate and limited liability insurance fraud (15 USC) **and is prim a facie evidence and grounds to impose a lien upon the Official personally to secure their public oath and service of office.** (18 USC 912)
