as moorish american nationals we are the law, and we remain in honor at all time. this judgement is complete

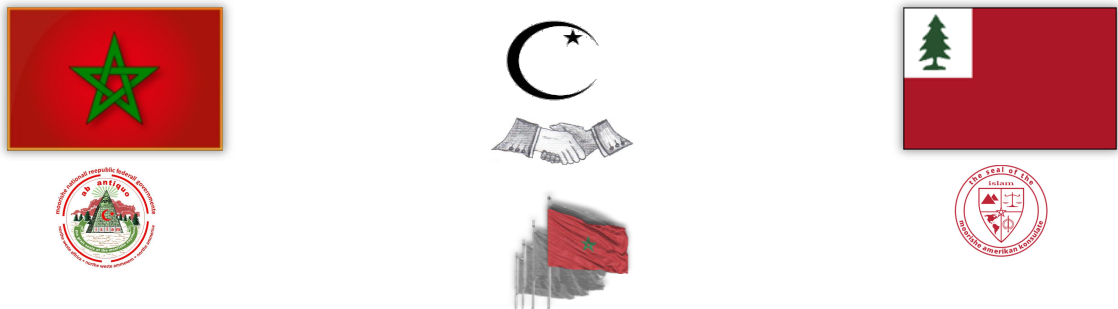

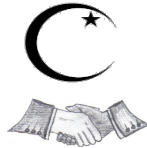
