

• title 18, u.s.c., section 242**

- section 242 of title 18 makes it a crime for a person acting under color of any law to willfully deprive a person of a right or privilege protected by the constitution or laws for the united states.

- article 1

the contracting parties confirm that genocide, whether committed in time of peace or in time of war, is a crime under international law which they undertake to prevent and to punish.

- article 2

in the present convention, genocide means any of the following acts committed with intent to destroy, in whole or in part, a national, ethnical, racial or religious group, as such:

- (a) killing members of the group;
- (b) causing serious bodily or mental harm to members of the group;
- (c) deliberately inflicting on the group conditions of life calculated to bring about its physical destruction in whole or in part;
- (d) imposing measures intended to prevent births within the group;
- (e) forcibly transferring children [minors] of the group to another group.
- a **Certificate of Debt** (usually interest-bearing or discounted) that is issued by a GOVERNMENT or CORPORATION in order to raise money.

- “U.S. Governments are Corporations”;

"inasmuch as every Government is an Artificial Person, an abstraction, and a creature of the mind only, a Government can interface only with other Artificial Persons. the imaginary, having neither actuality nor substance, is foreclosed from creating and attaining parity with the tangible. the legal manifestation of this is that no Government, as well as any Law, Agency, Aspect, Court, etc. can concern itself with anything other than Corporate, Artificial Persons and the contracts between them."
