**for the record and on the record let the record show;** the **Respondents** (Corporate employees): listed herein pretending to government have no lawful authority over the living. **Respondent(s);** knowingly without lawful authority arrested and incarcerated amir hessan el, and all derivatives thereof a natural living, breathing moorish american national without proof of authority and without proof of jurisdiction. For the record and on the record let the record show; no United States Corporate employees/Citizens has personum jurisdiction over natural living being, that includes moors; as we are not dead (Corporate employees), we are natural living beings.

whereas the United State Code states: **Title 18 U.S. Code § 913**, impersonator making arrest or search whoever falsely represents himself to be an officer, agent, or employee of the United States, and in such assumed character arrests or detains any person or in any manner searches the person, buildings, or other property of any person, shall be fined under this title or imprisoned not more than three years, or both.

the only contract between the **Respondent(s)**, Corporate Person(s) pretending to be Government is the constitution for the united states of america (morocco) 1791, and the treaty of peace and friendship 1836. Whereas an **Public Servant(s)** duty is to protect and serve the people, instead the un-constitutional Public Servant(s) (employee(s)) kidnaped amir hessam el, and all derivatives thereof, a natural living being without lawful; I.D, without proof of authority, proof of jurisdiction and without proof of just cause, which is an act of genocide. genocide includes but is not limited to, intent to destroy, in whole or in part, a national, ethnical, racial or religious group, as such: (c) deliberately inflicting on the group conditions of life calculated to bring about its physical destruction in whole or in part, et cetera.

whereas it has been stated **clearly**, "...every man is independent of all laws, except those prescribed by nature. he is not bound by any institutions formed by his fellowmen without his consent."

**case law: us v minker, 350 us 179 at 187(1956), supreme court of the united states 1795 states:** "inasmuch as every government is an artificial person, an abstraction, and a creature of the mind only, a government can interface only with other artificial persons. the imaginary, having neither actuality nor substance, is foreclosed from creating and attaining parity with the tangible. the legal manifestation of this is that no government, as well



as any law, agency, aspect, court, etc. can concern itself with anything other than corporate, artificial persons and the contracts between them."

**Respondent(s)** has 3 days upon receipt of the notice to respond with a favorable remedy, if respondent(s) choose not to respond, respondent(s) is in agreement with **remedy # 2.**

1. **remedy no. #1:** you are commanded to cease and desist any farther harm towards any/all natural living people. you are commanded to release amir hassan el; a natural living being who is being held under threat, duress, and coercion. you are to return his property and remove any and all false charges against him.
2. you are commanded to return the 499.00 (see attached bill for false charges) in gold backed currency for damages in lawful money, Article 1 section 10 of the United States of America Constitution 1791 which states; "No State shall enter into any Treaty, Alliance, or Confederation; make any Thing but gold and silver Coin a Tender in Payment of Debts;
