i am joniah joni el a natural living being and not a 14th Amendment US Citizen, i have been continuously violated by your so called public servants(i.e. employees) pretending to be public officials, you are ordered to cease and desist the un-ceasing acts of fraud; which is clear evidences of genocide. see prior cease and desist notice(s) sent (attached) to the Unidentified Corporate Persons pretending to be the de jure Government.

Whereas: case law: us v minker, 350 us 179 at 187(1956), supreme court of the united states 1795 states: "inasmuch as every government is an artificial person, an abstraction, and a creature of the mind only, a government can interface only with other artificial persons. the imaginary, having neither actuality nor substance, is foreclosed from creating and attaining parity with the tangible. the legal manifestation of this is that no government, as well as any law, agency, aspect, court, etc. can concern itself with anything other than corporate, artificial persons and the contracts between them."

No farther communication is necessary and it is not an option when Corporate Persons are pretending to be the de jure government and are in dis-honor; which strips any and all Corporate Person(s) of any assumed authority over natural living beings. whereas i have given many notices over the pass years, and the issue has not been resolved. The unidentified Corporate Persons continuous attempts to communicate and violate the natural people without contract and without full disclosure subjects the Corporate Persons to suit for damages under the 'fair debt collections act' and voids any legal proceedings.

pursuance to; "23. PUBLIC HAZARD BONDING OF CORPORATE AGENT: All officials are required by Federal, State and Municipal Law to provide the name, address and telephone number of their public hazard and malpractice bonding company, the policy number of the bond and if required, a copy of the policy describing the bonding coverage of their specific job performance.³

Failure to provide this information constitutes corporate and limited liability insurance fraud (15 USC) and is prima-facie evidence and grounds to impose a lien upon the official, personally, to secure their public oath and service of office.²⁴ This International Commercial Obligation Lien is, in part, supported & prefaced on UCC-9/102 (Agricultural Liens); UCC 9/607-610 (Secured Party's Right to take possession after default), with all rights reserved" (all rights exercised at all time).



remedy no. #1, offer and compromise:

The financing statement also constitutes a fixture filing as to the collateral indicated in the financing statement which is or is to become fixtures.
- (b) The office in which to file a financing statement to perfect a security interest in collateral, including fixtures, of a transmitting utility is the Office of the Mayor. The financing statement also constitutes a fixture filing as to the collateral indicated in the financing statement which is or is to become fixtures.

§ 28:9-515 Duration and effectiveness of financing statement; effect of lapsed financing statement.

(f) If a debtor is a transmitting utility and a filed initial financing statement so indicates, the financing statement is effective until a termination statement is filed.
