What should I do if I am not yet receiving mail at my new address? If you have not received forwarded mail (which would include a yellow or white sticker) 10 days from your start forwarding date, contact 1-800-ASK-USPS (1-800-275-8777).

How should I let my friends, family members, magazine publishers, and business

correspondents know of my new address?

Usually, magazines and business correspondence contain cards or instructions for telling them your new address and move date. Please alert your friends and family members about your new address.

Do I need to register to vote?

With a new address, you'll need to reregister to vote after you move (or if you change your last name). Filing a change-of-address does not update your voter registration information. To fill out your voter registration form and receive a pre-addressed mailer, visit app.mymove.com/welcome and enter code: 1k46ir97ne
