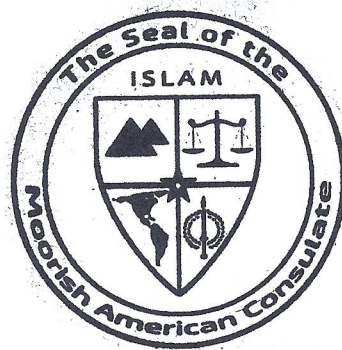

In addition, the court may issue an order for immobilization and/or impoundment of the cited vehicle, enter a judgment against you and impose a fine up to the maximum amount allowed by law, assign the citation for collection, and add fees. If your vehicle is immobilized or impounded, the entire amount due must be paid in government funds at the Multnomah County Circuit Court. The law company will also charge a fee before releasing an impounded vehicle.

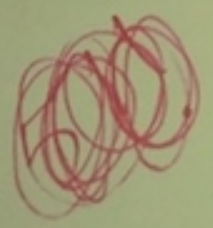
